



# PARTNERSHIP AGREEMENT

**Between schools, business, civic groups, government and others**

By our participation in this Partnership Agreement, we agree to the following:

**SCHOOLS:**

- To promote, support and encourage services provided by the Building Bridges to Careers (BB2C) Coordinator, especially Job Shadowing opportunities with high school students.
- To work collaboratively with the BB2C Coordinator.
- To invest a *minimum* of \$2,000 annually over the next three (3) years in order to sustain the collaborative grassroots project. **This minimum amount contribution allows the school district to have access to the services provided by the BB2C Coordinator.**

**BUSINESS:**

- To serve as a worksite location for students interested in job shadowing opportunities.
- To work collaboratively with the BB2C Coordinator.
- To allow our business' name to be included on the BB2C website.
- To assure completion of any paperwork on behalf of a student or a project, as necessary.
- To invest a *minimum* of \$1000 annually over the next three (3) years in order to sustain the collaborative grassroots project.

**CIVIC GROUPS:**

- To encourage involvement of members in this project.
- To utilize the BB2C Coordinator for presentations to group members
- To invest a *minimum* of \$1000 annually over the next three (3) years in order to sustain the collaborative grassroots project.

**OTHERS** – Other community entities (i.e. Chambers; Commissioners; Social Service Agencies; Philanthropic Organizations, etc.) are encouraged to become a partner by committing to a minimum of \$1000 per year.

**WASHINGTON COUNTY FAMILY & CHILDREN FIRST (FCF)**

FCF commits to administrative oversight of the BB2C Coordinator through the BB2C Board, and to serve as the fiscal entity for receipt and disbursement of project funds (through County Auditor). BB2C Coordinator shall be contracted through the Washington County Commissioners on behalf of FCF. The BB2C Coordinator agrees to work with the BB2C Board, schools, business, civic groups, social services and others in a collaborative, cooperative manner to ensure the success of the Project.

All organizations committing a minimum of \$1,000 in funding annually to the project for a three-year period will be listed as "Partners" on the BB2C website.
