- 2. Advertising agreement is for one year and NOT subject to cancellation. Agreement provides for an ad in two editions of print and online versions of Brides & Weddings, profile on www.bridesandweddings.com, and monthly bridal referrals.
- 3. Advertiser agrees to payment terms indicated on this agreement. Make all checks payable to Reinhold Publishing Inc. If paying by credit/debit card, this agreement and advertiser's signature authorize payment to Reinhold Publishing. VISA, MasterCard and American Express accepted.
- 4. Payments made after due date are subject to a \$50 late fee per billing cycle until account is current.
- 5. Any outstanding balance 90 days past due is subject to collection efforts by an attorney on behalf of Reinhold Publishing. Advertiser will be held responsible for court costs, attorney's fees and prevailing interest on outstanding balance.
