

TO: THE HONORABLE JOHN CARL WEST, Governor of the State of South Carolina

WHEREAS, the undersigned are all legal residents and citizens of Richland County, State of South Carolina, and more particularly the Town of Blythewood, South Carolina, located in said County and State aforesaid.

FURTHER, the undersigned presently reside within the geographic boundaries of the Town of Blythewood as set by the General Assembly of South Carolina in the year 1879, A. D., by General Act 160, which incorporated the Town of Blythewood.

WHEREAS, the Town of Blythewood, South Carolina does not presently have any officer or officers as called for in the aforementioned Act and whereas the undersigned are informed and believe that his Honor the Governor of the State of South Carolina has the power to order an election for filling the vacancies of Intendant and four Wardens as well as appointing the necessary officers for the holding and declaring of such election as set out in Section 47-121 of the Code of Laws of South Carolina, as amended.

NOW, BE IT KNOWN, that we, the undersigned respectfully petition the Governor of the State of South Carolina to order an election for the filling of the vacancies of the officers for the Town of Blythewood, South Carolina as hereinabove set out.
