


MS4 Toolkit goes LIVE!

Last week the MS4 education toolkit officially went live on the Clean Water MN website. The website includes brochures, newsletter articles, fact sheets, utility bill inserts, posters, training videos, surveys, case studies and more to help cities, counties and watersheds educate their staff and the public about stormwater pollution.

Educational materials are available in the following categories:

- 1) Public education and participation
 - *Streets to streams
 - *Landscaping for clean water

- 2) Illicit discharge detection and elimination
 - *Motor vehicle care

 - *Conservation Development
- 5) Pollution prevention in municipal operations

Along with the on-line materials, a kit will be available at the Washington Conservation District office for EMWREP partners to use and peruse. The kit includes a DVD of the parks and raingarden maintenance training videos filmed last summer and a pop-up banner to use at special events - "What color will kids be coloring lakes in the future?" - as well as examples of the new "Blue Thumb guide to year-round yard care" manual, the new "Save the walleye, then eat 'em" drink coasters, IDDE and construction site posters and BMP flash cards. 56 attend latest Stormwater U - Stormwater Pond Excavation

On May 6, EMWREP sponsored a Stormwater U workshop on stormwater pond excavation for public works and MS4 staff from the east metro area.

During the workshop, staff learned how to measure the amount of sediment that has accumulated in a storm pond, how to take a core sample, and how to safely dispose of potentially contaminated sediment.

Proposed topics for future Stormwater U workshops include infiltration design and maintenance, IDDE and winter street maintenance.

You are invited to enjoy "A View from the St. Croix River"

On Wednesday, June 17 from 5-9pm, we will set sail on the St. Croix River to take part in an innovative educational experience. This floating workshop will be a collaborative effort of EMWREP, WCD, MSCWMO, the St. Croix Partnership Team and Northland NEMO.

Elected officials, planning commission members, watershed representatives and city staff from communities within the St. Croix Basin are invited to join us to learn about special characteristics of the St. Croix, threats to the river, and planning and best management practices that can help to protect the river. ***This workshop is for all communities in the greater St. Croix watershed, not just those along the river.***

In addition to viewing key sites along the Lower St. Croix, participants will handle water monitoring equipment, examine live fish and mussel species, and have the opportunity to meet and network with people from other communities.
