Jeffrey H. Peters, MD

Executive Summary

There is little doubt that virtually all aspects of US healthcare are undergoing unprecedented change. Catalyzed by the debate accompanying the creation of the Affordable Care Act coupled with an unsustainable rise in the costs of US healthcare, it has now become widely recognized that the delivery of care for both the well and sick requires the same tenacity and innovation as has occurred in understanding the biology and deploying new treatments for human disease over



the past 50 years. It is this challenge that drives my personal desire to continue to advance medicine and my career.

An accomplished health care executive, surgeon, and researcher, I have been at the forefront of healthcare excellence and innovation throughout most of my career. I have enjoyed national and international leadership in the introduction and adoption of minimally invasive surgery, have been widely renowned for clinical and investigative work in the field of esophageal disease and most recently have furthered University Hospitals' Cleveland stature as a leading academic healthcare system following appointment as its Chief Operating Officer in January 2014. UH includes an integrated network of 18 hospitals, more than 40 outpatient health centers and 200 physician offices throughout northern Ohio.

During this period of unprecedented change in the health care industry, as UH COO, I was fully accountable for the clinical, operational and financial performance in a health system with over 4B in revenue serving over 1 million patients each year. Specific objectives for which I was responsible included:

- The deployment of high-quality clinical care in a large Academic Medical Center, 11 wholly owned community hospitals, over 50 outpatient facilities and hundreds of physician offices.
- Redesigning the academic medical center, university interface and the hiring of a new president of the academic medical center.
- Creation and implementation of value-based care, telemedicine and a culture of high reliability medicine and value improvement.
- Selection of new leader and re-design of a physician organization including over 2000 employed physicians in both an academic and community medical groups, including the creation and successful implantation of a novel academic compensation model.
- Increasing market share, and clinical integration
- Initiation and operational performance of major service line institutes, including cardiovascular, neurologic, digestive health, sports medicine, primary care and transplant.
- Optimizing the academic mission
- Achieving strong financial performance

Reporting to UH system CEO Thomas F. Zenty III, my direct reports included senior leaders including the President of UH's academic medical center, regional hospital executive leaders, Chief Medical and Nursing officers, and all Presidents of Community Hospitals and Physician

Services enterprises. These daily interfaces enabled us to drive clinical-care enhancements across the UH system. Major goals include improving quality, clinical outcomes and experiences for patients, their families and the communities that UH serves, operational excellence in all arenas and achieving ambitious financial goals.

More recently I was responsible for leading the emergence of UH Ventures, which extended core UH services beyond the health system to generate new sources of revenue. In 2018 I became responsible for UH Accountable Care organizations and population health. We furthered the creation of an integrated system focused on the advancement of community hospitals, rehabilitation, ambulatory and virtual health strategies. This includes furthering the adoption of high-reliability medicine practices, continuum of care, as well as evolving operational innovation and value-improvement initiatives.

Additionally, I lead the strategic development of academic partnerships made possible through UH's affiliation with Case Western Reserve University School of Medicine, which expands the health system's horizons to explore new relationships in research and clinician development.

Prior Experience

Prior to joining University Hospitals in 2014, Dr. Peters served as the Seymour I. Schwartz Professor and chairman of the Department of Surgery at the University of Rochester Medical Center (URMC), and surgeon-in-chief of Strong Memorial Hospital (2004-14). Dr. Peters served as Professor of Surgery at University of Southern California School of Medicine and Chief, Division of General Surgery, at USC University Hospital in Los Angeles, California. He served as President of the Society of American Gastrointestinal Endoscopic Surgeons (SAGES); President of the International Society for Diseases of the Esophagus; and member of the Board of Trustees of the Society of Surgery of the Alimentary Tract. Dr. Peters was named *Modern Healthcare*'s 2017 inaugural list of *Top 25 Chief Operating Officers in Healthcare*. He has been listed among the Best Doctors in America, recognized as "Physician of the Year" at USC University Hospital and received a Distinguished Alumni Award from The Ohio State University College of Medicine. He served as a consultant to industry on many occasions and an NIH funded researcher in the field of esophageal adenocarcinoma. He has authored more than 220 peer-reviewed original articles and more than 75 book chapters.

Education

Dr. Peters attended The Ohio State University where he received his BA in biochemistry in 1978. He remained in Columbus for medical school, receiving his medical degree from The Ohio State University College of Medicine and Public Health in 1981. He entered The Johns Hopkins Hospital surgical internship and residency, and completed a two-year post-doctoral research fellowship in immunology. He served as an honorary registrar at The John Radcliff Hospital in Oxford, England, and served as a clinical esophageal fellow with Tom DeMeester at Creighton University School of Medicine in Omaha, Nebraska. Dr. Peters completed his surgical training in 1988.

Originally from Columbus, Dr. Peters resides in Moreland Hills, Ohio.

Summary of Activities 2014-2018

University Hospitals expanded significantly Since Dr. Peters began his appointment as COO in early 2014. Major advancements since end-of-year 2013 include the following:

- The number of wholly owned UH system hospitals expanded from 10 to 15
- The number of physicians, advanced-practice providers and employees increased from 23,737 to 28,998
- Annual operating revenues grew from \$2.78 billion to over 4.00 billion
- Annual **operating income increased** from \$62.4 million to \$134 million

Key initiatives contributing to recent system outcomes include:

- UH expanded its mission to meet the rising demand across Northeast Ohio for the highest-quality care by bringing five community hospitals and a joint-venture rehabilitation hospital into its system since 2013. Each hospital acquisition requires a well-planned and executed strategy to fully integrate its services, staff, infrastructure and processes within the system, and the work continues to this day. Dr. Peters and his team devoted themselves to identifying opportunities for improving services and efficiencies while minimizing duplication of operations.
- The aggressive UH system expansion since 2013 has contributed greatly to a market-share jump of more than eight points, as measured by discharges. UH now commands nearly a one-third share of the highly competitive Northeast Ohio market.
- A productivity-based compensation model, introduced in 2016 for faculty physicians, has improved results to well above national benchmarks. This was achieved through effective physician engagement strategies led by Dr. Peters, and incentives that made productivity gains a win-win for physicians and for UH.
- Under Dr Peters' leadership, UH and Case Western Reserve University School of Medicine finalized a new academic affiliation agreement in 2016 that enables UH to redefine and advance all three areas of its mission: patient care, teaching and research. Under the agreement, UH remains strongly aligned with the School of Medicine in a multi-affiliate relationship that offers a wealth of opportunities not previously available. UH and its physicians have gained flexibility in conducting biomedical and clinical research by pursuing and investing in new research collaborations and directly funding a wider range of UH physician-researchers' work. UH continues to collaborate with the School of Medicine on nationally funded biomedical research.
- **UH institutes** bring together providers from different disciplines to collaborate on optimal patient treatments. Institutes also promote uniform care protocols and best-practice sharing. Recent additions under Dr Peters' tenure include UH Primary Care (adult and pediatric) and Sports Medicine institutes. Additional institutes, including UH Harrington Heart & Vascular, Neurological and Digestive Health, have expanded into new locations to provide subspecialty care close to home for patients across northern Ohio.
- Dr Peters led the development of a Department of Clinical Integration starting in 2014 to implement and manage physician-alignment strategies. To date, department initiatives have helped facilitate a 77-percent increase in relationship-building interactions among faculty and community-based physician colleagues to strengthen our continuum of care and improve quality by treating patients within the UH network. After identifying barriers that limited referral activity to UH's academic medical center, the Clinical Integration team

- worked with practice leaders and scheduling experts to help engineer reductions in time-to-first-appointment by 26 percent overall. These steps, plus new point-of-service scheduling for follow-up appointments, contribute to an improved patient experience.
- UH has launched a formal initiative to eliminate preventable medical errors and become a High Reliability Organization. The UH Rainbow Babies & Children's Hospital team has worked for several years to create a culture focused on safety, and Rainbow was one of the first children's hospitals in the nation to go an entire year without a serious safety event. They have achieved that milestone twice. Employees and leaders across the UH system are now attending mandatory training sessions to learn about and apply those same principles to benefit patients at all UH entities.
- The Harrington Discovery Institute at University Hospitals part of The Harrington Project for Discovery & Innovation – was launched in 2012 and reported to Dr. Peters. In just five years this initiative has funded promising drug-development efforts by 74 scientists, including 11 from the Cleveland medical community. This innovative approach is central to UH's developing vision for a new model of academic medical center at UH Cleveland Medical Center.
- Anticipating the impact of evolving health care reform, UH created the UH Value Improvement Program (UH VIP). The goal is to increase value to UH patients by improving care quality, safety, access and outcomes, while delivering the best possible experience. UH VIP is based on a thorough review of internal operations, programs and business practices, which identified several opportunities to deliver care more effectively. Financial savings from UH VIP and HRO (described above) initiatives since 2014 total \$300 million.
- UH entered into a partnership with **Medtronic Integrated Health Solutions** in late 2016 to improve the efficiency and effectiveness of clinical support operations in the cardiac catheterization and electrophysiology labs at UH Cleveland Medical Center. Medtronic now manages daily operations of scheduling, supplies/inventory, process optimization and room turnover/patient flow. This innovative partnership is the first of its kind in the United States.
- In 2015, UH introduced **Zocdoc**, featuring online 24/7 access to the appointment schedules of nearly 400 participating UH physicians, to enhance value and convenience to patients. More than 10,000 appointments were booked through the app during 2016.
- UH and other area trauma-care providers launched a new Northern Ohio Trauma System (NOTS) in February 2017, which provides coordinated trauma care to patients throughout Northeast Ohio. NOTS members coordinate with public safety forces and network hospitals to ensure patients are rapidly triaged and taken to the appropriate level of care within the network. The NOTS network comprises three adult Level I trauma centers, the newest launched in 2015 at UH Cleveland Medical Center under Jeff Peters' direction. UH Rainbow Babies & Children's Hospital serves as a Level I pediatric trauma center. Less-severe trauma patients are taken to one of Northeast Ohio's adult Level II or Level III trauma centers.

Dr Peters has been a champion for **patient experience at UH**. He reminds his direct reports to focus their efforts on improving the patient experience and achieving financial targets

 Across the UH system, seven hospitals achieved their HCAHPS patient satisfaction goals in 2016, compared to just two hospitals in 2015.

- In 2016, UH Geauga Medical Center reached all eight HCAHPS patient satisfaction domains after reaching only two of eight in 2015. Similarly, UH Conneaut Medical Center attained all eight domains after reaching just five in 2015.
- UH Rainbow Babies & Children's Hospital reached 10 of 10 pediatric inpatient satisfaction domains in 2016 after achieving only five in 2015.
