## - EXHIBITOR REGISTRATION AND GUIDELINES - NASHUA ARTWALK WEEKEND 2017

**OPEN STUDIO/EXHIBITION AND SALES:** Saturday, October 14, 2017, 11am – 5pm  
Sunday, October 15, 2017, Noon – 4pm

**ELIGIBILITY:** Open to all established, emerging and student artists in the Greater Nashua Area.

**APPLICATION DEADLINE:** September 1, 2017, Midnight, Eastern Time

**EXHIBITION GUIDELINES:** All art displayed and offered for sale must be the work of the exhibitor. All exhibitors must remain set up and available during dates and times listed above.

**LOCATION ASSIGNMENT:** Artists not associated with a studio will be assigned to a participating ArtWalk venue. If you are a returning artist, requests for placement in previous venue can be noted on application and will be considered, but not guaranteed. If you are an artist that requires ADA accommodations, please note this on the application so that appropriate accommodation can be made prior to the event.

**SET-UP and BREAKDOWN:** Your exhibit must be in place by 10:00AM on Saturday. Once you are assigned to a venue, it is your responsibility to make arrangements with the owner regarding specific set-up and breakdown guidelines.

**REGISTRATION FEES:** \$35.00 (\$25.00 Early Bird, \$15.00 Students) Non-Refundable Registration Fee, payable to City Arts Nashua, is required to process application. Early Bird Registration Ends August 18<sup>th</sup>. You may pay by credit card via the City Arts Nashua web site with a \$2.00 processing fee.

**IMAGES:** As part of the publicity campaign leading up to ArtWalk, we need as many photos as possible. Please email a high quality .jpg image (at least 300 dpi) of yourself creating your artwork with a description to the email below by September 8<sup>th</sup>. You can also send images of just your work; while publications prefer photos with people, City Arts Nashua can use the images of your work on the website and for social media publicity. Receipt of images grants permission to use them for these purposes.
