Minutes From the WCPA Executive Board, Nov. 5, 2014

Treasurer Reports. Gwen Barry reported Jack Morton reviewed and approved the tax report. She advised that payment arrangements such as Eventbright should be managed by the Treasurer to keep things straight. Board directed \$150 transferred to the Philanthropy restricted fund based on \$50 donated in memory of 3 deceased members. Rental income for October was \$6100. Property taxes were paid. \$1000 was donated for historic renovation. About \$3000 was collected for renovation of the Steinway piano.

Membership Report. Osborne reported that the class of new members met and are working on an activity. Ten women are on the waiting list. There was some discussion about criteria for being on the waiting list. There was consensus that the sponsor is the key to successful introduction and seasoning of new members. It was agreed that some more thought should go into criteria for membership.

Centennial Plans Osborne reported that planning for the Centennial celebration is now focused on FY15-16. A September to June 2015-2016 observance is planned.

House and Grounds. Lisa Sten is the representative to the Board for H&G. There was discussion of the ramp process and damage to the ballroom floor.

Federation Report submitted by Eileen Brooks. We decided to continue membership in the Federation at the cost of \$5000. per year since our tax-exempt status is through the Federation. It was decided to stay in the Federation but not attend all Federation meetings.

Rentals Committee. Lippert reported on 26 rentals scheduled this fiscal year. Lippert and Monroe reported on rental requirement changes. Motion approved to increase deposit to \$1000. and reduce capacity to 120 from 150.

Finance Committee. The cost to repair the Steinway based on a 2nd bid is \$5567. Our generous members donated \$5100. The rest is from unrestricted Historic Preservation donations in annual dues. Board approved \$6402 with 15% contingency. Monroe also reported a net of \$13,028 from Painted Chairs as a result of late payment from Eventbright, changing income/expense report for FY13-14.

ADA Ramp Progress Report: Lippert reported that the plans comply with all codes. The hard surface is being worked on first. Iron hand rails will follow.

Woman's Club National Register Application. President Sullivan attended a City Council meeting to thank them for supporting our application for National Register recognition for the one hundred year old Clubhouse. Margaret Feuer and Marilyn McDonald have spearheaded this request and attended the state hearing before the State Historic Preservation Organization to finalize the recognition. www.womansclubofpaloalto.org

Ad Hoc Committee on Rentals and Dues: Update, Recommendations, Action. Margo Ogus reported for the Ad Hoc Committee. The Committee was charged to investigate the issue of rental income as our main source of income and to look at the possibility of developing other sources to fund operating and capital budgets. The Committee included: Shambora, Lippert and Zwiep from Rentals Committee; Monroe from Finance; Sten and Shambora/Renzel from H&G, Osborne from Membership, and Ogus from the Board. There is concern about wear and tear to Clubhouse by rental to large groups as well as conflicts that occur between rentals and member use of the Club.

Some progress has been made on the issue of wear and tear by increasing the price and reducing capacity. The group defined the dilemma as balancing between rentals' impact on the house and the availability of the Club to members. The issues go straight to finance questions: fewer rentals may require a higher obligation for member dues. These conversations must continue with a plan to report to membership about the balance. The process requires educating members about the difficulties. The process needs to build trust rather than frustration. The process will likely involve separating out all the issues and putting them back together. At this point, no one is forcing a certain approach and there are no premature conclusions. As discussion evolved, it was clear that the Board needs to take charge of the tenor of the program. Premature discussion outside of the Board will not be helpful. The process and result must reflect the Club's values as noted in the collect. Board's job is to come up with the process for educating members and taking input from interest groups. A chair and two other members will define the purpose, recommend committee members to the Board, and establish a process for information gathering. The problem is a balancing of Dues and Fundraising, rather than Dues and Rentals, since rentals are a means of fundraising. Margo Ogus is the Chair and Sylvie Way is Co-Chair. They are charged with establishing the Committee on Revenue Balance, and to come up with a process and timeline to reolve the issue. President Sullivan will announce the conclusions of the Board to the membership very soon and let them know that no decisions have been made yet on funding the club. The Committee will rely on membership participation in order to arrive at the best funding balance for the club now and into the future.

History Corner Clelia D. Mosher

Clelia D. Mosher (1863-1940) is a woman many of us have never heard of, but she was an early figure in the scientific study of women, and her professional career was local! Encouraged by her father in her interest in science, Mosher went to Wellesley College and University of Wisconsin, but she earned her bachelor's (1893) and master's (1894) degrees in physiology from Stanford. Further studies earned her an MD from Johns Hopkins, but she returned to Stanford to teach personal hygiene as assistant professor in 1910. In her studies of menstrual cramps, Mosher developed a protocol of muscle building exercises dubbed "moshers" to counteract "cramps." She interviewed and sent questionnaires to dozens of women to find out what they thought about their personal and family lives. She challenged conventional wisdom regarding women's sexual habits and preferences. In the 1970s, Stanford professor Carl Degler found her papers in the Stanford archives, a treasure trove of raw data about women's preferences, expectations, and lives. Although Professor Mosher did not publish her findings, she kept detailed records, which became a gold mine for later scholars who examined what women thought about their lives in the late 19th and early 20th centuries.
