The Catskill Art Society at PO Box 991, Livingston Manor, NY 12758 (hereinafter referred to as CAS) and the Undersigned Exhibitor and his/her agents of (hereinafter referred to as EXHIBITOR) agree to the following:

Opening reception: Saturday, May 27, 2017 from 3-5pm
Artwork pickup date: Monday, June 24, 2017 from 12pm-6pm (no early pickups permitted)

- 1. EXHIBITOR must be a member of CAS at the time of submission, with annual membership dues paid.
2. EXHIBITOR shall pay a participation fee of \$15 for one (1) work, due on submission and are limited to one (1) work per member artist.
3. EXHIBITOR shall deliver artwork and submit all required paperwork, including this Agreement and all documents named herein, to CAS no earlier than Monday May 1, 2017 and no later than the deadline of 6pm on Monday May 22, 2017 Late submissions will NOT be accepted.
4. EXHIBITOR will provide artwork details including: title, date created, medium, and price on exhibition agreement form #1 and on artwork labels form #2.
5. EXHIBITOR will deliver artwork to CAS "ready to hang," properly framed with picture wire or otherwise prepared for display.
6. All works in the EXHIBIT shall be for sale.
7. All works in the EXHIBIT shall have been created within five (5) years of the exhibition date.
8. Any works included in past CAS Members Shows are ineligible for the EXHIBIT.
9. CAS makes all final decisions for installation.
10. EXHIBITOR grants CAS unlimited permission to use photographs of EXHIBITOR's work, and/or photographs of the exhibit for promotion and illustration of exhibits of CAS, in perpetuity.
11. CAS is not responsible for theft; however the building is protected by an alarm system. EXHIBITOR is advised to also insure his/her work independently.
12. Sales for work in the exhibit will be paid to CAS; CAS will collect NY State/Sullivan County Sales Tax; and pay collected Sales Tax to NY State/Sullivan County.
13. CAS shall pay EXHIBITOR by July 14, 2017 for all sales less 25% commission.
14. If EXHIBITOR's work is sold before the end of the show, EXHIBITOR will be notified to have the option to replace the work with another submission at no additional cost.
15. The pickup date for unsold work is Monday, June 25, 2017 from 12-6pm. Any work not picked up by August 24, 2017 will become property of CAS. Early pickups are not permitted.
16. CAS gallery hours are: Thursday - Saturday 11am-6pm, Sunday 11am-3pm, Monday 11am-6pm.
