CONTRACT FOR FINE ARTISTS

This is an agreement between Wood.Metal.Art, gallery and Artist _____ to exhibit and sell the Artist’s artwork selected for display at Wood.Metal.Art,1009 McKinley Ave.Columbus, OH 43222, from _____ to _____.

Part I.Wood.Metal.Art Gallery agrees to provide the following:

- Gallery space
- Marketing and promotion. For each exhibition, Wood.Metal.Art Gallery makes show cards, price lists, wall labels, invitational mailings and a press release.
- Installation assistance if needed
- ROY G BIV Gallery staff during public hours Wednesday – Friday, 10 AM– 6 PM, and Saturday, 10 AM – 6 PM. Appointments for visitation may also be arranged outside of these hours.
- Referral of potential buyers to Artist. Wood.Metal.Art Gallery receives a commission of 35% for works of art sold at the exhibition. In the event that Wood.Metal.Art Gallery secures an order for Artist to produce a new work, the gallery shall receive 35% of the total price as commission for arranging that work.
- Invitations will be mailed to our list of patrons and supporters. The artist will receive 40 show cards for personal use and distribution.

Part II.Artist agrees to the following:

- Artist will pay for a portion of the printing cost for show cards equaling \$25.
- Artist will provide necessary information for press release and exhibition labels, including résumé/curriculum vitae, artist statement, biography, two high-resolution photos of current artwork and image list (title, year of completion, medium and price for each work on display).
- Artist will provide a minimum 5 images for use on Wood.Metal.Art Gallery website.
- Permission to reproduce Artist’s images for use on Wood.Metal.Art Gallery website and exhibition postcards.
- Artist will provide transportation of all artwork to and from Wood.Metal.Art Gallery. If work must be mailed, Artist is responsible for all packing and shipping expenses.
- Artist will provide any special installation equipment, hardware or labor. Artist will provide any video monitors and projection equipment.
- Artwork must remain installed for the duration of the dates listed above.
- At least half of the works displayed by Artist at Wood.Metal.Art Gallery will be available for sale.
- Artist must return the space to original condition. Failure to do so will result in charges for repairs and cleaning.
- Artist will comply with the deadlines in the Monthly Exhibition Schedule submitted to Artist in conjunction with this Exhibition Contract
