### **WEATHER:**

The winter weather in Chino, Ca. this time of year can vary from highs in the 70's to lows in the 40's. Please bring appropriate outdoor weather clothing for your safety and comfort.

**TRAILS:**

The trailing sites for these events offer a variety of terrains and distractions. The sites include county public parks, industrial/corporate parks, and commercial areas/malls. As always, spectators are welcome as long as they do not interfere with the main focus of the trials themselves. Trial participants and spectators should check in at the hospitality area daily for schedule and logistical information. Trial entrants will receive additional information & confirmation of their run times via email prior to the events.

**EECT:**

EECT testing may be available at this event, it will depend on judges times, availability, and necessary testing grounds. This additional event will be decided at the trial if it can be accommodated. The fee for the EECT testing is \$15.00, handler must bring a copy of the dog's AKC registration.

**DIRECTIONS:**

*The directions are copied from AKC Superintendent website [www.jbradshaw.com](http://www.jbradshaw.com)*  
FROM THE EAST: Take the Pomona Freeway (60) west. Exit at Euclid (83) and go south approximately 8 miles. The park entrance is on your left.

FROM THE NORTH OR WEST: Take Interstate 60 or 10 to the 71 Expressway and go south to Euclid (83). Turn left onto Euclid and proceed approximately 2 miles. The park entrance will be on your right.

FROM ORANGE COUNTY: Take the Riverside Freeway (91) east. Go north on the 71 Expressway. Exit right on Euclid (83) and proceed approximately 2 miles. The park entrance will be on your right.

FROM THE SOUTH: Take Interstate 15 to the Riverside Freeway (91) west. Go north on the 71 Expressway. Exit right on Euclid (83) and proceed approximately 2 miles. The park entrance will be on your right.
