**Scope:** *The Leadership Council shall act as the Charge Conference body, including approving the budget and reviewing Vital Signs and new attendees. The pastor serves as an ex officio member on the Leadership Council and all other administrative/ministry teams.*

## ADMINISTRATIVE TEAM (AT)

**Purpose:** The Administrative Team shall carry out the administrative functions of the church related to building and grounds, personnel, and financial matters in accordance with our vision of growing as a church for people of all cultures, all nations, and all ages.

**Scope:** The Administrative Team is authorized to make any administrative decision not specifically reserved to the charge conference. It carries the authority of Trustees, Finance, and Staff-Parish Relations as laid out in the United Methodist Book of Discipline.

**Membership:** The Lay Leader, AT Focus, will be the chairperson of the Administrative Team. Members serve 3 year terms, renewable one time for the same or different position on the Administrative Team. After 2 consecutive terms, a member must take 1 year off before resuming a same or different position on AT. At least 1 member shall be a young adult (age 19-30). At least 1/3 members shall be laywomen and 1/3 laymen. Only one person from an immediate family residing in the same household shall serve on the staff-parish relations sub-team (Book of Discipline ¶258.2.a, interpreted by our district superintendent).

The committee shall meet only with the knowledge of the pastor and/or the district superintendent (Book of Discipline ¶258.2.e). The pastor shall be present at each meeting except where he or she voluntarily excuses himself or herself (Book of Discipline ¶258.2.e.), but is a non-voting member of the Administrative Team due to restrictions for the Trustees and Staff-Parish (Book of Discipline ¶2525).

As long as the Communications and Office Manager serves as Financial Secretary, s/he is not on the Administrative Team. (The Book of Discipline ¶258.4 states that paid financial employees are members without vote of the committee on finance; ¶258.2 states that no staff member or immediate family of a pastor or staff member may serve on staff-parish).
