## ENTRY CONDITIONS - Lane Cove Art Award 2018

1. **SECTIONS:**  
Paintings, drawings, artists' prints, etc. may be entered in the appropriate sections.  
**Section 1:** is for scenes, buildings or portraits of local identities within the Lane Cove Municipality (this **does not** include Lane Cove National Park). See attached map of Lane Cove Municipality. Any style, any medium.  
**Section 7:** is for a scene in or around Sydney. Traditional style, any medium.  
**Section 8:** Any style, any medium.
2. **SECTIONS & ACQUISITIVE PRIZES:**  
The winning works in Sections 1, 7, 8 and the Hycorp Property Group Prize are all **acquisitive** - you may put whatever **sale** price you like on your entry, but it is understood that the sponsors will acquire these winning works for the prize money only.  
Works in Sections 2 to 6 are **non-acquisitive**.
3. **NUMBER OF ENTRIES:**  
Total of TWO works per artist.  
Each unit of a pair is regarded as a separate entry - all units may not be hung, or hung together.
4. **ENTRY FORM & FEES:**  
Handling Fee is \$30.00 per artwork (Lane Cove Art Society Members \$20.00 per artwork). Send Entry Form & Fees to J. Heffernan, 42 Richardson St., Lane Cove 2066 by **MONDAY JULY 23**. Late entries will not be accepted. Pay by Bank Transfer or send cheque payable to "Lane Cove Art Society Inc". **Not refundable under any circumstances**.
5. **DELIVERY:**  
Deliver artworks to Gallery Lane Cove on Tuesday 31 July from 11am - 3pm and Wednesday 1 August 11am - 6:30pm. The Art Society is unable to accept or return paintings by postal delivery.
6. **SALES:**  
All works must be for sale (Note: the winning works in Sections 1, 7, 8 and the Hycorp Prize are acquired for the prize money only). **GST:** It is the personal responsibility of artists, other than hobbyists, to send the appropriate contribution to the Australian Tax Office if their work is sold.
7. **COMMISSION:**  
All sales subject to 25% commission.
8. **ORIGINALITY:**  
Entries must be **original** work of Exhibitor, completed within the previous two years, and not have been entered in any previous Lane Cove Art Exhibition. **No copies**.
9. **SIZE LIMIT:**  
All works **must not exceed** 366 cm (144 inches) **total outside perimeter of the frame**. Works exceeding this limit will be rejected.
10. **NOT ACCEPTABLE:** **No** paintings on glass, photo-reproductions, computer-assisted works, Giclee prints, or 3-dimensional works will be accepted. **No wet paint**.
11. **WEIGHT LIMIT:** The committee reserves the right to not hang paintings that are excessively heavy.
12. **PRESENTATION OF ARTWORK:**  
Work must be **professionally framed** and the backs neatly **sealed**, ready to hang with cord or plastic coated wire, with no projections or unprotected glass or Perspex edges. Stretched canvas acceptable if securely corded. All screws must be covered. Paintings or canvases with **screw eyes or bare wire will not be accepted**. Any artwork deemed unsuitable may be rejected at the discretion of the Committee.  
No refunds available if your work is rejected.
13. **IDENTIFICATION:**  
Firmly attach label provided to top right hand back of painting. The details on the label must be exactly the same as that on the entry form.
14. **JUDGING AND SELECTION:**  
**All entries will be viewed by the Judges**, but not all will necessarily be hung. The Judges' decisions are final; no refunds are available for works not hung. A list of selected works will appear on the Art Society website from Tuesday 7 August 2018. see **[www.lanecoveartsociety.com.au](http://www.lanecoveartsociety.com.au)**
15. **INSURANCE:**  
*Exhibitors are responsible for their own insurance of works*. All reasonable care taken but no responsibility accepted for loss or damage while in custody or transit, or for works not collected by Sunday 19 August 2018.
16. **RESUME:** Artists are encouraged to include their C.V. (resumé) with their Entry Form.
17. **PROMOTION:**  
Exhibitors shall allow their work to be reproduced for promotional purposes or display, or for use by the media.
18. **COLLECTION OF WORKS:**  
**Saturday 18 August 2:30pm - 5pm.**  
**NO artworks may be collected before 2:30pm.**  
**And Sunday 19 August 10am -12:30pm**  
Please bring receipt. Works collected after 12:30pm on Sunday 19 August will be charged \$20 per work per day Late Pick-up Fee. Uncollected works will be disposed of at the discretion of the Committee after 30 days.
