



## Release of Liability & Refund Policy

As a parent/guardian, I HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge JB3 Sports LLC, Matsplosion and their agents, employees, officers, directors, affiliates, successors and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I or my son/daughter ever had or may have, arising from or in any way related to my child's participation in the Matsplosion Event conducted by JB3 Sports.

I understand that the activities that my son/daughter will participate in are inherently dangerous and may cause serious or grievous injuries, including bodily injury and/or death. On behalf of myself, my son/daughter, my or their heirs, assigns and next of kin, I waive all claims for damages, injuries sustained by my son/daughter that against the aforementioned released party to such activity. I also give permission for my child's photograph and likeness to appear in event posters and promotional material regarding this event.

By completing this registration and acceptance of the Release of Liability, I assume any risk, and take full responsibility and waive any claims of personal injury, death associated with the Matsplosion Event.

## Medical Release:

Without this signed authorization from parent/guardian, hospitals in many states are obligated by law to deny treatment of a contestant's injury or illness until the parent/guardian can be reached by telephone and their permission granted to begin treatment. Such a delay can prove unnecessarily painful and even dangerous to the athlete, particularly if the parent/guardian cannot be reached immediately.

To avoid such delays, the parent/guardian should check one of the options below and endorse the selection with his/her signature.

Check:

If my child named above needs medical treatment during this event it is my wish that the necessary treatment be initiated while efforts are made to contact me. So that treatment of my child will not be delayed, I consent to any medical procedures that the physician believes my child needs on the understanding that efforts will continue to be made to reach me. I accept responsibility for all costs related to such treatment.
