



## **RAD RACE Crit, Rotterdam, 04.07.2015**

### **Waver of Liability (Disclaimer):**

By entering the event site and participating in the RAD RACE CRIT event, all participants and visitors accept the following disclaimer: The organizer (RAD RACE GmbH) shall not be liable for slight negligence. This applies both for his own actions, but also for acts of his representatives or agents. The above shall not apply in case of injury to life, body or health - in these cases, the common legal regulations apply.

By registering I declare that I have sufficiently trained for the participation in this contest, that I am physically fit and that my health status has been medically confirmed. I also declare that my skills on the Fixed Gear Bike (without brakes) allow me to participate in an extreme bicyclerace such as the RAD RACE CRIT.

The organizer is not liable for any health risks and dangers to the participant.

I agree to follow the rules and regulations that are determined by the organizer (Rules & regulations will be posted on the organizers website and will be presented on the event site).

I am aware that I will be disqualified if I change the official race number in any way, especially if I make the advertising print invisible or unrecognizable. Furthermore, it is forbidden to bring animals to the event site. The RAD RACE GmbH is actively engaged to protect the environment in all areas of its business operations. The organizer also expects the participants and all stakeholders that the environment will be respected. Strict obedience to all environmental legal requirements is a presupposition. This applies in particular to the rules on waste disposal, soil- and water conservation as well as for pollution control. I am aware that the organizer reserves the right to disqualify participants from the event for the proven infringement of any of the above mentioned obligations. In cases of force majeure, the organizer of the RAD RACE CRIT (RAD RACE GmbH) can not be held liable for damages. This shall not affect a refund of the registration fee, of course. The general registration as well as the debiting of the credit cards will be executed by Fixed Days GmbH on and for the account of the organizer (RAD RACE GmbH). If individual provisions of the disclaimer or other individual provisions of the agreement are invalid, the remaining provisions shall remain unaffected. By registering I agree that the photos, film footage and interviews made by me in connection with my participation at the RAD RACE CRIT can be used, distributed and published on radio, television, internet, advertisements, books, photomechanical copies-films, video cassettes, DVD's etc. without compensation claims on my part and my name can be published in the list of results on [www.rad-race.com](http://www.rad-race.com) (as part of the media coverage of the event). I certify that my date of birth as well as any other specified data provided by me is accurate. Participation in the event is only possible if the participants are of legal age (18 years) at the moment of the registration. Should you be under the age of 18 when registering for the race, a parent or legal guardian must provide permission for your admission to the race under the condition that you are at least 16 years of age. The signed release form needs to be submitted before the start of the race in order to participate. If a participant is accountable of providing a false date of birth, RAD RACE GmbH reserves the right to impose disqualifications.

(Information as per Data Protection Act : Your data will be read by machine).

### **Rules:**

- Helmets are absolutely mandatory. No helmet – no ride !!!
- Brakeless Fixed Gear Bikes only. No installation of breaks allowed.
- The event organizer will check all participating bikes but will not be responsible for any technical malfunction of the bicycles.
- Fairplay is mandatory. Unfair racing will result in immediate disqualification.

- Instructions given by the event organizers, judges, announcers and race officials have to be followed by any means.
- Overtaking-maneuvers are always permitted and possible. It is illegal to purposely cut your contenders. The rider who is being passed has to remain within his anticipated path.
- Rad Racers who fail to compete within the formulated set of rules will be disqualified.
- In case of a slight accident the race will continue – if possible. The involved rider has the option to resume the race or immediately leave the racetrack without interference of the ongoing race.
- In case of a serious accident the race will be interrupted by the race officials and the announcer. The remaining riders have to proceed slowly to the start-/finishline where the race will be restarted with the following lap. The rider involved in the accident will be withdrawn from the race.
- There will be electronic time measurement.
- Every rad racer has to show up 10 minutes prior to his race in the paddock. Delay may result in a withdrawal from the race. A disqualified rider can not be reintegrated to competition at a later state of the race. The exchange of starting-spots is not possible.
- The organizer strongly recommends the use of drop bars even though other variations are tolerated.

#### **Transponder:**

The transponders are required for timing. They must be returned immediately after the retire of their own to the organizer. Please give them to the track marshals on the side. In case of loss of the transponder the participant is liable. It is due a composition payment of € 100 to the Rad Race GmbH.
