

WAIVER AND RELEASE FOR USAGE OF PERSONAL AUTO

This waiver and release is presented to me by Embry-Riddle Aeronautical University (“ERAU”) located at 3700 Willow Creek Road, Prescott, AZ 86301 for my participation as a volunteer driver and I agree to abide by the following:

For myself, my estate, assigns and representatives, I hereby release, indemnify, hold harmless and forever discharge ERAU, its trustees, officers, employees, and agents from any and all claims, liability, demands, lawsuits, and causes of action of any kind or nature, known or unknown, that I have or may have, arising from or related to my volunteer participation in this event. I understand that activities, of which I will take part on a volunteer basis, can be dangerous and may cause or lead to injuries, including but not limited to, broken bones, concussions, comatose state and other very serious bodily injuries up to and including death.

In consideration of ERAU’s permission for me to operate as a volunteer driver, I, for myself, my estate, assigns and representatives, hereby waive any and all claims of any kind or nature, known or unknown, for damages, injuries or losses to myself or my property arising from or related to my volunteer participation in this event. Unless required by law or valid order of court, I shall not file, allow to be filed, consent to, or cooperate with any claim, cause of action, lawsuit, or demand of any kind or nature for injuries or losses to or by me arising from or related to my volunteer participation in this event, and shall on demand defend and indemnify ERAU for any cost or expense associated therewith.

I further agree that by driving or providing my own motor vehicle for transportation to, during or from the program site, I am solely responsible for my own acts and for the safety and the security of my own vehicle as well as for my own equipment, supplies, personal property and effects during the course of the event. I accept full responsibility for the liability of myself and my passengers, and I understand that if I am a passenger in such a private vehicle, Embry-Riddle Aeronautical University and its personnel are not in any way responsible for the safety of such transportation and that Embry-Riddle Aeronautical University insurance does not cover any damage or injury suffered in the course of traveling in such a vehicle.

I hereby consent that ERAU or its agent may arrange for or provide emergency medical care that appears reasonably necessary, or transportation to such care. I understand and agree that neither ERAU, nor its trustees, officers, employees, or agents shall provide medical insurance, nor will they pay any medical cost or expense incurred by me. I shall be responsible for the payment of all such expenses, including the costs of transportation or hospitalization.

I acknowledge that I am sufficiently fit to participate as a volunteer driver in this activity or event. Being over the age of 18 years, I hereby affix my signature as evidence of my assent to, and agreement with the terms above:
