


With early detection and intervention, children enrolled in HEAR Wisconsin's Language Access Services program can perform at language levels consistent with their peers by the time they enter school. Nearly 3,000 hours of direct service were provided to children enrolled in the program in 2017.

In 2017 HEAR Wisconsin served more than 6,000 children and adults in its newly updated Hearing Healthcare Center comprised of a state-of-the-art audiology clinic and assistive listening device store.

CommunicationLink, HEAR Wisconsin's interpreter coordination service, provides sign language interpreting throughout Wisconsin. From job interviews to weddings, from medical appointments to public events, CommunicationLink makes qualified, affordable sign language interpreters available to individuals and businesses 24 hours per day, 7 days a week to eliminate communication barriers and ensure equal access. The staff includes specialists in legal and mental health interpreting.
