Speech-Language Therapy and Communication Enhancement. Individuals with hearing loss, from infants to the elderly, receive services tailored to meet their individual needs. The full range of communication options are available from visual language (ASL) to spoken English, respecting the fact that there is more than one way to live successfully with hearing loss. Families who have an infant with hearing loss receive counseling and information on communication options as well as confidence building advice on how to communicate with their child. Children develop a strong foundation of language through innovative services and rich sensory experiences. Auditory-verbal therapy is provided in outlying areas through an Internet-based program. Programs for adults are designed to meet their specific needs, which may include one-on-one therapy sessions and/or small group communication strategy classes.

4b (Code:) (Expenses \$ 432,554. including grants of \$) (Revenue \$)

Other services offered at HEAR Wisconsin, Inc. are: Community Audiology Services, a collaboration between the Center and the University of Wisconsin-Milwaukee through June 30, 2016, and as of July 1, 2017 Audiology Services are offered through a collaboration with the Medical College of Wisconsin. The Store offers assistive devices for the Deaf and Hard of Hearing. Interpreters and Deaf Benefit Specialists for Wisconsin's Office of the Deaf and Hard of Hearing's Regional Coordinators are provided through the Community Service Associates program.

CommunicationLink, HEAR Wisconsin's interpreter coordination service, provides sign language interpreting throughout Wisconsin. From job interviews to weddings, from medical appointments to public events, CommunicationLink makes qualified, affordable sign language interpreters available to individuals and businesses 24 hours per day, 7 days a week to eliminate communication barriers and ensure equal access. The staff includes specialists in legal and mental health interpreting.
