The Treasurer reported we were solvent.

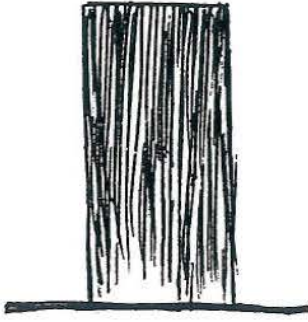
