1. RELEASE AND WAIVER OF LIABILITY: Pet Groomerie Mobile, its officers, directors, employees, agents and assigns cannot be held liable or responsible for any injuries suffered by your dog or medical conditions aggravated as a result of the grooming and/or bathing process unless such injury to your dog is the result of gross negligence or willful misconduct.

By signing these Terms & Conditions, the Customer agrees to hold Pet Groomerie Mobile, its owners, operators, employees and officers, harmless from any damage, loss, injury, action, claim or costs, including reasonable attorneys fees, arising from (i) any condition of the Dog(s), either known or unknown to Pet Groomerie Mobile, or (ii) any breach of these Terms & Conditions by the Customer.

2. CURRENT VACCINATIONS AND HEALTH OF DOG: The Customer warrants and verifies that the Dog is current on rabies, distemper and parvo-virus vaccinations. If requested by Pet Groomerie Mobile, the Customer shall provide proof of vaccination. If the Dog becomes ill or if the state of the Dog's health requires professional attention in the opinion of Pet Groomerie Mobile, Pet Groomerie Mobile, in its sole discretion, may engage the services of a veterinarian or seek to administer medicine, or a special diet, or give other requisite attention to the Dog, and the expenses thereof shall be paid by the Customer. If fleas or ticks are found during the Pet Groomerie Mobile process, Pet Groomerie Mobile is authorized to provide the Dog a flea bath to kill the parasites and in such event, an extra charge above the regular rate will be applied. In the event that ticks found during the Pet Groomerie Mobile process, Pet Groomerie Mobile is authorized to remove such tick(s) and an additional charge may be applied.

3. AGGRESSIVE OR DANGEROUS DOGS: The Customer must inform Pet Groomerie Mobile if the Dog has any history of biting other animals or people, or is aggressive to people, or other Dogs. Pet Groomerie Mobile, if necessary, may use muzzles. Pet Groomerie Mobile reserves the right to refuse or stop services for the Dog at any time before or during the Pet Groomerie Mobile process and charge an additional handling fee if the Dog becomes aggressive. If the Dog should bite any person or other Dog, the Customer agrees to be responsible for, and indemnifies Pet Groomerie Mobile for, any and all related losses, claims, actions, medical bills, costs and damages, including reasonable attorneys fees.

4. MAT REMOVAL: If Pet Groomerie Mobile determines the Dog is matted, such matting may require extra attention during the Pet Groomerie Mobile session and the Customer will be responsible for any charges that arise from any procedures performed in addition to regular services. Pet Groomerie Mobile reserves the right to refuse or stop services for the Dog at any time before or during the Pet Groomerie Mobile process, for the Dog if the Dog has excessive matting.
