### OTHER RELEVANT INFORMATION

**Box & Track Set Up/Tear Down:** AAWC will set up boxes and the 200 yard track on Friday evening if possible or Saturday morning as necessary. Your assistance is requested. Race meets require a lot of work, and those planning to run their hounds should plan to give their time and labor. We can't – and so we won't – do it without you. On Sunday, AAWC will tear down the track and pack up boxes for storage. Please do not leave the meet without helping with this necessary clean up.

**Boxing & Catching Hounds:** While we appreciate the participation of individuals with many hounds, we appreciate also when enough workers are available to manage the many hounds in competition. If you enter multiple hounds, please arrange in advance of competition for someone to box and to catch each of your dogs. There will not be enough people “hanging around” to ask for last minute assistance, and we cannot spare those workers assigned official meet positions (lure operator, line judge, foul judge and box operator) to leave their posts to manage the dogs themselves. As a rule of thumb, do not attempt to run more dogs than you have people to handle them.

**Box Training & Practice:** If your Sighthound has not seen the boxes for a while, or ever, plan to join practicebox on Saturday. As time allows, the club will offer box practice before or after the meet for any interested owners and their hounds. Hounds entering the meet may have a turn in the boxes as needed prior to inspection.

If your GPS tries to take you down a route with 30 turns between Houston and the location, ignore it and use these directions...much easier.

**From Houston:** Take Hwy 288 South to FM 1462 (Rosharon Exit). Turn left (under the freeway). Drive for about 8.5 mi until you reach County Road 185. Turn right on CR 185. Go approximately ½ -mi to the stop sign (County Road 172) and take a right. Our place is about a quarter mile on the right – brick house with big oak trees all around it and a beat-up red barn out back.

**From Freeport:** Take Hwy 288 North to FM 1462 (Rosharon Exit) and turn right. Drive for about 8.5 mil until you reach County Road 185. Turn right on CR 185. Go approximately a ½ -mile to the stop sign (County Road 172) and take a right. Our place is about a quarter mile on the right – brick house with big oak trees all around it and a beat-up red barn out back.

**From Galveston:** Take Hwy 6 West to Alvin. Turn left (South) on the Hwy 35 bypass (Home Depot and Wal-Mart on diagonal corners). Follow the bypass around Alvin (the hotels will be on your right as you drive) to FM 1462 (McDonalds on corner) and turn right. Go about 1.5 mi to the stop light for County Road 172 (Chevron on corner) and turn left. Our place is about 3.5 mi on the right – brick house with big oak trees all around it and a beat-up red barn out back.

**From Sugarland:** Take Hwy 6 East to Manvel. Turn right on Hwy 288 (South). Take Hwy 288 South to FM 1462 (Rosharon Exit) and turn left (under the freeway). Drive for about 8.5 miles until you reach County Road 185. Turn right on CR 185. Go approximately a half-mile to the stop sign (County Road 172) and take a right. Our place is about a quarter mile down on the right – brick house with big oak trees all around it and a beat-up red barn out back.

**Lodging:** Dry camping is available on site. Hotels that accept dogs in Alvin are listed below, it's recommended that you avoid the Rodeway Inn and Knight's Inn.
