Include only information necessary to depict the project and its setting (mechanical drawings are not required).

1. Ten (10) sets of Site Plan. Hand-drawn plans on 8 ½” by 11” paper are acceptable. Site Plan shall include and conform to the following requirements:
  - a. Drawn to scale;
  - b. North arrow shall be shown and oriented to top of page;
  - c. Street address of subject site;
  - d. Names of abutting streets;
  - e. Identify all building structures, and yards;
  - f. Identify parking area for non-resident employee(s);
  - g. Identify parking area for loading and unloading of children.
2. Attach License to operate a large Family Day Care Home by the State of California for the location specified in the application
