THE SITUATION

The Takata airbag recall is the largest and most complex safety recall in U.S. history. There are currently 19 affected vehicle manufacturers with an estimated 46 million unrepaired defective airbag inflators under recall in approximately 34 million U.S. vehicles.

The words “grenade” and “ticking time bomb” accurately convey the lethal potential of these defective inflators.

THE SITUATION

The Takata airbags under recall were installed in cars from model years 2000 through 2016. Some of these airbags could deploy explosively injuring or even killing car occupants. Even a minor fender bender can cause these airbag inflators to rupture, spraying metal shrapnel into drivers and passengers.



THE SITUATION

At least 22 people have been killed, including three Californians. Over 200 Americans have suffered serious injuries, including cuts or lacerations to the face or neck, broken or fractured facial bones, loss of eyesight and broken teeth. The most recent death occurred very recently on January 18, 2018 in Holiday, Florida.



THE SITUATION

There are over 500,000 cars affected by the Takata airbag recall in LA County and over 750,000 cars affected by the Takata airbag recall in the LA Metro area.

These airbags will be repaired for free if taken to a dealership.

We need your help to find these vehicles, and get them off the road and repaired immediately.

VICTIM OF INJURY CAUSED BY DEFECTIVE AIRBAGS



United States Air Force First Lt. Stephanie Erdman, from Destin, Florida, testified before members of Congress in Washington on Nov. 20, 2014. Erdman sustained injuries after a minor car accident caused the defective airbag inflator in her vehicle to explode, shooting shrapnel into her eye.

THE SETTLEMENT

In January 2017, the Japanese air bag manufacturer Takata reached a \$1 billion settlement with the U.S. Justice Department.

As part of the deal, Takata agreed to plead guilty to the felony offense of fraud. Of the \$1 billion, \$25 million will be paid as a fine to the U.S. government and \$125 million will be used for restitution to people are physically injured by the air bags. The remaining money will go to automakers that were defrauded by Takata to cover the cost of replacing recalled parts.

WHAT DRIVERS CAN DO

1. AirbagRecall.com

Put in your license plate or VIN to see if your car is a part of the recall.

If your car is a part of the recall, put in your zip code and you will see a list of the nearest dealerships. Call the dealership and schedule an appointment for a free repair. You can ask for a tow truck to pick up your car.

2. AutoAirbagsSettlement.com

Drivers might be eligible to receive a settlement of up to \$500.
