

CITY OF HAWTHORNE

ADMINISTRATIVE CITATION

SCHEDULE

The Hawthorne Municipal Code Section 1.20.030 provides that any violation of the City Code may be prosecuted as a misdemeanor, as an infraction or as a civil administrative action in the discretion of the city attorney or city prosecutor. Pursuant to California Government Code Section 36900(b), every violation of the Hawthorne Municipal Code determined to be a misdemeanor is punishable by a fine of not more than One Thousand (\$1,000.00) Dollars, or by imprisonment for a period of not more than six (6) months, or by both such fine and imprisonment. Further, every violation of the Hawthorne Municipal Code determined to be an infraction is punishable by: (1) a fine not exceeding One Hundred dollars (\$100) for a first violation; (2) a fine not exceeding Two Hundred dollars (\$200) for a second violation of the same Code provision within one year; (3) a fine not exceeding Five Hundred dollars (\$500) for each additional violation of the same Code provision within one year except as otherwise provided by City Council or as otherwise provided in the City of Hawthorne Administrative Citation Schedule. City officers delegated the responsibility of issuing administrative citations are code enforcement officers, building and safety officers and employees, public works officers and employees, animal control officers, any other city officer or employee designated by the city manager, pursuant to HMC Section 1.20.040. The City officer who issues the citation shall indicate the Code section or provision that was violated. For repeated offenses of the same Code section or provision within one calendar year, the officer will indicate the repeated offense by adding the number of repeated offenses in parentheses after the Code Section number. (For example, a second offense of HMC Section 2.22.125 would read: 2.22.125 /(2)).

Note: Unless otherwise provided by City Council, amounts for any violation of the Hawthorne Municipal Code for which no provision is made in this schedule shall be in the amount of One Hundred (\$100.00) Dollars for a first violation; Two Hundred (\$200.00) for a second violation of the same code provision within a twelve month period; and Five Hundred (\$500.00) Dollars for each additional violation of the same code provision within a twelve month period.
