I also acknowledge and agree that life coaching services are provided “as is”, without warranty of any kind, either expressed or implied, including without limitation any warranty for information services, coaching, uninterrupted access, or services provided through or in connection with the service. I represent that I am requesting Medesthai’s services voluntarily and of my own free will and that I have had sufficient time to read and review the terms herein.
