## HISTORY

The history of the Bellingham Golf and Country Club officially began in the year 1912 when the corporation of BG&CC was formed and approximately 142.5 acres were leased from the Bellingham Bay Improvement Company to construct a golf course and clubhouse.

There were 11 charter members who formed the corporation. Members paid an initiation fee of \$100.00 and the dues were \$60.00 annually. The greens fee was 50¢ per day to play the newly constructed 9-hole course. The Club purchased the land in 1919 for \$300 per acre or \$42,000.00. In 1925, nine additional holes were constructed. The grand opening of the original clubhouse was in 1913.

Since that time many renovations have been made. In 1986 a fire destroyed much of the upper floor of the clubhouse, but in true country club spirit, the membership continued to play that day with only the minor inconvenience of jumping over the fire hoses. In 2004 the membership approved a major remodel of the clubhouse, and the construction of a new Turf Center. After much study by the project oversight committee, it was decided it would be more beneficial in the club's long term interest to build a new building. A nine month building process completed the current building in time for the holiday season. The Turf Center was completed on the same timeline. In the Spring of 2006, the membership approved a major pool renovation which was completed in early June, much to the delight of the many families who consistently use the pool facility for swim lessons and pool parties.

Thus the tradition of the Bellingham Golf and Country Club carries on. The Club has been a leader in developing a strong interest in golf in the Northwest, and in bringing the people and families of Bellingham together!

## GOLF COURSE RULES

### GENERAL

1. All golf course play shall be under the direction and supervision of the Golf Professional and his representatives. All members and guests shall comply with the requests and suggestions of the Golf Professional for facilitating and speeding play on the course. Misconduct of golf etiquette or violation of course rules is to be reported to the Golf Professional, and disciplinary action will be taken by the Board of Trustees.
2. All members, guests, and others having the privilege of playing the course, shall register in the Pro Shop before teeing off.
3. All play shall start at the Number One Tee unless otherwise permitted by the Golf Professional or his representative.
4. All golf shall be restricted to designated practice areas. Practice on the course is not permitted except that a player may take an extra shot from the same position, with the permission of his fellow players, provided that there are no other golfers playing that hole or preparing to do so.
5. Replace or sand all divots, repair all ball marks on the greens, rake foot and club marks in traps. Keep power and pull carts behind the white lines designated around the greens. Power cart users should observe the 90° rule at all times – except when restricted to cart paths only.
6. All tournaments must be cleared through the General Manager and approved by the Board of Trustees.
7. No pets or livestock shall be allowed in any area of the club, except in the case of handicap assistance needs.
8. No jogging or bicycling shall be allowed on the course after 7:30 a.m.
9. If a group (5 players or less) should fail to keep their place on the course and lose a distance of one clear hole on the group in front of them, they should invite the following group to pass through. Groups must keep pace with the group in front of them, or yield to the faster group following them. Keeping pace to be defined as no more than one open hole between groups in play.
10. Instances of unusual delay and slow play shall be reported to the Golf Professional. In the event of repetition by the same individual or group, the matter shall be referred to the Board of Trustees

The Board of Trustees has authorized the Golf Professional to deviate from this schedule at his discretion during the months November 1 through February 28.

\*<sup>2</sup>Except Men's Feature Night when play is restricted to Hole In One Members Only and their guests.

\*<sup>3</sup>All Children and reciprocal play is at the discretion of the Head Golfing Professional.

\*<sup>4</sup>Holidays include Memorial Day, Independence Day and Labor Day only.

The practice range may be used by any golf member category on any day & social members on days they have a tee time. A driving range pass can be purchased for \$240 a year.

No junior activity on Wednesday.

The range is an "IRONS ONLY" practice facility.

Members may bring guests of either gender at all times except those times reserved for the Men's and Women's Divisions. (Men's Division reserved times – male guests only. Women's Division reserved times – female guests only.)

When a golf certificate has been transferred between spouses for the purpose of running and/or serving on the Board of Trustees, either the Certificate holder or the spouse may be designated as the Primary Golfer and the Primary Golfer will be the family member entitled to the privileges of a Certificate Holder.

#### **SOCIAL MEMBER RULES**

1. Social Members may play once per month. This does not include any tournament play or Mixed Golf events.
2. Social Members may play in any club tournament except club match play events. Entry to The Invitational will be allowed only if entries are not full three weeks prior to the event. Green fees will be added to tournament fees for social members in all tournaments entered.
3. Social Members may establish a handicap at the direction of the club professional.
4. Social Members may rent lockers.
5. Social Members (Clubhouse or Pool) do not have access to the practice facility except on those days for which they have a booked tee time for golf play.
6. Social members may not be guests of a golfing member.

\*Social Members who joined prior to 2003 may play on Monday, Friday and Sunday; and are entitled to invite one guest (or foursome) per month. .

#### **GUEST RULES**

1. Any individual being presented as a guest is restricted to 4 rounds per year. Play for all out of town guests should be arranged in advance with the Head Professional.
2. All golfing guests must be registered at the Pro Shop.
3. Members may bring guests of either gender at all times except those times reserved for the Men's and Women's Divisions. (Men's Division reserved times – male guests only. Women's Division reserved times – female guests only.)
4. For dining or other social purposes, a member may invite any number of guests so long as arrangements have been made in advance with the General Manager and unless the particular event is restricted to members only.

### **POWER CART RULES**

1. All carts shall use the cart paths at all places where they are established. The 90° rule shall be in effect at all times unless the Course Superintendent imposes winter cart rules.
2. 90° Rule – Cart should be driven on the path up to the point where the ball lies, then out onto the fairway (rough) at a 90° angle from the path to where the ball lies. The cart should return to the path at the 90° angle and resume on the path up to the next point where the ball lies.
3. Winter Rules – are categorized by three stages. Stage #1 is 90 degree rule through out the entire golf course, using a strict 90 degrees. Stage #2 is a strict 90 degree rule on all holes except holes #1, #2, #3, and #4, which are restricted to paths only. Stage #3 is all carts on the paths only with the opportunity of red flags at the superintendent's discretion. The superintendent may at any time restrict the carts to the paths for any reason of weather related issues at his discretion. Note: A medical waiver of this rule may be approved by obtaining a physician's letter regarding limited walking. The letter should be presented to the General Manager and Golf Professional.
4. Carts shall not be driven between any trap and green, nor shall they be driven within thirty (30) feet of any green or within ten (10) feet of any tee, unless there is an established cart path within that area.
5. Carts shall remain behind the white lines established around the green areas. (This applies to pull carts as well.)
6. Carts shall be operated in a prudent manner at all times and at minimum speed on all down slopes and across all bridges.
7. Members are expected to operate power and pull carts in a responsible way which will minimize their effect on conditioning of the course.
8. The club is not liable for any member's personal property.
9. Children (Juniors) – No children under the age of 16, may ride in a cart as a spectator, or drive such cart for liability reasons.
10. Members who use the driving range are permitted to take juniors to the range if the junior has his own set of clubs to practice with. Members will be solely responsible for the junior's actions on the range.
11. A junior is permitted to ride in a cart if a member is present with the junior during their round of play, and only if the junior meets the requirements of the junior program which enables them to play the course.
12. The Pro Shop staff will monitor these policies at all times.

### **CART LEASE PROGRAM**

This program is available to all members of the Bellingham Golf & Country Club, for an annual fee (set by the Board of Trustees). A member may use a power cart whenever he or she plays a round of golf. Listed are the conditions of the Lease Program. Conditions which must be paid monthly:

#### **Annual Fee:**

\$950 per year for a single member only.

\$1250 per year for a member and spouse only.

A) Term of the Licensee: Is one (1) year to complete the condition of the lease agreement. Cancellation of the lease agreement is not permitted during the current one (1) year term. Transferring of the lease agreement is not permitted. This License permits Licensee the use of a Licensor's cart for the term of the License.

B) In addition to the annual fee, Licensee shall be personally responsible for the payment of Licensor's costs to repair the cart and any damage resulting to property or persons from the use of the cart arising out of Licensee's misuse or negligence, including costs and attorney's fees. Repair and maintenance of the cart, except for repair arising out of Licensee's misuse or negligence, shall be the responsibility of Licensor.

C) It is agreed and understood that Licensee shall have no right of action whatsoever for damages of any kind, or nature, whether to person or property, or for any claim for loss of use resulting from unavailability of a cart. Licensee further agrees to at all times operate the cart in safe and prudent manner in accordance with such rules as may from time to

time be established for the use of cart operation.

D) This License does not guarantee cart availability, and Licensee must make reservations in advance for any daily or tournament play to the pro shop staff.

E) This License is applicable to the Licensee and/or spouse if the annual fee includes the spouse, together with non-member guests. Other club members riding in the right hand seat shall pay the fee of the club for either the nine, or eighteen hole rate, (see notice of riders below).

The Bellingham Golf & Country Club does allow the following right hand seat occupants to ride free of charge through the Lease Program if you are:

\* A guest of the member that day.

\* Another Lease Program riding member.

\* A spouse if he/she is on the Member Lease Program.

If you are normally a walker not falling into the above categories, you will be billed a normal (9) or (18) hole power cart rental fee for riding with a Lease Program rider. If you do not contact the pro shop of your desire to ride, whether with a Licensee, or splitting the cost with another walker, the pro shop will assume the duty of billing it for you.

F) This License is not assignable.

### **TOURNAMENT RECIPROCAL GOLFING POLICY**

#### **Clubs Involved Include:**

All arrangements can be made one (1) week in advance through the head professionals and their staff. Members from each club must arrange their play with their head professional or staff to make assurance of the reciprocal play. Members must not call the clubs on their own accord.

### **WEEKLY FOURSOME RECIPROCITY**

The club has agreed with several area clubs to exchange one foursome per week of reciprocal, complimentary play. These arrangements are made through the golf professionals, and are approved on a first come, first served basis. The reciprocal tee times will be set by the accommodating club. ### **HOUSE AND GROUND RULES**

1. Subscriptions, solicitations or sale of tickets for any cause shall not be permitted in the building. The name of the Bellingham Golf and Country Club shall not be used to sponsor any event or project in connections therewith unless approved by two thirds of the Board of Trustees.

2. No demonstration on behalf of any political or sectarian group shall be made in the club nor shall the distribution of printed matter pertaining thereto be permitted.

3. Notices, placards, pictures, or other written or printed material may not be posted on club property without permission of the General Manager.

4. The club disclaims responsibility for any property of members or guests.

5. Gambling shall not be permitted on the club premises except as authorized by the Board of Trustees in keeping with applicable state statutes.

6. Automobiles shall be parked properly in designated areas. No parking shall be permitted in unloading zones and no parking areas. No overnight parking shall be allowed unless approved by the General Manager.

7. Members may not store golf clubs or alcoholic beverages in their lockers.
8. Members shall not reprimand any club employee but are requested to report any incivility to the General Manager.
9. Members shall not be allowed to request special personal services from any club employee.
10. The General Manager or his representative shall have the power to eject any member or guest from the premises for any conduct which in his judgment is prejudicial to the best interests of the club and shall report this action to the Board of Trustees. Such member shall be privileged to appeal his/ her case as prescribed in the club by-laws.
11. Members and guests are not permitted behind the bar or in the kitchen.
12. No one under the legal age shall be served alcoholic beverages on club premises.
13. Children under the age of 12 must be supervised by an adult at all times.
14. Minors are not permitted in the lounge unless food service is taking place; nor are they permitted in the locker rooms unless accompanied by an adult.
15. No pets or other animals are allowed in the Clubhouse, except in the case of handicap assistance needs.
16. Picnicking on the grounds is not permitted. Food or Beverages are not to be brought to the club. Catering involving food service by outside sources is not permitted.
17. Members are required to register their guests for golf at the Pro Shop. (See Guest Rules.)
18. Members may cash personal checks up to a \$200.00 limit.
19. Reservations for dining room service are encouraged. A "no-show" charge may be applied to the member's account for failure to cancel a reservation for a special club event. This "no-show" policy does not apply to daily dining room service.
20. Smoking is not permitted in the clubhouse by vote of the membership in the fall of 2005. Smoking is permitted on the decks in designated areas.

## **DRESS CODE REQUIREMENTS**

### **General Requirements**

Appropriate golf attire will be worn at all times. The exception to this will be the pool and workout areas where appropriate dress for the activity is expected.

Denim may be worn in the clubhouse except in the fine dining room. Denim will not be allowed on the golf course, putting greens or driving range.

Metal spiked golf shoes of any kind are not allowed. Non-metal spike shoes are the only acceptable footwear allowed on the golf course.

Sweat suits of any kind will not be permitted in the grill room or the fine dining room. They are acceptable attire in the locker rooms, pool and workout areas.

Golf hats / caps or visors are not permitted in the fine dining room.

Shorts are not permitted in the fine dining room.

### **Men's Dress Code**

Appropriate golf attire shall consist of shirt and trousers or tailored shorts and shoes.

Shirts are to have collars and sleeves. Tee shirts and tank tops are not allowed, however mock turtle or turtle neck shirts are acceptable.

Shorts are to be tailored and have a length no shorter than mid thigh, no longer than the knee.

### **Ladies' Dress Code**

Appropriate golf attire shall consist of shirt or sweater, skirt, slacks or shorts and shoes.

Tank tops, halter tops, bare midriffs and tee shirts are not acceptable.

Shorts and skirts are to be tailored and have a length no less than mid-thigh.

### **Pool Area**

Swimsuits are to be worn poolside and in the pool locker rooms only. Appropriate cover ups must be worn on the upper deck.

Swimmers are not allowed to change clothes in the clubhouse locker rooms.

Members are responsible to see that their guests are properly attired and in compliance with the Dress Code Requirements.



## SWIMMING POOL RULES

All users of the pool swim entirely at their own risk.

All members and guests must register when entering the pool. Golfing and Social Pool memberships includes pool privileges, for the immediate family, at no charge. The Social Clubhouse membership does not include pool privileges of any kind.

Social Pool and Golfing members may purchase a 2 week Pool pass for visiting grandchildren. The 2 week pass is \$100 per family.

The daily guest fee (available to members with Pool privileges) is \$5.00 per person, except for Wednesdays where there is a 'No Guest Permitted' policy. Resident guests (living in Whatcom County) are limited to 3 times per month as a guest. Out-of-town guests may be afforded privileges by contacting the club office.

The pool will be open for swimming from 12:00 Noon to 8:00 p.m. unless otherwise posted on pool schedule. You can view the current Pool Schedule on our website at [www.bellinghamgcc.com](http://www.bellinghamgcc.com) after May 1st.

All persons in swimming or sun bathing attire must stay in the pool area, and are not permitted in any other part of the clubhouse, golf course, or pro shop. Showers and changing of clothing for all swimmers is restricted to the POOL LOCKER ROOMS ONLY. This applies to both golfing and social members.

A lifeguard will be on duty at all times when the pool is open. The lifeguard is employed for the swimmer's protection, and has complete authority to expel an individual from the pool for misconduct or infraction of the pool rules or other regulations deemed necessary for the safety and enjoyment of those using the pool facilities. If a lifeguard is not present, no one shall use the pool.

Running, wrestling, playing tag, and rough-housing in general is prohibited in the deck area around the pool, in the shower room, or elsewhere on the club grounds.

No children under 8 years of age shall use the pool unless under adult supervision of the child's family or a friend of the child's family, who is a club member or an employed baby-sitter 16 years or older who is also in a swimsuit. The employed baby-sitter will be permitted in the pool only when his/her charge is also in the pool, and must devote his/her entire attention to the discharge of duty. Babysitters shall register with the lifeguard, but are not subject to the guest fees. Appropriate dress for infants is a clean diaper and plastic pants. The lifeguard is not a baby-sitter, and must not be paid by any person for special attention to his/her child.

No air mattresses, inflatable rings, inner tubes, oversized plastic toys, or squirt guns are allowed at the pool. No small water toys allowed beyond the shallow end of the pool.

Catering from outside sources is not allowed. The snack shack is open daily during the summer for food and beverage service. Picnicking is not allowed on club grounds.

No glass of any kind (except for eyeglasses/sunglasses) allowed in the pool area.

Towels must be furnished by swimmers.

Care is requested that objects such as bobby pins, pins, rocks, and other small articles that might clog the drain be kept out of the pool.

Infraction of any of the rules noted above is grounds for suspension of swimming privileges by the lifeguard.

To ensure maximum enjoyment of the pool by all members and guests, it must be

recognized that the members have a responsibility for the behavior of their children. Your co-operation in this respect is necessary for the successful operation of the pool and the entire club.

The club requires each member to spend a minimum amount for food in the club every six (6) months. This minimum amount consists of FOOD CHARGES ONLY, and does not include tax, gratuity, or any beer, wine, or liquor. Should the member not meet the required minimum, they shall be charged for the unused minimum amount. For those members that reside out of town for four months or more out of the year, a "snow bird" program is available. The food minimum requirement will be calculated based on a calendar year and is \$20 more than the regular semi-annual food minimum. The member has one (1) full year to use the annual minimum.

**BELLINGHAM GOLF & COUNTRY CLUB**  
**AMENDED AND RESTATED BYLAWS** *(Approved March of 2010)*

**ARTICLE I: General**

**SECTION 1: NAME.** The name of the corporation shall be "BELLINGHAM GOLF AND COUNTRY CLUB, hereinafter referred to in these Bellingham Golf & Country Club Amended and Restated Bylaws ("Bylaws") as the "Club."

**SECTION 2: PURPOSE.** The purpose for which the Club is formed is as follows:

- (a) To own, establish and maintain on a not for profit basis social organization with clubhouse, golf course, swimming pool and such other recreational and social facilities as may from time to time be determined appropriate by the Board of Trustees.

The vision of the Club is set forth in its mission statement. The members of the Club should insure: (i) the highest quality golf course, clubhouse, facilities, service and programs; (ii) proudly nurture and enhance the Club as a desirable and welcoming place for members, spouses, children, relatives, associates, acquaintances, and others who wish to experience the uniqueness of a private country club; and (iii) to continually foster and promote recreation, relaxation and an outstanding social environment for all.

**SECTION 3: LOCATION.** The principal place of business of the Club is its Clubhouse at 3729 Meridian Street, Bellingham, Whatcom County, Washington.

**SECTION 4: INTERPRETATION.** On all questions as to the interpretation of these Bylaws, the decision of the Board shall be final.

**SECTION 5: CONSTRUCTION.** As used in these Bylaws, the plural shall include the singular and vice versa, and masculine, feminine and neuter words shall be used interchangeably.

**SECTION 6: FISCAL YEAR.** For accounting purposes, the Club shall have a fiscal year commencing January 1 and ending December 31 of each calendar year.

**SECTION 7: GOVERNING LAW.** The Club is subject to the provisions of Chapter 24.06 RCW.

**ARTICLE II: Board of Trustees**

**SECTION 1: ORGANIZATION.** The Board of Trustees ("Board") shall be thirteen (13) trustees ("Trustees") in number and duly elected as provided in Article IV of these Bylaws.

**SECTION 2: QUORUM.** All decisions of the Board shall be by majority vote of the Trustees present at a meeting at which a quorum is present, except as otherwise provided herein. Seven (7) members of the Board shall constitute a quorum for the transaction of business. Provided, when an action to be taken by the Board as hereinafter specified which requires approval of the majority or greater percentage of the entire Board (the "Entire Board"), that action requires the affirmance of seven (7) members of the Board for a simple majority and nine (9) members of the Board for a two-thirds (2/3) majority at a properly convened and conducted meeting.

**SECTION 3: POWERS.** The management of the Club's business affairs, properties and assets is vested in the Board, which shall have the authority to utilize all powers

granted by law, the Articles of Incorporation of the Club, and these Bylaws. Provided, the Board's power is limited by the terms of Section 5 of this Article II, and actions of the Board may be overruled as otherwise provided herein.

**SECTION 4: SPECIFIC AUTHORITY.** The authority and responsibility of the Board will include, but not be limited to, the authority:

- (a) To conduct the general business of the Club and establish and enforce Club policies and Club rules;
- (b) To employ professional staff, including a General Manager of the Club;
- (c) To delegate to the General Manager of the Club such authority from time to time as the Board deems appropriate so long as those powers and duties are not reserved to the Trustees or Officers or prohibited by law;
- (d) To establish the terms and conditions upon which a person may be accepted for Club membership and to examine and judge the qualifications of each applicant to determine with finality whether to accept or reject such application;
- (e) To hear and determine grievances made against any Member with full and final authority to discipline, reprimand, suspend or to expel any Member in accordance with the provisions of Article IX, Section 3 hereof;
- (f) To elect the President and President-Elect; to ratify the appointment of the Secretary and Treasurer as nominated by the President, and to ratify such other officers as nominated by the President as the Board deems appropriate provided, however, if the Board does not ratify such appointments of the President, the Board shall elect either a Secretary or Treasurer on its own motion;
- (g) To elect a successor Trustee who shall hold office for the unexpired term in the event of a vacancy on the Board, Committee or any office of the Club;
- (h) To remove a Trustee or Officer for cause by a two-thirds (2/3) affirmative vote of the Entire Board;
- (i) To approve or disapprove all presidential appointments of all permanent, temporary or special committee members and chairpersons thereof;
- (j) To determine dues, fees, and assessments, or revise schedules for dues, fees and assessments;
- (k) To authorize the purchase of materials or supplies; to authorize the employment of personnel; to contract for goods and services as may be reasonably required in the operation of the Club; to maintain and repair the Club's facilities; and to provide for capital improvements and alterations of the Club's properties and facilities;
- (l) Subject to the limitations of Section 5 hereof and by a two-thirds (2/3) affirmative vote of the Entire Board, to issue bonds and execute notes or other obligatory securities, and secure the same by pledge, mortgage, deed of trust or otherwise upon the real and/or personal property of the Club; and borrow money with Club credit and with or without security, and arrange for repayment hereof on terms and conditions deemed appropriate in the discretion of the Board;
- (m) To amend the Bylaws of the Club to correct typographical errors, so that the Bylaws conform to law, so as to make technical changes not modifying any substantive rights or obligations, or to qualify for advantageous tax treatment. Otherwise, an amendment to the Bylaws made by the Board shall not be effective until ratified by the Certificate Holders.

**SECTION 5: SPECIFIC LIMITATIONS OF AUTHORITY.** Notwithstanding the general authority that is vested in the Board pursuant to Section 4, without first obtaining the approval of the Certificate Holders, the Board shall not have the authority:

- (a) To assess the Membership in any fiscal year a special assessment in an amount exceeding Four Hundred Dollars (\$400.00);
- (b) To Increase mortgage indebtedness;
- (c) To change the maximum number of Certificate Holders authorized in Article VII, Section 1(a);
- (d) To sell, lease or otherwise dispose of or encumber the Club's real property, other than

- the granting of easements over, under or across real property owned by the Club; or
- (e) To make or enter into any contract or series of contracts in excess of \$250,000.00 for improvements, additions to, or construction of any of the principal facilities of the Club.

**SECTION 6: INDEMNIFICATION OF TRUSTEES.** The Club shall indemnify any Trustee or former Trustee of the Club against judgments, penalties, fines, settlements and reasonable expenses actually incurred by him or her in connection with any proceeding to the fullest extent authorized and subject to the provisions of Section 23B.08.500 through .600 of the Revised Code of Washington, as now enacted or as hereafter amended. The risk covered by this indemnification may be protected against by the purchase, maintenance and payment of premiums for such insurance as the Board deems appropriate. This right of indemnification shall also be extended to the Officers and General Manager and other supervisory personnel as the Board deems appropriate. Indemnification shall not be exclusive of other rights to which such Trustee or other person acting on behalf of the Club may be entitled as a matter of law.

### **ARTICLE III: Officers**

**SECTION 1: TITLES.** The Officers of the Club shall be President, President-Elect, Secretary and Treasurer, and they shall be elected or appointed for a one-year term as provided in Article II, Section 3(f) of these Bylaws; provided the President-Elect shall serve as President during the year following the President-Elect's term in that office.

**SECTION 2: QUALIFICATIONS.** Each Officer shall be a Certificate Holder in good standing. The President and President-Elect shall also be members of the Board. The Secretary and Treasurer may be, but are not required to be, members of the Board.

**SECTION 3: DUAL AND ADDITIONAL OFFICERS.** Except for the office of President, one qualified person may hold two offices. The Board by nomination from the President may also from time to time ratify the appointment of such other officers as it deems appropriate.

**SECTION 4: COMPENSATION.** No wage, salary or retainer shall be paid any Officer or Trustee of the Club.

**SECTION 5: DUTIES OF THE PRESIDENT AND PRESIDENT-ELECT.**

- (a) The President shall: (i) act as the Chief Executive Officer of the Club and preside at all Board and Member meetings; (ii) unless the Board has authorized another person to sign all deeds, contracts, promissory notes and other instruments on behalf of the Club, which require a signature of an officer of the Club, on proper authorization from the Board; and (iii) appoint members to and chairpersons for all of the Committees, subject to Board ratification as provided in Article II, Section 3(i) of these Bylaws.
- (b) In the President's absence, the President-Elect shall perform the duties of the President.
- (c) The President and President-Elect shall be ex-officio members of all permanent Committees.

**SECTION 6: DUTIES OF SECRETARY.** The Secretary shall: (i) ensure that complete and correct minutes of all Board meetings, annual meetings of Members, and special meetings of Members that are called pursuant to Article V of these Bylaws are taken, kept, and made readily available to the Membership; (ii) oversee the maintenance of the Certificate of Membership Record Books; and (iii) perform all other duties incident to the office and such other duties as are prescribed by the Board.

**SECTION 7: DUTIES OF TREASURER.** The Treasurer shall: (i) oversee the fiscal affairs of the Club, the adequacy of the Club's accounting systems and methods; (ii) recommend the selection of an outside auditor at least once every three years; (iii) oversee the preparation of the budget for each ensuing year; and (iv) perform all other duties incident of the

office and such other duties as are prescribed by the Board. At its option, the Board may request an outside audit at any time.

#### **ARTICLE IV: Elections**

**SECTION 1: ELECTION OF TRUSTEES.** Four (4) Trustees shall be elected annually by ballot of the Certificate Holders. The Trustees elected shall consist of three (3) Certificate Holders and one (1) Social Member, to serve three (3) years or until the Trustee's successor is elected and has qualified. The immediate Past-President shall be the thirteenth (13th) member of the Board.

**SECTION 2: NOMINATING COMMITTEE.** At least seventy-five (75) days prior to the annual meeting of the Club, the President shall appoint a Nominating Committee of three (3) Certificate Holders, which shall nominate five (5) Certificate Holders and two (2) Social Members. Those names shall be submitted to the Board for consideration and approval, then to the Certificate Holders for election to fill the vacancies arising on the Board at that time. Any group of five percent (5%) or more of Certificate Holders may also nominate an additional list of candidates by delivering such list to the Secretary or General Manager at least sixty (60) days prior to the annual meeting and by posting a copy of such list over their signatures upon the Club's bulletin boards. Certificate Holders may, on their ballots, write in the name or names of additional candidates for whom they wish to cast a vote.

**SECTION 3: VOTING FOR TRUSTEES.** Voting for Trustees shall be by ballot cast by mail. The Secretary shall cause to be mailed appropriate materials to the Certificate Holders at their last known address, and mailed not less than twenty (20) days and not more than fifty (50) days prior to the date of the annual meeting.

**SECTION 4: ANNOUNCEMENT OF ELECTIONS AND ASSUMPTION OF DUTIES.** The election of the incoming Trustees shall be announced to the Members at the annual meeting. Each new Trustee shall assume responsibility immediately following adjournment of the annual meeting. The announcement of the officers elected by the Board will be posted within fourteen (14) days following the annual meeting of the Club on the bulletin boards in the men's and women's locker rooms.

#### **ARTICLE V: Meetings and Voting**

**SECTION 1: MEETINGS OF MEMBERS.** The annual meeting of the Certificate Holders and all other Members shall be held on the third Tuesday of November of each year as designated by the Board; provided, however, that the Board may establish a different date for the annual meeting at its discretion. The purpose of the annual meeting is to review Club activities during the preceding year, describe matters deemed of interest to the Members, and announce the results of the election of Trustees. The agenda for the meeting shall be set by the Board of Trustees in their discretion. At the discretion of the President, other matters of interest, raised by Members, may be discussed but no vote, other than advisory, shall be taken.

- (a) **SPECIAL MEETING OF MEMBERS.** The Board shall call a meeting of the Certificate Holders or other Members of the Club at any time when requested in writing by at least ten percent (10%) of the Certificate Holders and may call such meeting upon its own motion.
- (b) **NOTICE OF MEETINGS.** Notices of any annual or special meeting of the Members shall be given by the Secretary in writing to the Members at their own last known address and mailed not less than twenty (20) days and not more than fifty (50) days prior to the date of such meeting. In the case of special meetings, the notice shall describe the purpose, time and place of the meeting, and the business of the meeting shall be confined to matters stated in the notice.



- (c) **PROCEDURE WITH REGARD TO SPECIAL MEETINGS.** If a special meeting is called by the request of ten percent (10%) of the Certificate Holders, the Board shall call a preliminary meeting. If a quorum is present at that preliminary meeting, the matter considered at the preliminary special meeting shall be submitted to the Certificate Holders for vote by mail ballot if a majority present at the preliminary meeting votes in favor of doing so. Thereafter, voting by the Certificate Holders as otherwise provided in these Bylaws shall be conducted, and the results announced at the special meeting thereafter called. No decision or action of the Board may be overturned by this process unless approved by affirmative vote to that effect by the majority of Certificate Holders of the Club.
- (d) **INFORMATIONAL MEETING.** Before any vote is held on any matter other than routine business of the Club, such as election of Trustees, an informational meeting of the Certificate Holders shall be had and, as appropriate, the Board may require that written materials, for and against any proposal, be submitted to the Certificate Holders for consideration.
- (e) **QUORUM.** Unless a higher percentage is required by law, or these Bylaws, twenty-five percent (25%) of Certificate Holders shall constitute a quorum with reference to any meeting, or mail ballot incident to a meeting of the Certificate Holders. Meetings held only for informational purposes do not require a quorum.
- (f) **VOTING.** Except as referenced with regard to a preliminary special meeting, as described in subsection (c) above, all voting by Certificate Holders shall be accomplished by mail ballots. Unless otherwise specified by these Bylaws, or by law, all ballots shall be distributed to Certificate Holders in person or by mail not less than twenty (20) days prior to the date the vote is to be counted. Such notice shall describe the purpose of the vote. To be counted, a ballot must be received by the President, Secretary or General Manager prior to the time the meeting is called to order.

**SECTION 2: BOARD OF TRUSTEES' MEETINGS.**

- (a) **MEETINGS OF THE BOARD.** The Board shall meet monthly at such time and place as it may determine. After proper notice of at least three (3) days, the Board shall hold special Board meetings at the call of the President or at the call of at least four (4) members of the Board at such time and place as the President may determine.
- (b) **ALTERNATIVE MEANS OF ATTENDANCE.** A Trustee may participate in a regular or special meeting through the use of any means of communication by which all Trustees participating in the meeting can hear each other during the meeting. A Trustee participating in a meeting by such means is deemed to be present in person and shall be included within the calculation of a quorum.
- (c) **PROXIES PROHIBITED.** Use of proxies by a Board member for the purpose of casting a vote when such Board member is not in attendance, as described in subsections (a) and (b) above, shall not be allowed.

**SECTION 3: CONDUCT OF ALL MEETINGS.** The President or his delegate shall preside at all meetings of the Board and Certificate Holders. The person presiding at any meeting shall conduct the meeting in a manner conducive to a fair exchange of ideas and opinions. Any Trustee or Certificate Holder present at a meeting who is entitled to comment on any matter before the Board or the Members shall be given a fair opportunity to be heard. The person presiding at any meeting shall have authority to maintain order and decorum and, if necessary, may adjourn a meeting from time to time in order to assure a fair process. The decision of the person presiding at any meeting shall be conclusive as to procedure and other procedural conduct of a meeting. Roberts Rules of Order shall act as a guide to the conduct of a meeting, but shall not be binding, and the failure to adhere, or a claim of failure to adhere to Roberts Rules of Order shall not negate any determina-

tion reached at the meeting which otherwise is of binding effect.

**SECTION 4: LOCATION OF MEETINGS.** Nothing in these Bylaws shall prevent meetings being held or the transaction of any business pertinent to the Club at some place other than the Clubhouse.

#### **ARTICLE VI: Committees**

**SECTION 1: PERMANENT COMMITTEES.** There shall be seven (7) Permanent Committees: Executive Committee; Finance Committee; Green Committee, Handicap Committee; House Committee; Membership Committee; and Long Range Planning Committee. The President, with the approval of the Board, shall appoint the members of all Committees. All Committee appointments shall be submitted to the Board for final action and approval.

**SECTION 2: EXECUTIVE COMMITTEE.** The Executive Committee will consist of the President, President-Elect, and one other Board member nominated by the President and ratified by the Board. The purpose of Executive Committee meetings are to discuss sensitive matters and significant situations that might affect the Club, and decide upon recommendations for action to the Board.

**SECTION 3: FINANCE COMMITTEE.** The Finance Committee shall consist of a minimum of three (3) members, which shall include the Treasurer who will serve as Chairman of the Committee. The Finance Committee shall be responsible for keeping the Board apprised of the current financial condition of the Club. Proposed expenditures in excess of \$5,000.00, or proposed operating expenses in excess of \$5,000.00 that are not already budgeted, shall be reviewed by the Finance Committee before presentation to the Board for consideration for approval of payment. The Finance Committee shall meet at least quarterly and shall report to the Board at the monthly meeting following each of its meetings.

**SECTION 4: GREEN COMMITTEE.** The Green Committee shall consist of a minimum of five (5) members, at least one of whom shall be a Board Member. The Green Committee shall oversee the maintenance of the golf course and the Club grounds with the exception of the area associated with the clubhouse, swimming pool, the pro shop and all parking areas and roadways leading to the clubhouse. The Green Committee shall establish the boundaries of the golf course and make such golf course rules as are consistent with the rules of the United States Golf Association. The Green Committee, in consultation with the Golf Professional, shall decide any controversy that may arise concerning golf course rules, subject to approval by the Board. The Green Committee shall also be consulted on settling tournament dates. The Green Committee shall meet monthly, prior to monthly Board meetings, and then give reports and recommendations to the Board each month. Provided, in the discretion of the Committee chairperson, if it is deemed that there is no pressing business, the monthly meeting may be cancelled.

**SECTION 5: HANDICAP COMMITTEE.** The Handicap Committee shall consist of a minimum of three (3) members, at least one of whom shall be a Board member. As appropriate, the Handicap Committee shall report to the Board. It shall oversee the establishment and maintenance of a handicap system consistent with the rules of the United States Golf Association.

**SECTION 6: HOUSE COMMITTEE.** The House Committee shall consist of a minimum of three (3) members, at least one (1) of whom shall be a Board member. It shall oversee the operation and maintenance of the clubhouse and the pro shop. It shall also oversee and make recommendations to the Board on all clubhouse activities and all Clubhouse facilities, including the interior furnishings and all gardens, lawn and shrubbery around the clubhouse, the pro shop and all parking areas and roadways to the clubhouse. The House Committee shall also be responsible for recommending any changes in the rules and regulations governing the use of the Clubhouse. The Board shall retain the authority to determine whether to implement the recommendations of the House Committee. The

Board may delegate to the House Committee authority to provide advice and assistance to the General Manager in promoting activities of the Club. The House Committee shall meet at least quarterly. The House Committee shall report to the Board at the Board meeting following a meeting of the House Committee or following any significant action taken by the Committee.

**SECTION 7: MEMBERSHIP COMMITTEE.** The Membership Committee shall consist of a minimum of three (3) members, at least one (1) of whom shall be a Board member. All proposals for Membership shall be investigated by the Membership Committee which shall make recommendations to the Board as to the candidate's suitability for Membership. The Membership Committee shall meet monthly, prior to the monthly Board meeting, and then give reports and recommendations to the Board each month. Provided, in the discretion of the Committee chairperson, if it is deemed that there is no pressing business, the monthly meeting may be cancelled.

**SECTION 8: LONG RANGE PLANNING COMMITTEE.** The Long Range Planning Committee shall consist of a minimum of six (6) members, at least two (2) of whom shall be Board members, and shall formulate and oversee long range proposals for Club improvements and make recommendations to the Board with respect to the funding of such improvements. The Long Range Planning Committee shall meet least bi-annually, and thereafter at the next Board meeting give its reports and recommendations to the Board.

**SECTION 9: CONTINUITY.** To further the interests of the Club, the President and Board shall establish committees and appoint members in such fashion as to promote continuity of committee membership.

#### **ARTICLE VII: Memberships**

**SECTION 1: CERTIFICATE HOLDERS.** A "Certificate" is a document issued by the Club establishing voting membership with full privileges. A "Certificate Holder" is an individual who has been accepted by the Board as provided in these Bylaws, and who has purchased a Certificate, paid appropriate fees and dues, and agrees to pay such further dues, assessments and obligations as may properly be imposed in accordance with these Bylaws. A Certificate Holder is synonymous to the traditional designation of "Golfing Member." The voting control of the Club shall be vested in its Certificate Holders. Throughout these Bylaws, reference to voting by Members means Certificate Holders.

- (a) There shall be no more than 500 Certificate Holders with any lesser number to be established by the Board.
- (b) Certificate Holders shall be limited to those who have been accepted by the Board as hereinafter provided, have purchased a Certificate, paid appropriate fees and dues, and who pay such further dues, assessments and obligations as may properly be imposed in accordance with these Bylaws.
- (c) No individual may own more than one (1) Certificate in the Club, and the Certificate will be issued in the individual's name. Provided, if a corporate Membership category is created, rules and procedures relating to such Memberships shall be established.
- (d) Certificate Holders shall be elected to Membership by the Board in conformity with Article II, Section 4 of these Bylaws and the following provisions:
  - (1) Proposals to become a Certificate Holder shall be on such forms as may be required and be furnished by the Board. Each candidate must be sponsored by at least two (2) Certificate Holders in good standing who shall affix their signatures to the proposal. The Board shall authorize such investigative and other procedures as it may consider necessary and desirable and may delegate any or all such duties to the Membership Committee.

(2) A candidate for a Certificate who has been excluded by action of the Board will not be considered for acceptance until twelve (12) months from the date of exclusion, except by unanimous agreement of Entire Board that reconsideration is justified.

(e) The annual dues paid by the Certificate Holder shall entitle the Member to golf and club privileges for the Member only. The spouse and minor children of a Member shall enjoy such Club privileges as are available under the rules and regulations adopted and published by the Board from time to time.

(f) Transfer of Certificates may be made only in the following manner:

- (1) A Certificate Holder may, with the approval of the Board, transfer the Member's Certificate to any prospective Certificate Holder who has placed his or her name on the waiting list. To accomplish the transfer, the Certificate Holder must ask the Club to place the Member's Certificate on an "Available for Sale" list which shall be made known to any prospective purchaser. Certificates deposited with the Club for sale shall be sold as soon as practicable. At such time as the Certificate is sold and funds are received from its sale, the Club shall pay to the depositing Certificate Holder or those entitled, as the case may be, the net proceeds from sale of the Certificate, after payment in full of any outstanding debts or fees owed to the Club.
- (2) Certificate Holder joining prior to March 1, 2010 who maintains a Heritage Golf Membership and is in good standing and who no longer desires the privileges of Membership and who is unable or unwilling to dispose of a Certificate as provided for by these bylaws shall be granted the option of surrendering the Certificate endorsed in favor of the Club in exchange for being relieved of liability for all future dues and assessments arising out of ownership of such certificate. A Certificate Holder joining after March 1, 2010 and/or maintains a Centennial Golf Membership, shall not have this right of surrender but rather must sell and transfer the certificate to a prospective member pursuant to subsection (f.)(1.) herein. Until such transfer is complete, the certificate holder shall remain financially responsible for all dues and assessments.
- (3) Upon transfer of a Certificate, approval of the Board, registry of the change of ownership with the Secretary of the Club, and payment of all fees, dues and assessments, the purchaser shall become a Certificate Holder of the Club.
- (4) No change of ownership shall be registered by the Secretary while there remains unpaid any indebtedness from the holder, nor until any Certificate purchase fee and transfer fee has been paid by the purchaser. The purchaser of a Certificate shall not be entitled to the privileges of the Club until such transfer is registered.
- (5) For the first two instances, no transfer or initiation fee shall be required for transfer of a Certificate by gift, inheritance or transfer by operation of law, arising from the death of a Certificate Holder, to a spouse, partner in a domestic union legally recognized where the Certificate Holder is domiciled (hereinafter subsumed in the definition of "spouse"), child or parent. Thereafter, a transfer fee shall be required in an amount established by the Board. A transfer of a Certificate between spouses for the sole purpose of making the transferee eligible for election to the Board, and the reassignment of that Certificate thereafter, shall be authorized and shall not be classified as a transfer which ultimately results in the imposition of a transfer or initiation fee.

- (6) The Board, by a majority vote, shall establish the transfer or initiation fee to be paid for the transfer of a Certificate and may change such fee from time to time, but no such change shall become effective until sixty (60) days after written notice has been given to all Certificate Holders of such change.

The Club shall establish a waiting list of persons who desire to acquire a Certificate in the Club.

**SECTION 2: SOCIAL MEMBERSHIPS.** A Social Member shall be an individual of 21 years of age or older who has been elected to Membership by the Board. A Social Member shall be issued a Social Membership card and pay such initiation fees, annual dues and other dues or assessments as established by the Board. Such Members are entitled to all the privileges of the clubhouse. A Social Member may use the golf course four times per year, with such other frequency, or limitations, as determined by the Board of Trustees, upon payment of the green fees as established by the Board. The Board shall establish the maximum number of Social Members. A Social Member shall not have the right to transfer a Social Membership except to his or her spouse or a child. A Social Membership terminates upon the member's death, voluntary termination, default in payment or allowable transfer of the membership. Social memberships must be held for a minimum of twelve months. Notwithstanding the foregoing, any Social Member whose membership was acquired prior to May 9, 2003, shall be entitled to maintain the Social Membership in accordance with the provisions of the Bylaws in effect at the time the Social Membership was obtained.

A Social Member shall not have voting rights.

**SECTION 3: PATRONAGE MEMBERSHIPS.** A Certificate Holder who has reached seventy (70) years of age, and who has been (or whose spouse has been) for the last twelve (12) consecutive years a Certificate Holder in good standing, may apply for approval of the Board to transfer to PATRONAGE Member, provided the applicant has paid in full any assessment to which the membership was subject at the time of application. The applicant shall surrender the Certificate, and shall endorse the Certificate in favor of the Club. Upon the surrender of the Certificate and proper endorsement of the Certificate as required in this article, the former Certificate Holder shall become a PATRONAGE Member accorded all of the privileges of the Club, subject to payment of such fees, dues and assessments as are established from time to time by the Board. PATRONAGE Members shall not be permitted to transfer PATRONAGE Membership status except to a spouse. PATRONAGE Certificate Holders in the Club shall be limited to a total of no more than forty (40) or such other number as may be established by the Board. Available spots will be filled from a list of eligible candidates once per year in December by way of a lottery.

A PATRONAGE Member shall not have voting rights.

**SECTION 4: YOUNG EXECUTIVE MEMBERSHIPS.** A Young Executive Membership shall be available to an individual between the age of (21) and (40) years. A Young Executive Member shall be required to pay the full cost of a Certificate and the Club initiation fee. Upon the approval of the Board, the initiation fee and certificate purchase may be prorated over a maximum of three years. Upon reaching 40 years of age and having paid in full the Certificate price and initiation or transfer fee, the Young Executive Member shall become a Certificate Holder. If a Young Executive Member fails to timely make all of the payments required for the purchase of the Certificate and initiation fee, or voluntarily resigns the Young Executive Membership, all potential membership rights shall be forfeited and there shall be no entitlement to a refund of any payments previously paid under this Section 4.

A Young Executive Member between the ages of (21) and (40) years shall pay one-half the amount of dues or assessments paid by a Certificate Holder

A Young Executive Member shall be subject to such assessments as may be established

by the Board. A Young Executive Member shall be entitled to all privileges of the Clubhouse and golf course. Membership in this group shall be limited to fifty (50) Young Executive Members or such other number as may be established by the Board. Any current Young Executive member who is less than 30 years of age as of December 31, 2008 shall be subject to all current by-laws and rule changes associated with the YOUNG EXECUTIVE category.

**SECTION 5: CASUAL GOLF MEMBERSHIPS.** As casual golf member shall have full social access to the club including; dining room, fitness room and pool area. A Casual Golf member does not have the opportunity to purchase a golf certificate and therefore does not have a vote in club business matters. Casual Golf members are subject to 50% of assessments of a full golf member. The Casual golfer has unlimited use of the driving range and can play golf after 2:00 pm April through September and after 12:00 pm October through March.

**SECTION 6: CORPORATE GOLF MEMBERSHIP**

A corporation may designate a minimum of four (4) golf members to the club. Each member will be responsible for a food minimum and will have full golf member access to the club. The corporation will pay a group initiation fee. Corporate memberships do not have the ability to purchase a golf certificate, therefore they do not have voting privileges in club business matters. The corporation is responsible for each club members charges under the corporate membership.

**SECTION 7: RESTRICTIONS ON TRANSFER.** No Member may transfer or assign the Member's Certificate or membership status, except as specifically provided in these By-laws.

**SECTION 8: NON-RESIDENT MEMBERSHIP** A non-resident member is a certificate holder whose primary residence is 75 miles away from the Club, located at 3729 Meridian St. Bellingham, WA, 98225. This member is subject to all the dues, fees and assessments associated with the category of membership but is not subject to any food minimum. Non-resident memberships are limited to ten (10) members or such other number as may be established by the Board. The predetermined distance will be established by a vote of the Board. All non-resident membership applications will be reviewed by the Board. Proof of residency as determined by the Board, will be required for all applications to this category.

**ARTICLE VIII: Dues, Fees, Assessments and Funds**

**SECTION 1: PAYMENT OF DUES, FEES AND ASSESSMENTS.** All dues, fees and assessments shall be paid as determined by the Board; however, in no case will dues, fees and assessments be payable more often than once per calendar month or accepted further in advance than one calendar quarter; provided, upon written request and approval of the Board, a Member may arrange to pay dues in advance annually or semi-annually, which advance payment shall be nonrefundable. However, the Board may require payments of fees and assessments in lump sums.

**SECTION 2: ACCOUNT DELINQUENCY.** Club dues, fees, assessments and charges are due and payable not later than thirty (30) days from the date the Club's statement is issued to the Member. Any Member failing to pay the Member's account by that date, upon resolution of the Board, shall have further credit suspended until the account is paid in full, and be suspended from the privileges of the Club and the golf course until the account is paid in full. If such indebtedness is not paid in full within sixty (60) days from the date of the statement, the Member may, upon resolution of the Board and pursuant to Article IX, be expelled from the Club and his Certificate or Membership forfeited.

**SECTION 3: CAPITAL IMPROVEMENT FUND.** Each Golfing member will be charged \$15 per month (casual, young exec, patronage members will be charged proportionally) to fund our Capital Improvement Fund. These funds shall be used for capital purchases as defined and recom-

mended by the Finance Committee and ratified by the Board of Trustees each year. These funds may never be used to fund the operational budget of the club without a vote of the membership.

#### **ARTICLE IX: Department of Members**

The Board shall have the power by the affirmative vote of two-thirds (2/3) of the Entire Board to discipline, reprimand, suspend or expel any Member of the Club for any violation of these Bylaws, for any unbecoming conduct or action which may be prejudicial to the best interests of the Club or for behavior that is disruptive or detrimental to Club operations and processes. Notice to a Member who may be subject to this article shall be given not less than one week prior to the hearing before the Board. Notice shall be given personally, or by certified mail, and if by certified mail shall be deemed received two days after regularly deposited with the United States Postal Service. The notice shall specify the actions or omissions with which the Member is charged. The Member shall have the right to be heard in his own defense and to question any person making any statement or delivering any documents to or before the Board. A Member shall be entitled to have legal counsel present to assist him and his counsel may likewise be heard in the Member's defense and to question any person providing evidence before the Board. Provided, if a Member in such a situation intends to have legal counsel, the Member shall provide notice to that effect to the Board at least three (3) days prior to the hearing. If the Member is unable or otherwise does not give such notice, and is assisted by legal counsel, the Board may, in its sole discretion, postpone the hearing for a period not to exceed seven (7) days unless circumstances beyond the control of the Board or those scheduled to appear before the Board is impractical. Upon expulsion of a Certificate Holder from the Club, the Member shall immediately deposit the Certificate with the Club pursuant to Article VII, Section 1 (f)(1). If the expelled Member fails or refuses to deposit the Certificate with the Club within one week of request to do so, the Certificate shall nevertheless be declared forfeited and cancelled.

#### **ARTICLE X: Transfer of Certificates Upon Death**

In case of the death of a Certificate Holder, the beneficiary named in the will or other testamentary instrument to receive the Certificate shall be granted a period of sixty (60) days after the death of the Member in which to make a decision whether to retain the Certificate or, alternatively to transfer to a different membership category which the beneficiary wishes to maintain or establish in the Club. The beneficiary shall make proper application for the appropriate Membership within the sixty (60) day period following the death of the Certificate Holder. If a specific beneficiary for the Certificate Holder is not determinable from the will or other instrument, the residuary heirs or beneficiaries of the Certificate Holder shall decide between themselves who shall have the right to exercise the benefits of this article. Failure of the appropriate beneficiary to notify the Club of such beneficiary's decision within sixty (60) days as provided in this article, or failure of the heirs or beneficiaries to reach agreement as to the person entitled to succeed to the Certificate Holder, shall give the Board, in its discretion, the power to cancel and sell the Certificate as provided in Article VII, Section 1(f)(1).

#### **ARTICLE XI: Administration**

**SECTION 1: CLUB FUNDS.** All funds shall be deposited in accounts at one or more federally-insured financial institutions selected by the Board. All disbursements in excess of \$5,000.00 shall be made by check drawn and countersigned by at least two (2) persons, one of whom must be a regularly elected Officer of the Club, and the other who must be either the General Manager or an employee or Officer of the Club to be designated by special resolution of the Board. The Treasurer, the General Manager and all other persons with access to Club funds shall be bonded in such amount as the Board shall direct.

**SECTION 2: GENERAL MANAGER.** The Board shall employ a General Manager who shall serve as the chief of operations responsible for the proper management of all aspects of the Club's activities, including all business, personnel and fiscal affairs of the Club. He shall report to the President and serve at the pleasure of the Board. He shall provide the overall administration of the Club pursuant to the policies adopted by the

Board within the provisions of these Bylaws and other governing instruments. His duties shall include, but not be limited to, the following:

- (a) Employ, discharge and supervise all employees or independent contractors of the Club;
- (b) Supervise and assist the Golf Professional and Golf Course Superintendent, both of whom shall report to and be accountable to the General Manager. He shall make regular assessments of their performance and such suggestions and recommendations to the Board as are requested or deemed appropriate.
- (c) Provide and supervise all goods and services to the members within the Club except those provided directly by the Golf Professional;
- (d) Work with and assist all Committees in their activities and make his services available to them; and
- (e) Assist the Officers and the members of the Board and keep them advised of all matters affecting the general welfare of the Club; attend all Board meetings, make regular reports and recommendations to the Board, and perform all other duties as may properly be assigned to him or authorized by the Board.

**SECTION 3: GOLF PROFESSIONAL AND GOLF COURSE SUPERINTENDENT.** The Golf Professional and Golf Course Superintendent shall be accountable to the General Manager and shall assist the General Manager, the Officers, Board Members, and all Committees, particularly the Greens Committee, in their endeavors.

**SECTION 4: COMPENSATION REVIEW.** The Executive Committee shall annually review the compensation and benefit schedule of the General Manager, the Golf Professional and the Golf Course Superintendent, together with any other employees of the Club deemed appropriate. This shall be completed at least one month prior to the end of the fiscal year to enable the President to make a summary report to the Board and seek approval or ratification of the prospective compensation schedule for such professional staff.

**SECTION 5: DISTRIBUTION OF BYLAWS.** Each new Member shall, upon his election to membership, be provided a complete copy of the Bylaws.

**SECTION 6: NOTICE OF FEES AND DUES.** Each Member shall from time to time be advised of the complete current structure of dues and fees as they apply to the different classifications of Membership and in case of any change shall, upon approval by the Board, be advised of such changes. The notice of change shall be given at least sixty (60) days prior to the effective date of the changes.

**SECTION 7: CLUB DOCUMENTS.** The Board shall, upon any revision of these Bylaws, give notice of that fact to the membership and may cause one copy of such revision to be mailed to each Member in good standing in every membership classification at his last known address. Additional copies of the current Articles of Incorporation and Amendments and copies of the Restated Bylaws, and any amendments thereto, shall be made available to any Member of any classification upon written request to the General Manager and upon payment of any cost as determined by the General Manager. The Articles and Bylaws shall be posted or available for review at or near the office of the General Manager.

#### **ARTICLE XII: Dissolution**

Upon dissolution of the Club, whether it be voluntary or involuntary, all liabilities and obligations of the Club shall be paid, satisfied and discharged or adequate provision for discharge made. To the extent practical all remaining assets shall be sold and distributed to those legally entitled to such distribution. Distributions may be in cash, in kind, or partially in cash and partially in kind, but the character of the money or property distributed need not be identical.

#### **ARTICLE XIII: Adoption and Effective Date**

These Amended and Restated Bylaws, incorporating all amendments through the effective date, have been duly adopted by vote of the Board of Trustees and shall become effective upon ratification by the Certificate Holders.
