IMPORTANT ELECTIONS INFORMATION | STUDENT COMMISSIONER

I. PETITION

- a. This petition requires **150 original and unique signatures** from individual UAF students currently in attendance this Spring 2016 semester
- b. The original petition, complete with signatures is due to the ASUAF Office in the Wood Center by **5:00pm on Monday, November 7th, 2016.**

II. CAMPAIGNING

- a. Candidates are free to campaign from now **until polls open at 12:00am, on Thursday November 24th.**
- b. All campaign materials (fliers, social media ads, etc.) must be fully removed by that time.
- c. The following shall be considered **illegal** forms of campaigning. **Violations of these rules may result in the removal your petition:**
 - i. Giving away non-consumables of more than five (5) dollars in value, outside of specific scheduled fund-raising events.
 - ii. Unsolicited telephone calls, emails, or social media messages targeting individuals
 - iii. Any and all use of ASUAF funds or property, (**candidates may NOT use the free printing service at ASUAF for campaign materials, or any rental equipment.**)
 - iv. Interfering directly with another candidates campaign is expressly forbidden.

III. OFFICIAL CANDIDATE REQUIREMENTS

- a. Candidates are **required** to attend an informational meeting **5:15pm on Wednesday, November 9th, 2016.** *If you are unable to attend this meeting, please contact us (see below)*
- b. A candidate biography (300 words or less) and a photo must be submitted digitally for public use to asuaf.office@alaska.edu by **5:00pm on Monday, November 7th, 2016.** *This may be submitted early at any time!*
- c. Candidates are **required** to attend **at least one** of two candidate forums from **1:00pm-2:00pm on Monday November 14th and Tuesday, November 15th, 2016.** Candidates are welcome to attend both if they wish. *If you are unable to attend either of these forums, please contact us.*

IV. ELECTION

- a. Polls will be open electronically from **12:00 AM Thursday November 24th to 11:59 PM the following Wednesday the 30th, April 14th, 2016.**
- b. Ballots will be available online through OrgSync for all six days.
- c. Physical polling stations will be available Monday – Wednesday November 28th-30th during regular business hours in the Wood Center, Dine 49, Moore-Bartlett-Skarland complex lobby, Reichardt, the UAF Community & Technical College, and any other location the Elections Board deems necessary.
