

1 AN ACT relating to crimes and punishments and making an appropriation therefor.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 453.190 is amended to read as follows:

4 (1) A court shall allow a poor person residing in this state to file or defend any action or
5 appeal therein without paying costs, whereupon he shall have any counsel that the
6 court assigns him and shall have from all officers all needful services and process,
7 including the preparation of necessary transcripts for appeal, without any fees,
8 except such as are included in the costs recovered from the adverse party, and shall
9 not be required to post any bond except in an amount and manner reasonable under
10 the circumstances of his poverty.

11 (2) A "poor person" means a person who ***has an income at or below one hundred***
12 ***percent (100%) on the sliding scale of indigency established by the Supreme***
13 ***Court of Kentucky by rule or*** is unable to pay the costs and fees of the proceeding
14 in which he is involved without depriving himself or his dependents of the
15 necessities of life, including food, shelter, or clothing.

16 (3) Application to proceed without payment of costs and fees, pursuant to subsection
17 (1) herein, shall be made by motion supported by the affidavit of the applicant
18 stating the reasons that he is unable to pay the costs and fees or give security
19 therefor.

20 (4) No inmate shall be automatically allowed to proceed through the courts in forma
21 pauperis by virtue of his status as an inmate, nor shall his incarceration lead to a
22 presumption of impoverishment, or constitute evidence of a rebuttable presumption
23 of impoverishment.

24 (5) A court may consider the value of all of the benefits an inmate receives by virtue of
25 his incarceration and for which the inmate has not monetarily reimbursed the
26 Commonwealth, including, among other things, the value of his room, board,
27 medical care, dental care, recreational programming, educational opportunities

1 offered to the inmate, legal services provided to the inmate without cost, clothing,
2 laundry, guard protection services, or any other benefit similarly conferred upon the
3 inmate.

4 ➔Section 2. KRS 23A.205 is amended to read as follows:

- 5 (1) Court costs for a criminal case in the Circuit Court shall be one hundred dollars
6 (\$100).
- 7 (2) The taxation of court costs against a defendant, upon conviction in a case, shall be
8 mandatory and shall not be subject to probation, suspension, proration, deduction,
9 or other form of nonimposition in the terms of a plea bargain or otherwise, unless
10 the court finds that the defendant is a poor person as defined by KRS 453.190(2)
11 and that he or she is unable to pay court costs and will be unable to pay the court
12 costs in the foreseeable future.
- 13 (3) If the court finds that the defendant does not meet the standard articulated in
14 subsection (2) of this section and that the defendant is nonetheless unable to pay the
15 full amount of the court costs, ~~and~~ fees, or fines at the time of sentencing, then the
16 court ~~shall establish a show cause date by which time the court costs, fees, and~~
17 ~~fines shall be paid and~~ may establish an installment payment plan in accordance
18 with Section 4 of this Act ~~whereby the defendant pays the full amount of the court~~

25 ➔Section 3. KRS 24A.175 is amended to read as follows:

- 26 (1) Court costs for a criminal case in the District Court shall be one hundred dollars
27 (\$100), regardless of whether the offense is one for which prepayment is permitted.

- 1 (2) There shall be no court costs for a parking citation when:
- 2 (a) The fine is paid to the clerk before the trial date in the same manner as
- 3 provided for speeding citations under KRS 189.394(3); and
- 4 (b) The citation does not involve parking in a fire lane or blocking the traveled
- 5 portion of the highway.
- 6 (3) The taxation of court costs against a defendant, upon conviction in a case, including
- 7 persons sentenced to state traffic school as provided under KRS 186.574, shall be
- 8 mandatory and shall not be subject to probation, suspension, proration, deduction,
- 9 or other form of nonimposition in the terms of a plea bargain or otherwise, unless
- 10 the court finds that the defendant is a poor person as defined by KRS 453.190(2)
- 11 and that he or she is unable to pay court costs and will be unable to pay the court
- 12 costs in the foreseeable future.
- 13 (4) If the court finds that the defendant does not meet the standard articulated in
- 14 subsection (3) of this section and that the defendant is nonetheless unable to pay the

- 25 (5) Notwithstanding any other provision to the contrary, the court shall not adjudicate a
- 26 traffic violation involving a defendant who is under the age of eighteen (18), unless
- 27 the person that assumed liability of the minor under the provisions of KRS 186.590

1 is present. This subsection shall not apply to emancipated minors.

2 ➔Section 4. KRS 534.020 is amended to read as follows:

3 (1) When a defendant is sentenced to pay **court costs, fees, or fines**~~[a fine]~~, the court
4 may provide for payment to be made within a specified period of time or in
5 specified installments. If no such provision is made a part of the sentence, then the
6 **court costs, fees, or fines**~~[fine]~~ shall be payable forthwith.

7 (2) **If the court establishes an installment payment plan for a defendant to pay the**
8 **full amount of court costs, fees, or fines:**

9 (a) **The defendant shall be given notice of the total amount due, the payment**
10 **frequency, and the date by which all payments must be made. The notice**
11 **shall indicate that if the defendant has not complied with the installment**
12 **payment plan by the scheduled date, he or she shall appear on that date to**
13 **show good cause as to why he or she is unable to satisfy the obligations.**
14 **This notice shall be given to the defendant in writing on a form provided by**
15 **the Administrative Office of the Courts;**

16 (b) **Except as provided in subsection (3) of this section, all court costs, fees, and**
17 **fees shall be paid within one (1) year of the date of sentencing**
18 **notwithstanding any remaining restitution or other monetary penalty owed**
19 **by the defendant and arising out of the conviction; and**

20 (c) **Installment payments shall be applied first to court costs, then to restitution,**
21 **then to fees, and then to fines.**

22 (3) (a) **If a defendant is required to appear at a show cause hearing pursuant to**
23 **subsection (2)(a) of this section, the court shall determine whether the**
24 **defendant's default in payment of court costs, fees, or fines is:**

25 **1. Excusable due to an inability to pay, and if so, the court may enter an**
26 **order allowing additional time for payment, reducing the amount of**
27 **each installment, or modifying the manner of payment in any other**

1 way; or

2 2. Willful and not due to an inability to pay, and if so, the court may
 3 order the defendant to jail on the condition that the defendant shall be
 4 released upon payment or completion of daily credit pursuant to
 5 Section 6 of this Act.

6 (b) If the defendant fails to appear at the show cause hearing, the court may
 7 issue a warrant for the defendant's arrest. Any warrant for arrest issued for
 8 nonpayment of court costs, fees, or fines pursuant to this subsection shall
 9 include a notice to the jailer that the defendant shall be released upon
 10 payment or completion of daily credit pursuant to Section 6 of this Act.

11 (4) When a defendant is sentenced to pay court costs, fees, or fines~~[a fine]~~, an
 12 alternative sentence of imprisonment that is to be served in the event the court
 13 costs, fees, or fines are~~[fine is]~~ not paid shall not be imposed at the same time. The
 14 response of a court to nonpayment~~[of a fine]~~ shall be determined only after:

15 (a) The court costs, fees, or fines have~~[fine has]~~ not been paid; and~~[,]~~

16 (b) 1. The show cause hearing has been held pursuant to subsections (2)(a)
 17 and (3)(a) of this section; or
 18 2. The defendant has failed to appear at the show cause hearing as
 19 outlined in subsection (3)(b) of this section~~[and as provided in KRS~~
 20 ~~24A.175 or 534.060].~~

21 (5) Court costs, fees, or fines being paid under an installment payment plan that is
 22 actively monitored by the court shall not be reported as part of the inventory of
 23 liquidated debt pursuant to KRS 45.241.

24 ➔Section 5. KRS 534.060 is amended to read as follows:

25 ~~[(1) When an individual sentenced to pay a fine defaults in the payment of the fine or~~
 26 ~~any installment, the court upon motion of the prosecuting attorney or upon its own~~
 27 ~~motion may require him to show cause why he should not be imprisoned for~~

1 ~~nonpayment. The court may issue a warrant of arrest or a summons for his~~
2 ~~appearance.~~

3 ~~(2) Following an order to show cause under subsection (1) of this section, unless the~~
4 ~~defendant shows that his default was not attributable to an intentional refusal to~~
5 ~~obey the sentence of the court and not attributable to a failure on his part to make a~~
6 ~~good faith effort to obtain the necessary funds for payment, the court may order the~~
7 ~~defendant imprisoned for a term not to exceed:~~

8 ~~(a) Six (6) months, if the fine was imposed for the conviction of a felony; or~~

9 ~~(b) One third (1/3) of the maximum authorized term of imprisonment for the~~

19 ~~pay the fine from assets of the corporation. The failure of such persons to do so shall~~
20 ~~render them subject to imprisonment under subsections (1) and (2) of this section.~~

21 ~~[(5) Following a default in the payment of a fine or any installment thereof, the fine may~~
22 ~~be collected by any means authorized for the enforcement of money judgments~~
23 ~~rendered in favor of the Commonwealth.]~~

24 ➔ Section 6. KRS 534.070 is amended to read as follows:

25 (1) A defendant who has been sentenced to jail for failure to pay ~~[\del a fine or]~~ court costs,
26 fees, or fines or for failure to appear in court on a date set for the sole purpose of
27 addressing nonpayment of ~~[\del a fine or]~~ court costs, fees, or fines shall receive credit

1 against the ~~court~~~~[fine and]~~ costs, fees, or fines owed for each day the defendant
2 spends in jail at the following rates:

3 (a) ~~Seventy-five~~~~[Fifty]~~ dollars ~~(\$75)~~~~(\$50)~~ per day if the defendant does not work
4 at a community service or community labor program; or

5 (b) One hundred ~~fifty~~ dollars ~~(\$150)~~~~(\$100)~~ per day if the defendant works eight
6 (8) hours per day at a community service or community labor program. If the
7 defendant works less than eight (8) hours in a community service or
8 community labor program, the defendant shall be allowed an amount of
9 eighteen dollars and seventy-five cents (\$18.75)~~[one-eighth (1/8) of the one~~
10 ~~hundred dollars (\$100)]~~ for each hour worked in a community service or
11 community labor program.

12 (2) Credit against~~[a fine or]~~ court costs, fees, or fines earned by a defendant pursuant
13 to this section shall prohibit the collection of any part of ~~court~~~~[a fine or]~~ costs, fees,
14 or fines which has been credited pursuant to this section, and that portion of the
15 ~~court~~~~[fine or]~~ costs, fees, or fines shall be considered paid.

16 (3) (a) The jailer shall be responsible for monitoring a defendant's community service
17 and tracking the number of days to be served to pay any outstanding~~[fine or]~~
18 court costs, fees, or fines.

19 (b) Unless the defendant is incarcerated pursuant to orders in other cases, upon
20 the service of sufficient days in jail to have sufficient credit to satisfy the
21 court costs, fees, or fines, the defendant shall be released from jail.

22 (4) If a partial payment is made by the defendant or on behalf of a defendant, that
23 payment shall be applied first to court costs, then to fees, and then to fines pursuant
24 to Section 4 of this Act~~[KRS 23A.205 or 24A.175]~~ prior to the application of any
25 credit earned pursuant to this section. Credit earned pursuant to this section shall
26 not be applied to restitution.

27 ➔Section 7. KRS 45.237 is amended to read as follows:

- 1 (1) As used in KRS 45.237 to 45.239:
- 2 (a) "Agency" means an organizational unit or administrative body in the
3 executive branch of state government as defined in KRS 12.010;
- 4 (b) "Cabinet" means the Finance and Administration Cabinet;
- 5 (c) "Court of Justice" means the Administrative Office of the Courts, all courts,
6 and all clerks of the courts;
- 7 (d) "Debt" means:
- 8 1. For agencies, a sum certain which has been certified as due and owing;
- 9 2. For local governments, a sum certain which has been certified as due
10 and owing, including but not limited to any delinquent taxes or fees
11 other than delinquent real and personal property taxes; and
- 12 3. For the Court of Justice, a legal debt, including any fine, fee, court costs,
13 or restitution due the Commonwealth, which have been imposed by a
14 final sentence of a trial court of the Commonwealth and for which the
15 time permitted for payment pursuant to Section 4 of this Act~~KRS~~
16 ~~23A.205(3) or 24A.175(4)]~~ has expired;
- 17 (e) "Department" means the Department of Revenue;
- 18 (f) "Improper payment" means a payment made to a vendor, provider, or recipient
19 due to error, fraud, or abuse; and
- 20 (g) "Local government" means any city, county, urban-county government,
21 consolidated local government, charter county government, or unified local
22 government of the Commonwealth.
- 23 (2) The cabinet shall develop for the executive branch of state government a system of
24 internal controls and preaudit policies and procedures applicable to disbursement
25 transactions for the purpose of prevention and detection of errors or fraud and abuse
26 prior to the issuance of a check or warrant. The initial policies and procedures shall
27 focus first on programs or activities that expend the most federal and general fund

1 dollars. The cabinet shall develop preaudit procedures that meet the unique needs of
2 each agency.

3 (3) In establishing these systems of internal control and preaudit policies and
4 procedures, the cabinet shall:

5 (a) Consult with each agency within the executive branch to ascertain its unique
6 fraud risks;

7 (b) Establish policies and procedures for agency-level oversight of fraud risks,
8 including risk assessment, risk tolerance, and management policies, and fraud-
9 prevention processing controls;

10 (c) Establish systems and procedures for detecting both unintentional errors and
11 fraudulent misrepresentations that may have occurred in vendor invoices
12 submitted for payment, applications submitted for benefits, claims for refunds
13 of amounts previously paid or withheld, and other disbursements;

14 (d) Establish systems and procedures for preventing and detecting unintentional
15 errors and the fraudulent disbursement of funds by state government
16 employees in the processing, approving, and paying of invoices, refunds,
17 vouchers, benefit payments, and other disbursements; and

18 (e) Consult with the state Auditor of Public Accounts, the Commonwealth Office
19 of Technology, the American Institute of Certified Public Accountants, the
20 Association of Certified Fraud Examiners, law enforcement agencies, or any
21 other entity with knowledge and expertise in the detection and prevention of
22 fraud.

23 (4) Each agency shall diligently attempt to collect amounts paid to a vendor, provider,
24 or recipient due to error, fraud, or abuse for sixty (60) days after the improper
25 payment is discovered. If the improper payment has not been recovered after sixty
26 (60) days, the agency shall certify the improper payment as a debt of the agency and
27 shall refer all certified debts to the department.

- 1 (5) A local government may, after making reasonable efforts to collect its debts, by
2 ordinance, resolution, or otherwise pursuant to law, certify its debts that have been
3 due and owing for more than ninety (90) days to the department for collection. The
4 department may, by administrative regulation promulgated in accordance with KRS
5 Chapter 13A, prescribe the form and format of, and the information required in,
6 referrals by a local government, which may be required to be made electronically.
- 7 (6) Any funds recovered by an agency within the sixty (60) day collection period
8 allowed under subsection (4) of this section and prior to referral to the department
9 shall be allocated to the fund from which the improper payment was expended.
- 10 (7) Each agency shall submit annual summaries of debts due to error, fraud, or abuse,
11 improper payments discovered, and certified debts referred to the department to the
12 Legislative Research Commission. These summaries shall include but not be
13 limited to:
- 14 (a) Debts owed the Commonwealth that have been identified by the agency, in
15 accordance with the preaudit procedures established under this section, as
16 those resulting from error, fraud, or abuse, of either the payee or the state
17 agency;
- 18 (b) The aggregate amount of money collected by the agency on those debts during
19 the sixty (60) day period allowed under subsection (4) of this section; and
- 20 (c) The aggregate amount of certified debts that the agency referred to the
21 department.
- 22 (8) Each agency shall provide information about each debt due to error, fraud, or abuse
23 that is certified under this section to the State Treasurer for the Treasurer's action
24 under KRS 44.030(1).
- 25 (9) Each local government shall, where feasible, provide information about each debt
26 that is certified pursuant to this section to the State Treasurer for the Treasurer's
27 action under KRS 44.030(1).

1 ➔Section 8. KRS 45.241 is amended to read as follows:

2 (1) As used in this section:

3 (a) "Debt" means:

4 1. For agencies, a sum certain which has been certified by an agency as due
5 and owing; and

6 2. For local governments, a sum certain which has been certified by a local
7 government as due and owing, including but not limited to any
8 delinquent taxes or fees other than delinquent real and personal property
9 taxes;

10 (b) "Liquidated debt" means:

11 1. For agencies, a legal debt for a sum certain which has been certified by
12 an agency as final due and owing, all appeals and legal actions having
13 been exhausted;

14 2. For local governments, a legal debt for a sum certain which has been
15 certified by a local government as final due and owing, all appeals and
16 legal actions having been exhausted, including but not limited to any
17 delinquent taxes or fees other than delinquent real and personal property
18 taxes; and

19 3. For the Court of Justice, a legal debt including any fine, fee, court costs,
20 or restitution due the Commonwealth, which have been imposed by a
21 final sentence of a trial court of the Commonwealth and for which the
22 time permitted for payment pursuant to the provisions of Section 4 of
23 this Act~~[KRS 23A.205(3) or 24A.175(4)]~~ has expired;

24 (c) "Agency" means an organizational unit or administrative body in the
25 executive branch of state government, as defined in KRS 12.010;

26 (d) "Department" means the Department of Revenue;

27 (e) "Court of Justice" means the Administrative Office of the Courts, all courts,

- 1 and all clerks of the courts;
- 2 (f) "Forgivable loan agreement" means a loan agreement entered into between an
3 agency and a borrower that establishes specific conditions, which, if satisfied
4 by the borrower, allows the agency to forgive a portion or all of the loan;
- 5 (g) "Improper payment" means a payment made to a vendor, provider, or recipient
6 due to error, fraud, or abuse; and
- 7 (h) "Local government" means any city, county, urban-county government,
8 consolidated local government, charter county, or unified local government of
9 the Commonwealth.
- 10 (2) Each agency and the Court of Justice shall develop, maintain, and update in a timely
11 manner an ongoing inventory of each debt owed to it, including debts due to
12 improper payments, and shall make every reasonable effort to collect each debt.
13 Within sixty (60) days after the identification of a debt, each agency shall begin
14 administrative action to collect the debt.
- 15 (3) The Auditor of Public Accounts shall review each agency's debt identification and
16 collection procedures as part of the annual audit of state agencies.
- 17 (4) An agency shall not forgive any debt owed to it unless that agency has entered into a
18 forgivable loan agreement with a borrower, or unless otherwise provided by statute.
- 19 (5) For those agencies without statutory procedures for collecting debts, the Department
20 of Revenue shall promulgate administrative regulations in accordance with KRS
21 Chapter 13A to prescribe standards and procedures with which those agencies shall
22 comply regarding collection of debts, notices to persons owing debt, information to
23 be monitored concerning the debts, and an appeals process.
- 24 (6) (a) Each agency and the Court of Justice shall identify all liquidated debts,
25 including debts due to improper payments, and shall submit a list of those
26 liquidated debts in the form and manner prescribed by the department to the
27 department for review. The department shall review the information submitted

1 by the agencies and the Court of Justice and shall, within ninety (90) days of
2 receipt of the information, determine whether it would be cost-effective for
3 the department to further pursue collection of the liquidated debts.

4 (b) A local government, after making reasonable efforts to collect its debts, may
5 by ordinance, resolution, or otherwise pursuant to law, submit a list of its
6 liquidated debts that have been due and owing for more than ninety (90) days
7 to the department for review to determine whether it would be cost-effective
8 for the department to pursue collection of the liquidated debts. The
9 department shall review the information submitted by a local government and
10 shall, within ninety (90) days of receipt of the information, determine whether
11 it would be cost-effective for the department to further pursue collection of the
12 liquidated debts.

13 (c) The department may, after consultation with the agency, Court of Justice, or a
14 local government, return the liquidated debt to the entity submitting the
15 liquidated debt if:

- 16 1. The request for review contains insufficient information; or
- 17 2. The debt is not feasible to collect.

18 Any return of a liquidated debt shall be in writing, and shall state why the debt
19 is being returned.

20 (d) The department shall identify in writing to the submitting agency, Court of
21 Justice, or local government, the liquidated debts it has determined that it can
22 pursue in a cost-effective manner, and the agency, Court of Justice, or local
23 government shall officially refer the identified liquidated debts to the
24 department for collection.

25 (e) The agency, Court of Justice, and local government shall retain a complete
26 record of all liquidated debts referred to the department for collection until the
27 debt is collected, forgiven, or returned as uncollectible.

- 1 (f) Each agency, the Court of Justice, and local government shall make
2 appropriate accounting of any uncollected debt as prescribed by law.
- 3 (7) (a) If the agency recovers the debt funds prior to referral to the department, the
4 agency shall retain the collected funds in accordance with its statutory
5 authority.
- 6 (b) 1. Upon referral of a liquidated debt to the department, the liquidated debt
7 shall accrue the following amounts:
- 8 a. Interest on the total amount of the debt plus legal accruals at the
9 tax interest rate provided in KRS 131.183, from the time of referral
10 until paid; and
- 11 b. A one (1) time twenty-five percent (25%) collection fee on the
12 total amount of the debt plus legal accruals, as of the time of
13 referral;
- 14 unless the interest and collection fee are waived by the department.
- 15 2. The interest and collection fee shall be in addition to any other costs
16 accrued prior to the time of referral.
- 17 3. The department may deduct and retain from the liquidated debt
18 recovered an amount equal to the lesser of the collection fee or the
19 actual expenses incurred in the collection of the debt.
- 20 4. In the case of agencies and the Court of Justice, any funds recovered by
21 the department after the deduction of the department's cost of collection
22 expenses may, at the discretion of the secretary of the Finance and
23 Administration Cabinet, be returned to the agency identifying the
24 liquidated debt or to the Court of Justice for allocation as otherwise
25 provided by law. If the recovered funds and interest are not returned to
26 the agency or Court of Justice, the amounts shall be deposited in the
27 general fund, except for Medicaid benefits funds and funds required by

1 law to be remitted to a federal agency, which shall be remitted as
2 required by law.

3 5. In the case of local governments, any funds recovered by the department
4 after the deduction of the department's cost of collection expenses shall
5 be returned to the local government referring the liquidated debt, for
6 allocation as provided by ordinance, resolution, or as otherwise provided
7 by law.

8 (c) Nothing in this section shall prohibit the department from entering into a
9 memorandum of agreement with an agency pursuant to KRS 131.130(11), for
10 collection of debts prior to liquidation. If an agency enters into an agreement
11 with the department, the agency shall retain funds collected according to the
12 provisions of the agreement.

13 (d) This section shall not affect any agreement between the department and an
14 agency entered into under KRS 131.130(11) that is in effect on July 13, 2004,
15 that provides for the collection of liquidated debts by the department on behalf
16 of the agency.

17 (e) This section shall not affect the collection of delinquent taxes by sheriffs or
18 county attorneys under KRS 91A.070 or 134.504.

19 (f) This section shall not affect the collection of performance or reclamation

18 individual shall immediately accept or object to the sanction or sanctions proposed
19 by the officer. The failure of the supervised individual to comply with a sanction
20 shall constitute a violation of community supervision.

21 (4) If the supervised individual objects to the imposition of the sanction or sanctions,
22 then:

23 (a) If the supervised individual is serving a period of parole or post-release
24 supervision from prison or jail, then the administrative process promulgated
25 under KRS 439.3107(3) shall apply; or

26 (b) If the supervised individual is on probation, then the provisions of KRS
27 533.050 shall apply.

- 1 (5) If the graduated sanction involves confinement in a correctional or detention
2 facility, confinement shall be approved by the probation and parole district
3 supervisor, but the supervised individual may be taken into custody for up to four
4 (4) hours while such approval is obtained. If the supervised individual is employed,
5 the probation and parole officer shall, to the extent feasible, impose this sanction on
6 weekend days or other days and times when the supervised individual is not
7 working.
- 8 (6) A sanction that confines a supervised individual in a correctional or detention
9 facility for a period of more than ten (10) consecutive days, or extends the term of
10 community supervision, shall not be imposed as a graduated sanction, except
11 pursuant to an order of the court or the board.
- 12 (7) Upon successful completion of a graduated sanction or sanctions, a court may not
13 revoke the term of community supervision or impose additional sanctions for the
14 same violation.
- 15 (8) If a probation and parole officer modifies the conditions of community supervision
16 by imposing a graduated sanction, the officer shall:
- 17 (a) Deliver a copy of the modified conditions to the supervised individual;
- 18 (b) File a copy of the modified conditions with the sentencing court or releasing
19 authority; and
- 20 (c) Note the date of delivery of the copy in the supervised individual's file or case
21 management system.
- 22 ➔Section 15. KRS 439.3406 is amended to read as follows:
- 23 (1) The board shall order mandatory reentry supervision six (6) months prior to the
24 projected completion date of an inmate's sentence for an inmate who has not been
25 granted discretionary parole.
- 26 (2) The provisions of subsection (1) of this section shall not apply to an inmate who:
- 27 (a) Is not eligible for parole by statute;

- 1 (b) Has been convicted of a capital offense or a Class A felony;
- 2 (c) Has a maximum or close security classification as defined by administrative
3 regulations promulgated by the department;
- 4 (d) Has been sentenced to two (2) years or less of incarceration;
- 5 (e) Is subject to the provisions of KRS 532.043;~~or~~
- 6 (f) Has six (6) months or less to be served after his or her sentencing by a court or
7 recommitment to prison for a violation of probation, shock probation, parole,
8 or conditional discharge;
- 9 **(g) If recommitted to prison for a violation of probation, shock probation,**
10 **parole, or conditional discharge, has not served at least six (6) months since**
11 **being recommitted; or**
- 12 **(h) Has twice been released on mandatory reentry supervision.**
- 13 (3) An inmate granted mandatory reentry supervision pursuant to this section may be
14 returned by the board to prison for violation of the conditions of supervision and
15 shall not again be eligible for mandatory reentry supervision during the same period
16 of incarceration.
- 17 (4) An inmate released to mandatory reentry supervision shall be considered to be
18 released on parole.
- 19 (5) Mandatory reentry supervision is not a commutation of sentence or any other form
20 of clemency.
- 21 (6) No hearing shall be required for the board to order an inmate to mandatory reentry
22 supervision pursuant to subsection (1) of this section. Terms of supervision for
23 inmates released on mandatory reentry supervision shall be established as follows:
- 24 (a) The board shall adopt administrative regulations establishing general
25 conditions applicable to each inmate ordered to mandatory reentry supervision
26 pursuant to subsection (1) of this section. If an inmate is ordered to mandatory
27 reentry supervision, the board's order shall set forth the general conditions and

1 shall require the inmate to comply with the general conditions and any
2 requirements imposed by the department in accordance with this section;

3 (b) Upon intake of an inmate ordered to mandatory reentry supervision by the
4 board, the department shall use the results of the risk and needs assessment
5 administered pursuant to KRS 439.3104(1) to establish appropriate terms and
6 conditions of supervision, taking into consideration the level of risk to public
7 safety, criminal risk factors, and the need for treatment and other
8 interventions. The terms and conditions imposed by the department under this
9 paragraph shall not conflict with the general conditions adopted by the board
10 pursuant to paragraph (a) of this subsection; and

11 (c) The powers and duties assigned to the commissioner in relation to probation
12 or parole under KRS 439.470 shall be assigned to the commissioner in
13 relation to mandatory reentry supervision.

14 (7) Subject to subsection (3) of this section, the period of mandatory reentry
15 supervision shall conclude upon completion of the individual's minimum expiration
16 of sentence.

17 (8) If the board issues a warrant for the arrest of an inmate for absconding from
18 supervision during the mandatory reentry supervision period, and the inmate is
19 subsequently returned to prison as a violator of conditions of supervision for
20 absconding, the inmate shall not receive credit toward the remainder of his or her
21 sentence for the time spent absconding.

22 (9) The department shall report the results of the mandatory reentry supervision
23 program to the Interim Joint Committee on Judiciary by February 1, 2015.

24 ➔Section 16. KRS 17.510 is amended to read as follows:

25 (1) The cabinet shall develop and implement a registration system for registrants which
26 includes creating a new computerized information file to be accessed through the
27 Law Information Network of Kentucky.

- 1 (2) A registrant shall, on or before the date of his or her release by the court, the parole
2 board, the cabinet, or any detention facility, register with the appropriate local
3 probation and parole office in the county in which he or she intends to reside. The
4 person in charge of the release shall facilitate the registration process.
- 5 (3) Any person required to register pursuant to subsection (2) of this section shall be
6 informed of the duty to register by the court at the time of sentencing if the court
7 grants probation or conditional discharge or does not impose a penalty of
8 incarceration, or if incarcerated, by the official in charge of the place of confinement
9 upon release. The court and the official shall require the person to read and sign any
10 form that may be required by the cabinet, stating that the duty of the person to

20 of the duty to register by that state, territory, or court, or who has been
21 committed as a sexually violent predator under the laws of another state, laws

4 **create a duty to register. This paragraph shall be retroactive.**

5 (7) **(a) Except as provided in paragraph (b) of this subsection,** if a person is
6 required to register under federal law or the laws of another state or territory,
7 or if the person has been convicted of an offense under the laws of another
8 state or territory that would require registration if committed in this
9 Commonwealth, that person upon changing residence from the other state or
10 territory of the United States to the Commonwealth or upon entering the
11 Commonwealth for employment, to carry on a vocation, or as a student shall
12 comply with the registration requirement of this section, including the
13 requirements of subsection (4) of this section, and shall register within five (5)
14 working days with the appropriate local probation and parole office in the
15 county of residence, employment, vocation, or schooling. A person required to
16 register under federal law or the laws of another state or territory shall be
17 presumed to know of the duty to register in the Commonwealth. As used in

3 include registrant information, including an up-to-date photograph of the registrant

- 5 (9) For purposes of KRS 17.500 to 17.580 and 17.991, a post office box number shall
6 not be considered an address.
- 7 (10) (a) If the residence address of any registrant changes, but the registrant remains in
8 the same county, the person shall register, on or before the date of the change
9 of address, with the appropriate local probation and parole office in the county
10 in which he or she resides.
- 11 (b) 1. If the registrant changes his or her residence to a new county, the person
12 shall notify his or her current local probation and parole office of the
13 new residence address on or before the date of the change of address.
- 14 2. The registrant shall also register with the appropriate local probation and
15 parole office in the county of his or her new residence no later than five
16 (5) working days after the date of the change of address.
- 17 (c) If the electronic mail address or any instant messaging, chat, or other Internet
18 communication name identities of any registrant changes, or if the registrant
19 creates or uses any new Internet communication name identities, the registrant
20 shall register the change or new identity, on or before the date of the change or
21 use or creation of the new identity, with the appropriate local probation and
22 parole office in the county in which he or she resides.
- 23 (d) 1. As soon as a probation and parole office learns of the person's new
24 address under paragraph (b)1. of this subsection, that probation and
25 parole office shall notify the appropriate local probation and parole
26 office in the county of the new address of the effective date of the new
27 address.

1 2. As soon as a probation and parole office learns of the person's new
2 address under paragraph (b)2. of this subsection or learns of the
3 registrant's new or changed electronic mail address or instant messaging,
4 chat, or other Internet communication name identities under paragraph
5 (c) of this subsection, that office shall forward this information as set
6 forth under subsection (5) of this section.

7 (11) Any person required to register under this section who knowingly violates any of
8 the provisions of this section or prior law is guilty of a Class D felony for the first
9 offense and a Class C felony for each subsequent offense.

10 (12) Any person required to register under this section or prior law who knowingly
11 provides false, misleading, or incomplete information is guilty of a Class D felony
12 for the first offense and a Class C felony for each subsequent offense.

13 (13) (a) The cabinet shall verify the addresses and the electronic mail address and any
14 instant messaging, chat, or other Internet communication name identities of
15 individuals required to register under this section. Verification shall occur at
16 least once every ninety (90) days for a person required to register under KRS
17 17.520(2) and at least once every calendar year for a person required to
18 register under KRS 17.520(3). If the cabinet determines that a person has
19 moved or has created or changed any electronic mail address or any instant
20 messaging, chat, or other Internet communication name identities used by the
21 person without providing his or her new address, electronic mail address, or
22 instant messaging, chat, or other Internet communication name identity to the

18 **(3) "Drug supervision session" means a meeting between the reentry team and the**
19 **participant to discuss the participant's progress through the reentry drug**
20 **supervision pilot program;**

21 **(4) "Participant" means an inmate or parolee selected to participate in the reentry**
22 **drug supervision pilot program;**

23 **(5) "Reentry drug supervision pilot program" or "pilot program" means the**

26 **administer and oversee the reentry drug supervision pilot program; and**

27 **(7) "Substance use disorder" has the same meaning as in the current edition of the**

3 ➔SECTION 18. A NEW SECTION OF KRS CHAPTER 439 IS CREATED TO
4 READ AS FOLLOWS:

5 (1) By March 2018, the department shall implement a reentry drug supervision pilot
6 program with the goal of restoring lives and reducing recidivism through
7 oversight and behavior modification.

8 (2) The reentry drug supervision pilot program shall last four (4) years and shall:

9 (a) Be administered and overseen by a reentry team organized under Section 19
10 of this Act;

11 (b) Be composed of inmates or parolees placed in the pilot program pursuant to
12 Section 20 of this Act;

13 (c) Consist of two (2) phases as outlined in Section 21 of this Act;

14 (d) Provide a continuum of substance use disorder treatments and
15 rehabilitative services;

16 (e) Monitor participants with frequent drug testing;

17 (f) Implement a coordinated strategy to govern the pilot program's responses to
18 participants' compliance;

19 (g) Require ongoing reentry team interaction with each participant; and

20 (h) Forge partnerships among public agencies and community-based
21 organizations.

22 (3) The department shall monitor and evaluate the reentry drug supervision pilot
23 program to determine:

24 (a) The number of participants who complete the pilot program;

25 (b) Of the participants who complete the pilot program, the number who later
26 have their parole revoked and for what offense or, if no longer on parole,
27 the number who commit new offenses and a description of those new

1 offenses;

2 (c) The number of participants terminated from the pilot program, the reason
3 for their termination, and how long they participated in the pilot program
4 before termination; and

5 (d) Any savings associated from placing participants in the pilot program
6 versus keeping those participants incarcerated.

7 (4) For a total of seven (7) years, the department shall provide an annual report to
8 the Legislative Research Commission and to the Interim Joint Committee on
9 Judiciary by January 1 of each year the reentry drug supervision pilot program is
10 in operation as well as the following three (3) years. The report shall include the
11 data detailed in subsection (3) of this section.

12 (5) The department may promulgate administrative regulations to implement
13 Sections 17 to 24 of this Act.

14 ➔SECTION 19. A NEW SECTION OF KRS CHAPTER 439 IS CREATED TO
15 READ AS FOLLOWS:

16 (1) The reentry team shall administer and oversee the reentry drug supervision pilot
17 program. The team shall consist of the following members:

18 (a) A department hearing officer shall lead the reentry team and ensure that
19 due process is followed. If reentry team members disagree on incentives or
20 sanctions, the hearing officer shall be the final decision maker;

21 (b) A parole officer who shall have regular parole officer duties, including drug
22 testing and maintaining records;

23 (c) A reentry liaison or facilitator from the Division of Probation and Parole;

24 (d) A social service clinician;

25 (e) A public defender or his or her designated representative who may or may
26 not be an attorney; and

27 (f) A designated representative from a community mental health center who

- 1 shall provide substance use disorder treatment to participants.
- 2 (2) The Administrative Office of the Courts shall train reentry team members on the
3 philosophy behind drug courts as well as their roles within the team.
- 4 (3) The reentry team may provide incentives, including but not limited to the
5 following:
- 6 (a) Promotion to the next phase as outlined in Section 21 of this Act;
7 (b) Certificates and tokens;
8 (c) Compliance credit or any other parole credit approved by the reentry team;
9 (d) Decreased supervision;
10 (e) Increased privileges and responsibilities;
11 (f) Praise from the hearing officer and reentry team;
12 (g) Extended curfews; and
13 (h) Other individual incentives approved by the reentry team.
- 14 (4) (a) Notwithstanding KRS 439.3108 or 439.340(3)(b) or any other statute to the
15 contrary, only the reentry team may impose sanctions on participants who
16 do not comply with the requirements and conditions established by the
17 reentry team. Notwithstanding KRS 439.3107 or 439.3108 or any other
18 statute to the contrary, sanctions include but are not limited to the
19 following:
- 20 1. Admonishments by the hearing officer;
21 2. Graduated sanctions similar to those adopted by the department
22 pursuant to KRS 439.3107;
23 3. Community service;
24 4. Phase demotion;
25 5. Increased pilot program requirements;
26 6. Electronic monitoring;
27 7. Home incarceration;

1 8. Imprisonment in a state or local correctional or detention facility or
2 residential center for no more than sixty (60) days in any one (1)
3 calendar year; and

4 9. Termination from the pilot program.

5 (b) When considering appropriate sanctions, the reentry team shall consider
6 alternatives to incarceration.

7 (c) Notwithstanding paragraph (a) of this subsection, a parole officer may
8 arrest a participant without first consulting the reentry team if the parole
9 officer believes the participant poses an imminent threat to himself or
10 herself or to others. The parole officer shall immediately notify the reentry
11 team of the arrest. Upon receiving notification of the arrest, the reentry
12 team shall then determine whether to impose additional sanctions.

13 (5) Reentry team proceedings shall be confidential and shall be closed unless
14 otherwise authorized by the hearing officer. Each reentry team member shall sign
15 a confidentiality agreement and shall comply with state and federal
16 confidentiality laws regarding treatment information. Documents contained in a
17 participant's pilot program case file shall be confidential and only those
18 documents that do not violate these state and federal confidentiality laws shall be
19 released.

20 ➔SECTION 20. A NEW SECTION OF KRS CHAPTER 439 IS CREATED TO
21 READ AS FOLLOWS:

22 (1) The department shall implement the reentry drug supervision pilot program
23 created under Section 18 of this Act for inmates or parolees placed in the pilot
24 program pursuant to this section.

25 (2) Inmates or parolees may be referred to the Parole Board as candidates for the
26 pilot program by either the department's Division of Substance Abuse
27 Programming as outlined in subsection (3) of this section or the department's

1 hearing officers as outlined in subsection (4) of this section.

2 (3) (a) After sentencing, the department's Division of Substance Abuse
3 Programming shall conduct a substance abuse assessment of the following
4 inmates:

5 1. Inmates whose offense for which he or she was sentenced:

6 a. Does not qualify him or her as a violent offender as defined in
7 KRS 439.3401 or a sexual offender as defined in KRS 17.550;
8 and

9 b. Did not result in death or serious physical injury of a victim;

10 2. Inmates:

11 a. Who have been convicted of, or entered an Alford plea or plea of
12 nolo contendere to, a Class C or D felony that is:

13 i. A drug offense; or

14 ii. An offense arising from a substance use disorder; or

15 b. Whose probation or parole was revoked due to a substance use
16 disorder or those with a history of substance use disorder; and

17 3. Inmates who have not previously participated in the reentry drug
18 supervision pilot program.

19 (b) After reviewing the substance abuse assessments required under paragraph
20 (a) of this subsection, the department's Division of Substance Abuse
21 Programming shall refer to the Parole Board those inmates determined by
22 the division to be candidates for the reentry drug supervision pilot program.

23 (4) During a preliminary parole revocation hearing, if a department hearing officer
24 suspects a parolee is suffering from a substance use disorder, the hearing officer
25 may order a one (1) month deferment to allow the department's Division of
26 Substance Abuse Programming to conduct a substance abuse assessment of the
27 parolee. After evaluating the assessment, the hearing officer may recommend to

1 the Parole Board that the parolee be placed into the pilot program instead of
2 being revoked.

3 (5) (a) Upon receiving a referral from the department's Division of Substance
4 Abuse Programming pursuant to subsection (3) of this section or from the
5 department's hearing officers pursuant to subsection (4) of this section, the
6 Parole Board shall notify the inmate's or parolee's victims, if any, and
7 provide them an opportunity to submit a written victim impact statement
8 and to testify. The Parole Board shall then evaluate the referred inmate or
9 parolee to determine whether to place him or her in the reentry drug
10 supervision pilot program.

11 (b) When evaluating whether to place a referred inmate or parolee in the
12 reentry drug supervision pilot program, the Parole Board shall consider the
13 following:

14 1. Current criminal charges, if any;

15 2. Criminal convictions;

16 3. Results of the substance abuse assessment conducted pursuant to
17 subsection (3) or (4) of this section;

18 4. Plan of recovery created by the department;

19 5. Information regarding the victims, if any;

20 6. Trial court's recommendation to participate in the pilot program, if
21 any;

22 7. An inmate's or parolee's willingness to participate; and

23 8. Other relevant information as identified by the department.

24 (6) After evaluating the referred inmate or parolee pursuant to subsection (5) of this
25 section, the Parole Board shall determine whether to place an inmate or parolee
26 into the reentry drug supervision pilot program.

27 (7) (a) 1. Notwithstanding KRS 218A.1412 or 439.340 or any other statute to

1 the contrary, if the Parole Board decides to place an inmate in the
 2 reentry drug supervision pilot program, the inmate shall immediately
 3 be paroled into the pilot program. The only conditions of parole shall
 4 be to:

5 a. Have no contact with victims, if applicable;

6 b. Pay restitution, if applicable; and

7 c. Adhere to Sections 17 to 24 of this Act and to the reentry team's
 8 requirements and conditions.

9 2. Notwithstanding any statute to the contrary, if the Parole Board
 10 decides to place a parolee in the reentry drug supervision pilot
 11 program, the parolee shall immediately be entered into the pilot
 12 program. The only conditions of parole shall be to:

13 a. Adhere to any special conditions established by the Parole
 14 Board; and

15 b. Adhere to Sections 17 to 24 of this Act and to the reentry team's
 16 requirements and conditions.

17 (b) Participants shall remain on parole until sentence completion unless the
 18 reentry team determines to terminate or administratively discharge the
 19 participant from the pilot program. If terminated from the pilot program,
 20 the reentry team shall refer the participant to the Parole Board for
 21 revocation.

22 ➔SECTION 21. A NEW SECTION OF KRS CHAPTER 439 IS CREATED TO
 23 READ AS FOLLOWS:

24 (1) The reentry drug supervision pilot program shall consist of two (2) phases lasting
 25 a minimum of twelve (12) months or until sentence completion, whichever occurs
 26 first. Both phases shall occur after the participant is paroled.

27 (2) The first phase is an education phase. For the first phase, the participant shall at

1 *a minimum:*

2 *(a) Provide at least three (3) random drug screens per week;*

3 *(b) Attend as many group therapy sessions per week as determined necessary by*
4 *a community mental health center. The community mental health center*

7 *(d) Obtain and maintain full-time employment, training, or education approved*

9 *(e) Obtain and maintain housing approved by the reentry team;*

10 *(f) Make arrangements for payment of court obligations and any probation*
11 *and parole fees required by the department;*

12 *(g) Indicate an appropriate understanding of recovery principles;*

13 *(h) Attend self-help programs, such as a twelve (12) step program; and*

14 *(i) Remain drug-free for ninety (90) consecutive days in this phase before*
15 *consideration for promotion to the second phase.*

16 *(3) The second phase is the self-motivation phase. For the second phase, the*

21 *shall conduct the group therapy sessions;*

14 completed his or her sentence, the participant shall move from the reentry drug
15 supervision pilot program to regular parole.

18 reentry team shall determine whether the participant may receive credit toward
19 the remainder of his or her sentence for the time spent in the pilot program.

22 If reentry drug supervision pilot program participation as outlined in Section 21 of this
23 Act is impracticable due to inpatient treatment or similar circumstances in which the

19 a displaced employed worker is:

22 the prisoner labor were leased; or

17 lease prisoner labor agreeing to not displace any of its non-prisoner
18 employees with leased prisoner labor;

21 craft, or trade in which a prisoner may labor at that facility. If a local union
22 is not available, the department shall consult with a similar statewide union.

26 that may be economically impacted by the leased labor project. The
27 department shall present this information to the Kentucky State Corrections

4 (7) The leasing of prisoner labor shall not be deemed to create an employer-employee
5 relationship between the person leasing the labor of the prisoner and the

7 workers' compensation coverage for the prisoner and, if applicable, Social
8 Security coverage for the prisoner.

9 (8) A prisoner, as a condition of participation in a program operating under the

6 labor leased to the highest responsible bidder.

7 (11) The department shall provide for reasonable access to the grounds of the
8 Department of Corrections facilities for the person leasing the inmate labor and
9 for the location of the work and the transporting and siting of equipment and
10 supplies, with the security of the public being paramount.

11 (12) The department may promulgate administrative regulations to implement the
12 provisions of this section.

25 probationary conditions upon, a license as ordered by the board in any decision
26 made after hearing as provided in this chapter. One (1) year from the date of
27 revocation of a license under this chapter, application may be made to the board for

1 reinstatement. The board shall have discretion to accept or reject an application for
2 reinstatement.

3 (3) A person applying for reinstatement of licensure shall provide evidence of
4 completion of continuing professional education in speech-language pathology or
5 audiology as prescribed by the board.

6 (4) A plea or verdict of guilty or a conviction following a plea of nolo contendere made
7 to a charge of a felony is deemed to be a conviction within the meaning of this
8 chapter. At the direction of the board, ***if in accordance with KRS Chapter 335B,***
9 the license shall be suspended or revoked, or shall decline to issue a license when
10 the time for appeal has elapsed, or the judgment of conviction has been affirmed on
11 appeal, or when an order granting probation is made suspending the imposition of
12 sentence irrespective of a subsequent order under the provisions of the penal code
13 allowing such person to withdraw his plea of guilty and to enter a plea of not guilty,
14 or setting aside the verdict of guilty, or dismissing the acquisition, information or
15 indictment.

17 (1) The board may revoke, suspend, or refuse to issue or renew; impose probationary or

13 mental health services for the client which are needed as a result of the sexual
14 contact.

16 convicted of a misdemeanor offense under KRS Chapter 510 involving a client or a
17 felony offense under KRS Chapter 510, 530.064(1)(a), or 531.310, or has been
18 found to have had sexual contact as defined in KRS 510.010(7) with a client while
19 the client was under the care of the social worker.

13 (1) The board may refuse to issue a credential, or may suspend, revoke, impose
14 probationary conditions upon, impose an administrative fine, or issue a written
15 reprimand or admonishment if the credential holder has:

16 (a) Committed a dishonest or corrupt act, **if in accordance with KRS Chapter**
17 **335B**. If the act is a crime, conviction in a criminal proceeding shall not be a
18 condition precedent to disciplinary action. Upon conviction of the crime, the
19 judgment and sentence are presumptive evidence at the ensuing disciplinary
20 hearing of the guilt of the credential holder or applicant. Conviction includes
21 all instances in which a plea of no contest is the basis of the conviction;

22 (b) Misrepresented or concealed a material fact in obtaining or reinstating a

23 **program or work release participation. In addition, the inmate may be**
24 **required to pay for any drug testing performed on the inmate as a**

27 **1. Is not eligible for work release pursuant to KRS 197.140;**

1 2. Has a maximum or close security classification as defined by
2 administrative regulations promulgated by the Department of

5 4. Is in a reentry center as defined in Section 87 of this Act.

6 ➔SECTION 86. A NEW SECTION OF KRS CHAPTER 533 IS CREATED TO
7 READ AS FOLLOWS:

8 (1) As used in this section:

9 (a) "County jail" means all detention and penal facilities of a county, charter
10 county, urban-county government, unified local government, or
11 consolidated local government for adult offenders, together with all its
12 rehabilitative facilities for adult offenders, including facilities operated by
13 private agencies under contract with the county, charter county, urban-
14 county government, unified local government, or consolidated local
15 government;

16 (b) "Day reporting program" or "program" means a community-based,
17 structured sentencing program operated by a county jail that combines
18 enhanced community supervision with resources and services tailored to
19 meet identified offender needs; and

20 (c) "Eligible defendant" means an individual convicted of a misdemeanor or a
21 felony who is eligible to serve all or part of his or her sentence in a county
22 jail or who is found in contempt of court and who meets the intake criteria
23 established by the day reporting program to which the person would be
24 sentenced.

25 (2) A court may sentence an eligible defendant as part of an alternative sentencing
26 plan or as a sentence for contempt to a local day reporting program for a period
27 of time not longer than the defendant's maximum potential period of

1 incarceration if:

2 (a) The program utilizes whenever practicable a validated screening tool based
3 on criminogenic risk factors to identify an individual's likelihood of
4 reoffending and his or her treatment needs in determining program
5 eligibility;

6 (b) The program has agreed to accept the defendant;

7 (c) The defendant agrees in writing to comply with the program's written terms
8 and conditions; and

9 (d) The defendant, if additionally required by the court or the program to do so,
10 agrees to be subject to the conditions of electronic monitoring pursuant to
11 KRS 532.210 to 532.250.

12 (3) In sentencing a defendant to a day reporting program under this section, a court
13 may authorize a temporary release from the program for any of the purposes
14 allowed for the release of a jail prisoner under KRS 439.179.

15 (4) The day reporting program shall provide a weekly report of all violations of the
16 program's terms and conditions for each program participant to the sentencing
17 court, to the prosecutor, and to the defendant in the case. If specified in the
18 program's written terms and conditions, the program may alter the terms and
19 conditions of a person's participation in the program in response to that person's
20 minor breach of the program's terms and conditions.

21 (5) A court may alter or revoke a defendant's participation in a day reporting
22 program if written notice of the grounds for alteration or revocation is given to
23 the defendant and a hearing is conducted at which the defendant is represented
24 by counsel. Following the hearing, if the court finds that the defendant has
25 without good cause failed to participate in the program or to comply with its
26 terms and conditions, the court may impose any additional sentence or other
27 sanction specified in the original sentencing order.

1 **(6) The Administrative Office of the Courts shall prescribe forms to be utilized in the**
2 **implementation of this section.**

3 **(7) A day reporting program may be referred to as a day reporting center or other**
4 **appropriate nomenclature in its day-to-day operations.**

5 ➔Section 87. KRS 441.005 is amended to read as follows:

6 As used in this chapter, unless the context otherwise requires:

7 (1) "Jail" means county jails and correctional or detention facilities, including
8 correctional facilities defined in KRS 67B.020 and juvenile detention facilities,
9 operated by and under the supervision of any political subdivision.

10 (2) "Holdover" means any jail housing prisoners for a maximum period of ninety-six
11 (96) continuous hours and excluding times when a prisoner is released for a
12 minimum of seven (7) hours for the purpose of working at his employment,
13 attending an educational institution, or conducting other business pursuant to a
14 court order, or when a prisoner is released for in court proceedings.

15 (3) "Prisoner" means any person confined in jail pursuant to any code, ordinance, law,
16 or statute of any unit of government and who is:

17 (a) Charged with or convicted of an offense; or

18 (b) Held for extradition or as a material witness; or

19 (c) Confined for any other reason.

20 (4) "Unit of government" means that unit of government including the United States
21 government whose law, statute, ordinance, or code a prisoner is charged with
22 violating. If a person is imprisoned for contempt of court, the state shall be deemed
23 the responsible unit of government.

24 (5) "Department" means the Department of Corrections.

25 (6) "Jail personnel" means deputy jailers, matrons, cooks, and other food service
26 personnel, and other jail employees involved in the supervision, custody, care, or
27 treatment of prisoners in jails but does not include maintenance or clerical

1 personnel.

2 (7) "Regional jail" means a jail that may house prisoners for up to one (1) year and
3 which is:

4 (a) Owned and operated by one (1) county and, on a regular basis, holds prisoners
5 for another county or for the state; or

6 (b) Owned and operated by two (2) or more counties through a regional jail
7 authority as provided in KRS 441.800.

8 (8) "Commissioner" means the Commissioner of the Department of Corrections.

9 **(9) "Reentry center" means a supervised community residential facility operated by a**
10 **local correctional facility, county jail, or regional jail as detailed in Section 88 of**
11 **this Act.**

12 ➔SECTION 88. A NEW SECTION OF KRS CHAPTER 441 IS CREATED TO
13 READ AS FOLLOWS:

14 **(1) A local correctional facility, county jail, or regional jail may, with the approval of**
15 **the Department of Corrections, operate a reentry center. Reentry centers**
16 **established pursuant to this section shall:**

17 **(a) Employ a program coordinator responsible for oversight of the reentry**
18 **center;**

19 **(b) Offer residents at least one (1) vocational training program approved by the**
20 **Department of Corrections;**

21 **(c) Offer residents at least two (2) other evidence-based programs approved by**
22 **the Department of Corrections;**

23 **(d) Review each participant's case with a certified alcohol and drug counselor**
24 **as defined in KRS 309.080;**

25 **(e) Require residents to participate in family outreach and community**
26 **involvement programs;**

27 **(f) Require residents to seek or maintain employment in the community. The**

1 reentry center shall require ten percent (10%) of the resident's income to be
 2 deposited into a savings account, shall require fifteen percent (15%) of the
 3 resident's income to be directed to payment of restitution if applicable, and
 4 may charge each resident a fee of not more than twenty percent (20%) of
 5 the resident's income; and

6 (g) Report data as required by the Department of Corrections in order to allow
 7 evaluation of the effectiveness of the reentry center.

8 (2) A person is eligible for placement in a reentry center if he or she has less than
 9 twelve (12) months until the expected expiration of his or her sentence and is:

10 (a) A state inmate eligible for placement in a local jail pursuant to Section 85
 11 of this Act;

12 (b) A Class B felon who is classified as low risk by the Department of
 13 Corrections; or

14 (c) A county inmate in the jail operated by the political subdivision which
 15 operates the reentry center.

16 (3) Residents may be assigned to a reentry center by:

17 (a) Administrative classification by the Department of Corrections;

18 (b) Administrative decision of the jailer for inmates of the jail;

19 (c) The court, as an alternative sentence; or

20 (d) The Parole Board, as a condition of parole or as a sanction for violation of
 21 conditions of parole.

22 ➔SECTION 89. A NEW SECTION OF KRS CHAPTER 441 IS CREATED TO
 23 READ AS FOLLOWS:

24 (1) The Department of Corrections shall, by administrative regulation, establish
 25 standards for the operation of reentry centers established pursuant to Section 88
 26 of this Act.

27 (2) The Department of Corrections shall utilize data reported by the reentry centers

1 pursuant to Section 88 of this Act to analyze the effectiveness of the reentry
2 centers in reducing recidivism and the engagement of residents in employment
3 and in the community.

4 (3) Placement of inmates in reentry centers by the Department of Corrections or the
5 Parole Board shall prioritize placement in higher-performing centers, as
6 determined by the Department of Corrections.

7 ➔Section 90. KRS 196.031 is amended to read as follows:

8 (1) The cabinet shall employ the personnel and operate and maintain data collection
9 and processing systems necessary to comply with the provisions of this section.

10 (2) The cabinet shall annually on July 1 of each year report to the Governor, the
11 Legislative Research Commission, and the Kentucky State Corrections Commission
12 on:

13 (a) The placement of prisoners within the Commonwealth's correctional system
14 by institution, whether imprisoned in a state prison or other institution,
15 including county jails, on probation, paroled, housed in halfway houses,
16 housed in reentry centers, sentenced to community service or otherwise;

17 (b) Numbers of prisoners by type of offense;

18 (c) Numbers of prisoners by number and type of prior convictions;

19 (d) Numbers of prisoners paroled by type of offense and by length of time served;

20 (e) Numbers of prisoners released through shock probation by type of offense and
21 by length of time served;

22 (f) Numbers of prisoners serving their full sentence by type of offense;

23 (g) The percentage of felony offenders on parole or some form of post-release
24 supervision who are participating or completing treatment consistent with
25 assessment results, in prison and in the community;

26 (h) The percentage of felony offenders whose reassessment results demonstrate
27 reductions in criminal risk factors;

- 1 (i) The percentage of programs that demonstrate their effectiveness in reducing
2 recidivism;
- 3 (j) The percentage of felony offenders on parole or some form of post-release
4 supervision, by supervision type, who:
- 5 1. Are employed or in school within thirty (30) days, six (6) months, and
6 one (1) year of the start of supervision;
- 7 2. Have had part-time employment for a minimum of six (6) months, and
8 the percentage of offenders who have had full-time employment for a
9 minimum of six (6) months;
- 10 3. Have housing upon release from incarceration;
- 11 4. Had stable housing for at least six (6) months; and
- 12 5. Are arrested, convicted, or incarcerated within six (6) months, one (1)
13 year, and three (3) years;
- 14 (k) The percentage of admissions to prison by offenders under supervision at the
15 time of admission, including information regarding whether the violations
16 were criminal or technical; and
- 17 (l) Any other data that provides information on state-funded crime reduction and
18 recidivism reduction efforts, including caseload sizes by risk level,
19 participation in treatment and intervention programming, public safety
20 outcomes, and cost effectiveness.
- 21 (3) The cabinet shall annually report to the Governor and to the Legislative Research
22 Commission on:
- 23 (a) Numbers and types of prison beds necessary to meet current population needs
24 and six (6) year projections of those needs;
- 25 (b) Current personnel needs of the cabinet and five (5) year projections of the
26 needs; and
- 27 (c) A six (6) year projection of needed capital construction, program

1 development, and anticipated requests for appropriations.

2 ➔Section 91. KRS 439.340 is amended to read as follows:

- 3 (1) The board may release on parole persons confined in any adult state penal or
4 correctional institution of Kentucky or sentenced felons incarcerated in county jails
5 eligible for parole. All paroles shall issue upon order of the board duly adopted. As
6 soon as practicable after his or her admission to an adult state penal or correctional
7 institution or county jail if he or she is a sentenced felon, and at such intervals
8 thereafter as it may determine, the Department of Corrections shall obtain all
9 pertinent information regarding each prisoner, except those not eligible for parole.
10 The information shall include the results of his or her most recent risk and needs
11 assessment, his or her criminal record, his or her conduct, employment, and the
12 reports of physical and mental examinations that have been made. The Department
13 of Corrections shall furnish the circumstances of his or her offense, the results of his
14 or her most recent risk and needs assessment, and his or her previous social history
15 to the board. The Department of Corrections shall prepare a report on any
16 information it obtains. It shall be the duty of the Department of Corrections to
17 supplement this report with any material the board may request and submit the
18 report to the board.
- 19 (2) Before granting the parole of any prisoner, the board shall consider the pertinent
20 information regarding the prisoner, including the results of his or her most recent
21 risk and needs assessment, and shall have him or her appear before it for interview
22 and hearing. The board in its discretion may hold interviews and hearings for
23 prisoners convicted of Class C felonies not included within the definition of
24 "violent offender" in KRS 439.3401 and Class D felonies. The board in its
25 discretion may request the parole board of another state confining prisoners
26 pursuant to KRS 196.610 to interview eligible prisoners and make a parole
27 recommendation to the board. A parole shall be ordered only for the best interest of

1 society and not as an award of clemency, and it shall not be considered a reduction
2 of sentence or pardon. A prisoner shall be placed on parole only when arrangements
3 have been made for his or her proper employment or for his or her maintenance and
4 care, and when the board believes he or she is able and willing to fulfill the
5 obligations of a law abiding citizen. Notwithstanding any statute to the contrary,
6 including KRS 440.330, when a prisoner is otherwise eligible for parole and the
7 board has recommended parole for that prisoner for the reasons set forth in this
8 subsection, the board may grant parole to any prisoner wanted as a fugitive by any
9 other jurisdiction, and the prisoner shall be released to the detainer from that
10 jurisdiction. Such parole shall not constitute a relinquishment of jurisdiction over
11 the prisoner, and the board in all cases expressly reserves the right to return the
12 prisoner to confinement in a correctional institution of the Commonwealth if the
13 prisoner violates the terms of his or her parole.

14 (3) (a) A nonviolent offender convicted of a Class D felony with an aggregate
15 sentence of one (1) to five (5) years who is confined to a state penal institution
16 or county jail shall have his or her case reviewed by the Parole Board after
17 serving fifteen percent (15%) or two (2) months of the original sentence,
18 whichever is longer.

19 (b) Except as provided in this section, the board shall adopt administrative
20 regulations with respect to the eligibility of prisoners for parole, the conduct
21 of parole and parole revocation hearings and all other matters that come
22 before it, or conditions to be imposed upon parolees. Regulations governing
23 the eligibility of prisoners for parole shall be in accordance with
24 professionally accepted ideas of correction and reform and may utilize in part
25 objective, performance-based criteria and risk and needs assessment
26 information; however, nothing herein contained shall preclude the board from
27 utilizing its present regulations in conjunction with other factors involved that

1 would relate to the inmate's needs and the safety of the public.

2 (4) The board shall insure that all sentenced felons who have longer than ninety (90)
3 days to serve in state penal institutions, halfway houses, reentry centers, and county
4 jails are considered for parole not less than sixty (60) days prior to their parole
5 eligibility date, and the Department of Corrections shall provide the necessary
6 assistance and information to the board in order for it to conduct timely parole
7 reviews.

8 (5) In addition to or in conjunction with each hearing conducted under subsection (2) of
9 this section for any prisoner convicted of a Class A, B, or C felony and prior to the
10 granting of a parole to any such prisoner, the parole board shall conduct a hearing of
11 which the following persons shall receive not less than forty-five (45) nor more than
12 ninety (90) days' notice: the Commonwealth's attorney who shall notify the sheriff
13 of every county and the chief of police of every city and county in which the
14 prisoner committed any Class A, B, or C felony for which he or she is imprisoned,
15 and all identified victims of the crimes or the next of kin of any victim who is
16 deceased. Notice to the Commonwealth's attorney shall be by mail, fax, or
17 electronic means at the discretion of the board, and shall be in a manner that ensures
18 receipt at the Commonwealth attorney's business office. Notices received by chiefs
19 of police and sheriffs shall be posted in a conspicuous location where police
20 employed by the department may see it. Notices shall be posted in a manner and at a
21 time that will allow officers to make comment thereon to the Parole Board. Notice
22 to victims or their next of kin shall be made, for prisoners incarcerated prior to July
23 15, 1986, by mail, fax, or electronic means at the discretion of the board, and shall
24 be in a manner that ensures receipt by the Commonwealth's attorney, who shall
25 forward the notice promptly to the victims or their next of kin at their last known
26 address. For prisoners incarcerated on or after July 15, 1986, notice to the victims or
27 their next of kin shall be by mail from the Parole Board to their last known address

1 as provided by the Commonwealth's attorney to the Parole Board at the time of
2 incarceration of the prisoner. Notice to the victim or the next of kin of subsequent
3 considerations for parole after the initial consideration shall not be sent if the victim
4 or the next of kin gives notice to the board that he or she no longer wants to receive
5 such notices. The notice shall include the time, date, and place of the hearing
6 provided for in this subsection, and the name and address of a person to write if the
7 recipient of the notice desires to attend the hearing or to submit written comments.

8 (6) Persons receiving notice as provided for in subsection (5) of this section may
9 submit comments, in person or in writing, to the board upon all issues relating to the
10 parole of the prisoner. The board shall read and consider all comments prior to
11 making its parole decision, if they are received by the board not less than seven (7)
12 days before the date for the hearing. The board shall retain all comments in the
13 prisoner's permanent Parole Board file, and shall consider them in conjunction with
14 any subsequent parole decisions affecting the prisoner. In addition to officers listed
15 in subsection (5) of this section, the crime victims or the next of kin of any victim
16 who is deceased or who is disabled and cannot attend the hearing or the parent or
17 legal guardian of any victim who is a minor may attend the hearing provided for in
18 subsection (5) of this section and present oral and written comments upon all issues
19 relating to the parole of the prisoner, if they have advised the board, in writing
20 received by the board not less than seven (7) days prior to the date set for the
21 hearing, of their intention to attend the hearing. The board shall receive and
22 consider all comments, shall make a record of them which it shall retain in the
23 prisoner's permanent Parole Board file, and shall consider them in conjunction with
24 any subsequent parole decision affecting the prisoner. Persons appearing before the
25 Parole Board pursuant to this subsection may elect to make their presentations
26 outside of the presence of the prisoner.

27 (7) Victims of Class D felonies may submit comments in person or in writing to the

- 1 board upon all issues relating to the parole of a prisoner.
- 2 (8) Any hearing provided for in subsections (5), (6), and (7) of this section shall be
3 open to the public unless the persons having a right to appear before the board as
4 specified in those subsections request closure of hearing for reasons of personal
5 safety, in which event the hearing shall be closed. The time, date, and location of
6 closed hearings shall not be disclosed to the public.
- 7 (9) Except as specifically set forth in this section, nothing in this section shall be
8 deemed to expand or abridge any existing rights of persons to contact and
9 communicate with the Parole Board or any of its members, agents, or employees.
- 10 (10) The unintentional failure by the Parole Board, sheriff, chief of police, or any of its
11 members, agents, or employees or by a Commonwealth's attorney or any of his or
12 her agents or employees to comply with any of the provisions of subsections (5),
13 (6), and (8) of this section shall not affect the validity of any parole decision or give
14 rise to any right or cause of action by the crime victim, the prisoner, or any other
15 person.
- 16 (11) No eligible sexual offender within the meaning of KRS 197.400 to 197.440 shall be
17 granted parole unless he or she has successfully completed the Sexual Offender
18 Treatment Program.
- 19 (12) Any prisoner who is granted parole after completion of the Sexual Offender
20 Treatment Program shall be required, as a condition of his or her parole, to
21 participate in regular treatment in a mental health program approved or operated by
22 the Department of Corrections.
- 23 (13) When the board grants parole contingent upon completion of a program, the
24 commissioner, or his or her designee, shall determine the most appropriate
25 placement in a program operated by the department or a residential or nonresidential
26 program within the community approved by the department. If the department
27 releases a parolee to a nonresidential program, the department shall release the

1 parolee only if he or she will have appropriate community housing pursuant to KRS
2 439.3408.

3 (14) If the parole board does not grant parole to a prisoner, the maximum deferment for a
4 prisoner convicted of a non-violent, non-sexual Class C or Class D felony shall be
5 twenty-four (24) months. For all other prisoners who are eligible for parole:

6 (a) No parole deferment greater than five (5) years shall be ordered unless
7 approved by a majority vote of the full board; and

8 (b) No deferment shall exceed ten (10) years, except for life sentences.

9 (15) When an order for parole is issued, it shall recite the conditions thereof.

10 ➔Section 92. KRS 439.3407 is amended to read as follows:

11 (1) The department may promulgate administrative regulations to implement
12 conditional parole of state inmates incarcerated in state corrections institutions or
13 local correctional facilities or county jails to place those individuals closer to their
14 communities prior to release. A parolee placed on conditional parole shall serve that
15 term in a local correctional facility or county jail or reentry center in a county in
16 which the fiscal court has agreed to house parolees if beds are available in the local
17 correctional facility or county jail or reentry center.

18 (2) The department may authorize parolees on conditional parole to be placed on work
19 release. If a person placed in a county jail on conditional parole under subsection (1)
20 of this section is granted work release, he or she shall pay the work release fees
21 required by law to the jailer. The amount of work release fees paid by a parolee

24 (3) Local correctional facilities or county jails housing parolees under subsection (1) of
25 this section shall have the same rights and obligations as county jails housing felons

27 (4) Administrative regulations promulgated pursuant to subsection (1) of this section

1 relating to eligibility of an individual for conditional parole shall take into
2 consideration, at a minimum, the following information about the individual:

- 3 (a) The offense for which the individual was convicted and his or her
4 rehabilitation efforts while incarcerated;
- 5 (b) The security classification while incarcerated in the state correctional
6 institution;
- 7 (c) Conduct while incarcerated in the state correctional institution;
- 8 (d) Ability to find employment in the community; and
- 9 (e) The availability of additional applicable education, treatment or intervention,
10 and training for employment in the local correctional facility or county jail, if
11 needed by the individual.

12 ➔Section 93. KRS 439.3408 is amended to read as follows:

13 When considering appropriate housing options for a person considered for parole or a
14 person who is being paroled, the department shall approve any form of acceptable
15 housing, including but not limited to apartments, shelters for homeless or other persons,
16 county jails or restricted custody facilities that a county approves for parolees, educational
17 institutions with dormitories if the parolee is enrolled or accepted for enrollment at an
18 educational institution, halfway houses, reentry centers, residential treatment or other
19 programs in which the parolee is enrolled or accepted for enrollment, and other forms of
20 transitional housing meeting the requirements of applicable statutes.

21 ➔Section 94. KRS 446.010 is amended to read as follows:

22 As used in the statute laws of this state, unless the context requires otherwise:

- 23 (1) "Action" includes all proceedings in any court of this state;
- 24 (2) "Animal" includes every warm-blooded living creature except a human being;
- 25 (3) "Attorney" means attorney-at-law;
- 26 (4) "Bequeath" and "devise" mean the same thing;

21 of and guidelines to financial accounting and reporting as adopted by the National
22 Council on Governmental Accounting, under the auspices of the Municipal Finance
23 Officers Association and by the Financial Accounting Standards Board, under the
24 auspices of the American Institute of Certified Public Accountants;
- 25 (21) "Graduated sanction" means any of a wide range of accountability measures and
26 programs for supervised individuals, including but not limited to electronic
27 monitoring; drug and alcohol testing or monitoring; day or evening reporting

11 approves for persons granted conditional release, educational institutions with dormitories

10 defendant, probation with an alternative sentencing plan shall be granted unless the
11 court is of the opinion that imprisonment is necessary for the protection of the
12 public because:
- 13 (a) There is a likelihood that during a period of probation with an alternative
14 sentencing plan or conditional discharge the defendant will commit a Class D
15 or Class C felony or a substantial risk that the defendant will commit a Class
16 B or Class A felony;
- 17 (b) The defendant is in need of correctional treatment that can be provided most
18 effectively by commitment to a correctional institution; or
- 19 (c) A disposition under this chapter will unduly depreciate the seriousness of the
20 defendant's crime.
- 21 (4) The court shall not determine that there is a likelihood that the defendant will
