Dear Parents,

Planning for the 19-20 school year is underway. We are writing to share with you some important dates and also some exciting developments on the horizon for the Fall of 2019.

First off, registration forms and financial aid information are included in this mailing. Registration forms and financial aid forms are due back May 1st. In order to receive financial aid, you must make this May 1st deadline.

Secondly, as you may have heard, we will be partnering with St. Xavier University for two different dual enrollment opportunities for 19-20:

- First, Juniors and Seniors who have a 3.0 GPA will be eligible to take college Freshman classes on campus at St. Xavier University (SXU). All who are interested should see Mr. Kimec for details.
- Also, there will be two SXU courses offered right here on our campus next year, The Business College has committed to offering two sections-one in the fall and one in the spring-of *Business Matters 100*, an Introduction to Business. The College of Sports & Exercise Science will also offer a fall and spring option also. Our Juniors and Seniors will be able to take a 100 level college course right here at de Sales next year!

This opportunity dovetails perfectly with our near-committed transition to the Work-Study model in the fall of 2020. These courses will give our students a decided advantage in the college application process and give them a taste of what it will be like to enter the workforce, which is exactly what we are planning to have our rising Sophomores and Juniors do in the fall of 2020.

Our 9th and 10th grade students who are above grade level will also have access to the SXU classes, but for others, we will be offering a Pioneer Skills Building class that will provide students with the executive functional skills necessary for success both in school and in the workforce.

So for now, please get your registration and financial aid forms complete by May 1st. If you have any questions about next year please reach out to me.

Dear Parents of Returning St. Francis de Sales Pioneers,

Thank you for choosing St. Francis de Sales High School. As we solidify plans for the 2019-2020 school year, it is time for SFDSHS students to re-register.

Re-Registration:

- 1. The annual registration fee for the 2019-2020 academic year is \$100 for all returning students who register by **May 1, 2019**. After that date, the required registration fee is \$150.
- 2. The base tuition rate for 2019-2020 will be \$8,250 If you have financial aid or plan to apply for financial aid, read below.
- 3. Please note that the course selection form, which the students submit in school, is a planning tool. It does not register the students or make them eligible for financial aid or scholarships. This is done by completing the registration packet and paying the registration fee.

Financial Aid Process:

As we did last year, we are only asking incoming freshman (Class of 2023) and rising juniors (Class of 2021) to re-apply for financial aid. For the class of 2022 and 2020 (rising sophomores and rising seniors), we are attaching your tuition agreement letter with your financial aid award. If your financial situation has changed or you have a rising junior (class of 2021), you must re-apply as outlined below for financial aid.

On the backside of this letter, we outlined what forms are due by class year.

FOR INCOMING FRESHMAN (CLASS OF 2023) AND RISING JUNIORS (CLASS OF 2021)

Any financial aid grants and scholarship awards will be subtracted from the base tuition price. Those who return the completed registration/financial aid packet by May 1, 2019 will receive their financial aid offer by May 15, 2019. If the packet is returned after May 1st, the next turnaround date for financial aid will be June 1st and the registration fee is \$150.

The registration fee and materials must be turned in to Main Office in order to be considered for financial aid.

Materials required for financial aid for incoming freshman and rising juniors include:

- a. The 2019-2020 Tuition Contract (includes all applicable fees)
- b. The Big Shoulders Common Application Financial Aid Form (This is very important. Many of our students receive Big Shoulders Scholarships and other scholarships using the information on this form. It is also used in determining the financial aid the student qualifies for.)
- c. Big Shoulders Voluntary Consent Form for incoming freshman or if not previously returned
- d. Family income documentation acceptable documents include: W-2, 1099 or tax return.
- e. Paid Registration Fee

FOR RISING SOPHOMORES (CLASS OF 2022) AND RISING SENIORS (CLASS OF 2020)

For rising sophomores (class of 2022) and rising seniors (class of 2020) your tuition agreement letter and tuition contract is attached to this letter. Please return these forms with your registration fee by May 1st. If your financial aid situation has changed and you would like to apply for additional financial aid, you must follow the steps outlined above for rising juniors.

Materials required for rising Sophomores (Class of 2022) and Seniors (Class of 2020):

- a. Signed attached 2019-2020 Tuition Contract (includes all applicable fees)
- b. Signed attached tuition agreement letter
- c. Paid Registration Fee
