WAIVER, RELEASE AND INDEMNITY AGREEMENT

Bethany Lutheran Church and School

For the purposes of the agreement the terms below shall have the following meanings:

- LICENSEE : The person who uses Bethany’s facilities or grounds.
- PARENT/GUARDIAN : The parent or lawful guardian of the licensee.
- BETHANY : Bethany Lutheran Church, 9101 Lamar, Overland Park, Kansas.
- FACILITIES : The real estate and each and all improvements, including, without limitation, the church premises, grounds, kitchen, gymnasium and classrooms located at 9101 Lamar, Overland Park, Kansas.

Terms and Conditions:

1. For and in consideration of Bethany’s permitting the Licensee to enter upon and use the Facilities, the Licensee does hereby release, waive and discharge Bethany, its officers, agents and employees of and from all liability to the Licensee from any and all claims, demands, losses or damage on account of any personal injury suffered by or the death of Licensee, as well as damage to property of the Licensee, caused or alleged to have been caused, in whole or part, by the negligence of Bethany, its officers, directors, agents and employees.
2. Licensee further hereby agrees to indemnify and hold Bethany, its officers, directors, agent and employees, harmless from and against any loss, expense or damage to the Facilities or property of others thereon arising from or growing out of Licensee’s use of the Facilities or grounds.
3. By execution and delivery hereof Parent/Guardian for and in consideration of Bethany permitting Licensee to enter upon and use the Facilities, assumes all risks imposed by conditions in and about the Facilities and use thereof by Licensee and hereby voluntarily releases, waives and discharges Bethany, its directors, officers, agents and employees of and from all liability to Parent/Guardian or Licensee, caused or alleged to have been caused, in whole or part by the negligence of Bethany, its officers, directors, agents and employees.
4. By execution and delivery hereof Parent/Guardian hereby agrees to indemnify and hold Bethany , its officers, directors, agents and employees, harmless from and against any loss, expense or damage to the Facilities, or the property of others thereon arising from or growing out of Licensee’s use of the Facilities or grounds.
