I am agreeing with the terms and conditions of this liability waiver both on my own behalf and on behalf of a minor child (named below) as parent or guardian. In consideration for the repairs and maintenance performed on this bicycle by Wheels for Winners staff and volunteers, I, on behalf of my child, myself, our heirs, executors, administrators, successors, and assigns hereby agree to release from liability, defend, indemnify, and hold harmless Wheels for Winners, Inc., and its Board of Directors, paid staff, volunteers and affiliated entities and their employees or agents from any claims or lawsuits whatsoever that may arise by virtue of my use or my child's use of his/her bicycle following maintenance by Wheels for Winners, including, but not limited to, claims for personal injury and property damage to me, my child or to third parties. I agree that I will assume responsibility for any and all consequences of the use of this bicycle resulting from any defects. I realize that I have a duty to inspect the bicycle before I or my child rides it and that I have the right to have the bicycle inspected, at my own cost, by a professional bicycle mechanic before I or my child rides it.

I also consent to the use of photographs or videos of me and/or my child taken during community service and Wheels for Winners activities by any representative of Wheels for Winners in any media. And I understand that a maximum of one bike may be earned per year by me and/or my child.

I agree that this liability waiver and photo/video consent constitutes the whole agreement between myself, individually and on behalf of my child as parent or guardian and Wheels for Winners regarding any and all repairs or maintenance performed on my or my child's bicycle. By signing this waiver and consent form I acknowledge that I have entered into this agreement freely and voluntarily and I agree to be bound by all terms contained in this document.
