- **Plan** is looking for a Technical Advisor on Gender Mainstreaming and Gender Equality for the Ministry of Education and Sports (MOES) in Lao PDR

The purpose of the post is to provide technical support to the IEC to facilitate the establishment of the Gender Education Technical Working Group. Approximately 20% of the TA time will be spent based in the IEC. The advisor will also lead gender analysis in the mid-term review of the ESDP, working within a larger external review team. This will include development of a methodology, guided by an established theoretical framework, for the analysis, implementation and reporting. For this component the TA will be based in the Department of Planning, MOES.

The position will commence in March 2013 for a period of up to 5 months and the advisor will work under the direction of the Director of the Inclusive Education Centre, MOES, in close collaboration with Country Director, Plan International. The position will be contracted by and managed by Plan International.

- **Plan** is looking for a team to carry out a Midterm Evaluation of the Plan Netherlands Girl Power Programme.

The Girl Power program is developed under the MFS-II subsidy facility of the Dutch Ministry of Foreign Affairs, and runs from 2011 to 2015. Its main goal is to build capacity in local civil society in 10 countries Bolivia and Nicaragua in Latin America, Ghana, Liberia, Sierra Leone, Ethiopia and Zambia in Africa and Pakistan, Nepal and Bangladesh in Asia, to support the empowerment of girls and young women for gender equality

For the Girl Power Program a midterm evaluation is planned for August to November 2013 and an endterm evaluation at the end of the Program in 2015. The **terms of reference** apply to the midterm evaluation. However, it is expected that the endterm evaluation will be developed along similar lines. In case of a high quality midterm evaluation delivery and a satisfactory collaboration process, the same parties will be considered to carry out the endterm evaluation in 2015.
