## 1. GADN News

### **DFID, Women's Rights and Family Planning**

The UK Government is currently working with the Bill & Melinda Gates Foundation and partners to host a Family Planning summit in London in July 2012. The event will aim to generate unprecedented political commitment and resources from developing countries, donors, the private sector, civil society and other partners to meet the family planning needs of women in the world's poorest countries by 2020. In early February, GADN were invited to a meeting with DFID and other NGOs to discuss initial plans for this event. GADN are excited to see DFID has prioritised this issue, and extremely pleased to see the strong focus on rights.

In March, GADN will hold a meeting with members to discuss how we can support DFID to make sure women's rights are central in this process. An update will be provided in the March newsletter.

### **Beyond Gender Mainstreaming Learning Event**

As part of its 2011/2012 Beyond Gender Mainstreaming Learning Project, **Gender & Development** held a highly-successful 2-day learning event in London on February 13 and 14, 2012, in partnership with **IDS/BRIDGE, Plan UK, and GADN**. Practitioners and academics from around the world met to share learning and experiences and assess the progress and future of gender mainstreaming in development.

At the Learning Event, GADN Trustee and Independent Development Consultant Helen Derbyshire presented a synthesis of learning paper on gender mainstreaming within GADN member organisations. We aim to share the learning more widely in the next financial year.

## **From beneficiaries to participants: Peruvian women driving change from the bottom up**

In February, GADN was delighted to host Womankind's partners from Peru for a meeting which allowed GADN members to hear from development practitioners and women beneficiaries on how participatory approaches can empower vulnerable women to become active change makers in their communities to reduce violence against women and young women's susceptibility to HIV.

**DEMUS (Institute for the Defence of Women's Rights)** is a Peruvian organisation working for 24 years for the defence of women's rights. We heard how they have been working to enable a grassroots women's leader to monitor government policies and services on violence against women and to demand that their interests and needs are represented locally, regionally and nationally.

**FEPROMU (Federation of Ica's Women)** is a federation of women's organisations established in 1989 in the Ica Region in Peru. We learnt about their participatory approaches to enabling young people to be community promoters so that they can sensitise their peers on sexual health and HIV, as well as participate in advocacy and lobbying activities with regional authorities.

**MEP (Movimiento El Pozo)** works with women in prostitution and victims of trafficking providing counselling to spaces for women to discuss their experiences, but also providing them with some income generating skills. At the same time MEP is actively sensitising schools, police officers and the general society on the issue of women in prostitution, to fight some of the myths around it and to lobby for the improvement of services offered to these women from police officers.

## **2. GADN Members' Update**

- **CARE** has launched a report called 'Reaching New Heights: The Case for Measuring Women's Empowerment' for IWD 2012:

*"Whilst there is broad international consensus that gender equality is key to achieving the MDGs, evidence of how and why has been absent. In an effort to better understand why CARE's huge rights based poverty reduction programme in*

*Bangladesh (SHOUARDO), had significantly reduced child malnutrition, CARE and the Institute for Development Studies sought to explore the assumption that women's empowerment was the decisive factor.*

*The research revealed that in four years, the annual stunting rate of children fell by 4.5% percent, overshadowing the 0.1% decline in Bangladesh as a whole. Declines were most striking in regions where more women had partaken in empowerment interventions – including where they had organised themselves into community groups to press for their rights to be respected at local levels, where special child care centres were established and where women's participation in parent-teacher associations were increased. In addition the in- depth research revealed that women's overall decision making power within the household had increased by 23%. Efforts to promote women's rights and child health were mutually reinforcing.*

*More evidence needs to be gathered at the international level to start measuring progress for women — or lack of it — in a systematic way to achieve MDG 3 on gender equality. The EDGE initiative, launched at the November Busan Aid Effectiveness conference aims to do this by developing a list of core indicators to track women's status in education, employment and entrepreneurship. The UN will partner with governments around the world to start collecting the data. To date it appears that only the US and South Korea have committed to the initiative. We urge you to encourage the UK Government to support it.”*

### Call for Nominations: Women Inspiring Europe

In 2010 on 8 March, the European Institute for Gender Equality started collecting nominations for the Women of Europe resource pool which is used to highlight women's achievements and success stories. Inspiring experiences and stories of women from this pool are published on **EIGE's website weekly**.

Selected women who display *outstanding experiences and achievements* are chosen to be portrayed in EIGE's annual "Women Inspiring Europe" calendar.

For each nominee a short biography and a photo should be sent to EIGE. Preferably, a written agreement should accompany the nomination, allowing EIGE use of their data in the event it should need to be made public (e.g. on EIGE's website, in social media or in EIGE's Calendar 2013).

USAID, the Government of Norway, the Bill & Melinda Gates Foundation, Grand Challenges Canada, and DFID invite applications to respond to "Saving Lives at Birth: A Grand Challenge for Development" (Round II). The partners aim to invest at least \$50 million in "groundbreaking" and sustainable projects that cut across the domains of science and technology, service delivery, and demand-side innovation. They anticipate awarding 25 seed grants and five transition-to-scale grants this year. Applications shall be received no sooner than March 19, 2012 and no later than Monday, April 2, 2012.
