1. GADN News

Members Meeting and Public Seminar: Peace, Security and Violence against Women – Is SCR 1325 delivering for women?

On September 23rd GADN in collaboration with Gender Action for Peace and Security (GAPS) hosted a public seminar on peace, security and violence against women in the context of the implementation of UN Security Council Resolution 1325. Sharon Smee (ActionAid) introduced the work of the GADN Violence against Women Working Group and led a discussion about the causes and consequences of Violence against Women while Laura Hotchkiss (GAPS) introduced the work of GAPS, the No Women No Peace Campaign and the APG on Women, Peace and Security. This was followed by a discussion led by Mairi MacRae (Womankind Worldwide) on how GADN and GAPS can work together and what the two networks hope to see from a revised UK National Action Plan on 1325. The seminar then welcomed Chris Hunter and Alice Hutchinson (FCO) who addressed the UK government's approach to SCR 1325 and details of the revised National Action Plan, followed by a consultation space that allowed the FCO to answer questions from the audience about the revised plan. The second half of the meeting included presentations by different GADN members with case studies regarding the actual implementation of SCR 1325. Howard Mollett (Care International) gave a presentation on the 'Research on the impact of 1325 on the lives of women in Nepal, Uganda and Afghanistan'; Dr. Annalise Moser (Consultant) presented on 'Civil Society Monitoring of 1325: Global Analysis from 11 Countries' (Project of the Global Network of Women Peacebuilders), and Katherine Ronderos (CAWN) gave a presentation on 'Women in Honduras: Trapped between Peacebuilding and Militarisation'. Minutes and notes from the presentations will be circulated shortly.

Meeting with DFID

On 8th September, members of the GADN Steering Group met with Ros Ebdon, DFID's Senior Gender Adviser in the Equity and Rights Team, and Simon Williams, Gender Equality Champion in DFID's Europe Department and DFID's lead co-ordinator for the European Development Practitioners Network. Plans for DFID's work on gender equality and women and girls was discussed, as well as how DFID and GADN can work together in the coming months on our common priorities:

1. Girls' primary and secondary education
2. Improving maternal health and family planning
3. Economic empowerment
4. Violence against women.

London consultation meeting on DFID's business plan on reproductive, maternal and newborn health

On the 29th September Jessica Woodroffe (GADN Chair) and zohra moosa (GADN Steering Group member and Women's Rights Advisor at ActionAid) attended a consultation meeting with DFID on the maternal health plan, with Andrew Mitchell speaking. Views expressed at the meeting will be assessed by DFID alongside all the consultation submissions, giving them a greater understanding of reproductive, maternal and newborn health issues around the world. After the consultation closes DFID will publish a final summary of responses to all the feedback submitted. Feedback will also be provided to explain how the consultation influenced the plan and explain why any items may not have been included.

International Womens Day 2011

GADN Working Group updates

The members meeting and public seminar on the 23rd September was successfully organised by the **GADN Violence Against Women Working Group**. A huge thank you to the group and in particular to the chair, Sharon Smee (ActionAid), for all their hard work.

The **Gender Mainstreaming Working Group** will have its next meeting on the 28th October from 2-5pm. CAFOD and Plan UK will present their experiences of gender mainstreaming; sharing and discussing in greater detail the challenges and approaches to gender mainstreaming in their respective organisations – as part of a wider process of action learning. It is hoped that these case studies will at a later stage be developed into a learning product or publication.

Following the Summit in New York, the **MDGs Working Group** is working with BOND on their submission to the International Development inquiry into the summit, to ensure a gender analysis is included. The working group is now thinking forward on the post-2015 MDG framework.

The **UN Women Working Group** is putting together a policy paper on the new UN Women's entity. It will be draw on past failures of gender bodies of the UN and will provide operational recommendations. Oxfam Novib and GADN are commissioning the international consultancy firm MDF Training and Consultancy to conduct a survey which identifies what women want from the new UN gender equality entity at country level by interviewing a diverse range of women's rights advocates and their organisations. Based on the survey results, a report that honestly and accurately captures the needs, aspirations and concerns of women's rights advocates and their organisations at country-level will be produced.

The **Sexual and Reproductive Health and Rights Working Group** is pleased about the recognition that the new coalition government has given to increasing SRHR on the development agenda, and one of the priority issues of the working group will be to include gender and feminist perspectives in that debate. The group hopes to find expertise in that area, so please sign up to the group if you are interested. Currently, GADN is organising a conference with Marie Stopes International and Euro NGOs on the 8th and 9th of November (see <http://www.gadnetwork.org.uk/events/>), as well as working on a submission to DFID's maternal health consultation.

2. GADN Members' Update

- **Social Development Direct**, in partnership with the Barbican, are hosting a screening of the award winning documentary *The Greatest Silence* directed by Lisa F. Jackson. The documentary was the winner of the Special Jury Prize at the 2008 Sundance Film Festival. The screening of this documentary is to commemorate the 10th anniversary of UN Security Council Resolution 1325 on the participation and protection of women in conflict and peacebuilding. The documentary is a piercing look into the struggles of rape survivors in the Congo over the last two decades and was an inspiration for a 2008 UN Security Council Resolution demanding international action on rape. A survivor of rape herself, Lisa travels through the Democratic Republic of Congo to bring to light the plight of women and girls caught in the country's intractable conflicts. Following the screening, there will be a panel discussion with Lisa and Sarah Maguire, the Chief Executive of Social Development Direct. This event will take place at **8:45pm on Wednesday October 20th, 2010** at the Barbican Centre in London. Tickets are £8.50 online available from the **Barbican website**.
- **GAPS (Gender Action for Peace and Security)** will be hosting two events to commemorate the 10th Anniversary of SCR 1325. During conflict women are a prime target. Yet when it comes to building peace, women are often excluded. At the 10 year anniversary of an important UN resolution on women and peacebuilding, 'No women, No Peace' will make the case that you can't build peace leaving half the people out. On Friday, the **15 October 2010**, GAPS will be launching the 'No women, No Peace' campaign at the Frontline Club, London. This Public Launch and Party will include a night of drinks, art, comedy and music. The night will feature an exhibition of artwork from the 'No women, No Peace' creative competition, some inspiring speakers, and comedy from finalists of the 2010 Funny Women Awards!

GAPS will also be hosting the Parliamentary Launch of the 'No Women, No Peace Campaign on **11 October 2010**. This event will include a Panel Debate on 'How can the UK government facilitate women's participation in peacebuilding?' and will take place at the Grand Committee Room, House of Commons at 6pm. The event will also launch a new report by GAPS member **CARE International UK** examining women's participation in peacebuilding and post-conflict governance. Speakers include: The Foreign Secretary, Rt Hon William Hague MP; Kate Allen, Director, Amnesty International UK; Wazhma Frogh, Afghan women's rights activist; Chair: Deborah Haynes, Defence Editor, The Times and more.

- **CAWN** would like to invite you to the launch of the research report, 'Intersecting Violences: A Review of Feminist Theories and Debates on Violence against Women and Poverty in Latin America' on **Thursday 21st October 2010 from 2pm - 5pm** (followed by drinks reception). This research report, commissioned and published by CAWN, provides a critical review of academic literature on violence against women (VAW) and the links between violence and women's poverty. - **One World Action** has launched its MDG Report entitled **'Getting Back on Track: Putting Women at the Heart of the MDGs'**. Governments from around the world met in September to reaffirm the original vision of development that gave rise to the Millennium Development Goals. With only five years left to meet the MDGs, the MDG Review Summit is a chance to revisit the shortcomings of the last ten years and to make a lasting, tangible impact on the lives of the world's poorest people. One World Action believes that urgent action is needed to address gender inequality and discrimination that makes and keeps people poor.
- **Plan UK** is pleased to announce the 4th instalment of the yearly girls report entitled **'Because I am a Girl: The State of the World's Girls 2010'**. This year's 'Because I am a Girl' report looks at the lives of adolescent girls in two of the fastest growing arenas in the world today – the urban environment and the digital world. Both present new opportunities for girls and young women but also new dangers; risks which are little regulated or researched. This is particularly serious at adolescence, when girls are becoming sexual beings but have not yet developed the skills or the knowledge to protect themselves from harm. It is precisely at this time in their lives that they need the most support. Yet this is also when prejudice and discrimination – that treats girls as less equal and less important than boys – puts them most at risk. Young women should not have to put up with the abusive experiences that for many are part of their daily lives. In these new arenas girls have the right to the same protection, opportunity and equality that they should have always and everywhere.

Adolescent girls need access to information, to education, to safe spaces, decent housing and to networks of people who can support them as they grow into women. Without these we doom a new generation to unfulfilled and unproductive lives. But we don't have to. The digital and urban worlds provide real opportunities for girls and young women. If we plan our cities properly, if we keep girls safe on our streets and online; if we protect them from harm, but at the same time enable them to develop the skills they need, we have the chance to change lives. With genuine access to opportunity and protection from danger, girls will grow up as empowered citizens and our world will be the richer for it. Now, as we

build cities and the digital world expands, there is the opportunity to really equip girls with the skills and the knowledge to ensure a better and safer future for us all.

- **UNIFEM UK** will be marking the International Day for the Elimination of Violence Against Women at the end of November with a series of seminars. Two of the seminars will be held in London. The first will be held on **Thursday 25 November** (evening) on **'Moving Public Advocacy Forward'** and will include a discussion about public advocacy campaigns to tackle gender related violence examining what has and hasn't worked in the past, how these campaigns will evolve in the future and innovative campaigns to target men, such as the White Ribbon Campaign. The second event will be held on **Thursday 7 December** (evening) and will speak about 'Does the UK have the right domestic violence laws and are they enforced?' The panel of speakers will focus on whether the UK has the correct laws for dealing with domestic violence. The venues are to be announced.
- On **Thursday 14 October** at The Human Rights Action Centre, 17-25 New Inn Yard, London EC2A 3EA, **Amnesty International UK** hosts an exclusive screening of **'The Stoning of Soraya M'**, a shocking and powerful film which tells the story of a horrific punishment meted out to a woman in Iran. The film will be followed by a Q&A with director Cyrus Nowrasteh and an opportunity to take action to help stop the real-life execution by stoning of Sakineh Mohammadi Ashtiani in Iran. - **WOMANKIND Worldwide: Freedom to achieve: Preventing Violence, Promoting Equality: Starting in schools, 25th November 2010, 10am – 4pm**

What does the government think about the prevention of violence against women and girls? What do we know works in schools? Tim Loughton MP, Parliamentary Under Secretary for Children and Families, is the keynote speaker for WOMANKIND Worldwide's event, which will launch the findings from a two-year research project which looked at how to develop a whole-school approach to end violence against women and girls, which in addition to the physical and psychological effects, is estimated to cost society £40 billion each year. The research team considered existing initiatives taken across secondary schools in England and Wales and how these approaches can create a safe and equal environment.

Are you aware that across the UK, 3 million women experience violence each year? Recent research suggests that this starts at a young age, with young women reporting daily experiences of sexual bullying in secondary school. 6. Campaigns/Calls for Papers

- **Campaign: Global Justice Centre: The Right to an Abortion for Girls and Women Raped in Armed Conflict: *states' positive obligations to provide non-discriminatory medical care***

The Global Justice Centre comprises a body of international law experts that advocate for the progressive implementation of international human rights and international humanitarian law. Currently, the GJC is campaigning on the right to abortion under international humanitarian law for girls and women impregnated by wartime rape under the Geneva Conventions, its Additional Protocols, and customary international law, including the law on state's responsibilities. Since rape is considered to be a war crime, the failure to provide women with access to safe abortions is therefore a breach of the aforementioned International law. As a result, more women are killed daily in the denial of abortion than rape as a weapon of war. The GJC believes there must be accountability for women in conflict – when the Geneva Conventions are valid, non-discrimination must be applied to both civilian and combatants and all states have a responsibility to ensure the effective delivery of humanitarian aid.

Accordingly, the GJC advocates for an end to US abortion restriction services on all foreign aid which fosters and perpetuates states' breaches of the Geneva Conventions. While President Obama has lifted the Global Gag Rule, the Helm's Amendment¹ remains in tact and affects over \$49 billion dollars of foreign aid, ultimately censoring the promotion of international legal rights to abortion. The GJC holds that US foreign policy has had a pernicious effect towards the promotion of human rights, particularly in the way agencies teach and practice human rights overseas. This policy has a far-reaching effect and ultimately hampers the UK's ability to effectively deliver its aid promises. While DFID's policy is to provide equal care and access to abortion for women raped during armed conflict, this gets squelched when mingled with US funds and a US mandate.

The GJC has filed a shadow report with the Human Rights Council urging the Council in its universal periodic review of the United States in November 2010 to include in its findings that US abortion restrictions placed on humanitarian aid violate international humanitarian law.

The GJC aims to:

1) Get the UK to make clear this censorship and prevention of access to abortion during wartime is a violation of the Geneva Conventions and in breach of delivering equal care to all civilians.

2) Although rape is considered a weapon of war in many Security Council resolutions, legally rape is considered a war crime but not actually as a weapon. The law of weaponry is a component of international humanitarian law and the UK has signed protocols that every weapon in the law of weaponry has to be reviewed and analysed and weapon-inflicted injuries have to be treated by local hospitals. The GJC wants to classify rape as a 'weapon' under international humanitarian law.

¹ No foreign assistance funds may be used to pay for the performance of abortion as a method of family planning or to motivate or coerce any person to practice abortions.

ADI have teamed up with 38 Degrees and ECPAT UK to ensure the Government sends out a tough message across the world to traffickers that this crime will not be tolerated and that concerns over sovereignty are not prioritised over the rights and protection of victims.

- **Call for Papers: Gender & Development - Social Protection**

The July 2011 issue of the international journal Gender & Development, (published for Oxfam GB by Routledge/Taylor and Francis) will focus on Social Protection.

For poor women, men, children, and elderly people in developing countries, fear of an unexpected crisis which will spell disaster is the norm, and particular groups of people face chronic poverty simply because they are unable to earn an income. In the wake of the global economic crisis, Social Protection measures which ensure a basic level of support to enable people to survive or stabilise their livelihoods have become still more critical. Social Protection is central to the development challenge of ending poverty.

This issue of Gender & Development looks at Social Protection from a gender perspective. How do different forms of social protection support gender equality and women's equal rights? How do women's organisations and gender-sensitive development organisations understand the role of Social Protection in alleviating poverty and challenging marginalisation? Gender & Development invites articles from development activists, advocates, policymakers, practitioners, and feminist activists who are able to share insights about Social Protection from a gender perspective. All our articles are drawn from primary research into the impact of policies on poor women and men in specific countries and communities. They envisage addressing questions including:

- What forms of Social Protection work well from a gender perspective (in particular, to support gender equality, and the care work which forms a part of all societies)?
- What potential have different schemes had for redistributing assets from men to women? Case studies of schemes involving different stakeholders: government, NGOs, research institutions
- What are the pitfalls of Social Protection schemes which fail to consider gender issues?

Tactical Tech's new project - Visualising Women's Rights in the Arab World - aims to strengthen the use of visual techniques for campaigning amongst women's rights activists in the Arab World. Tactical Tech invites applications for participation from activists and NGOs in the Arab region, working on women's rights, to join us in a three day hands-on workshop to explore how visual techniques can strengthen campaigning.

The workshop will give participants the skills to plan and strategise visual campaigns, think about how to use information effectively and gain hands-on skills to develop a campaign using information design, mapping and animation/imaging techniques. This initiative has been designed to help advocates develop their creative skills and learn how to use information more effectively. Maya Ganesh, who is leading this project at Tactical Tech, says: "The inventive and creative use of information has great potential to express women's particular experiences and realities in addition to exposing the systemic and structural barriers that prevent the full enjoyment of their human rights. This is an under-utilised technique, but has the potential to really engage audiences and present ways of addressing new and old debates".

Tactical Tech invite applications for those working on women's rights issues, in particular violence against women, the impact and role of women in political and violent conflict and women's participation and leadership in public life. They also welcome communications specialists, designers, artists, illustrators, or technologists working with mapping techniques or data who can support women's rights activists. 35 to 40 applicants will be selected to attend the launch workshop in Jordan in December. Participants will have to bring with them a campaign idea which will be developed over the course of three days. Of these, 10 campaigns will be provided with small-scale follow up support and mentoring to implement the visualisation element of their campaign in early 2011.

Scholarships to attend this event are available for those working on women's rights issues in Palestine, Iraq, Lebanon, and Jordan. - **Podcast:** In time for the UN Summit on the Millennium Development Goals 2010, **UNIFEM (part of UN Women)**, in collaboration with UNTV, produced a series of five videos highlighting select MDGs from a gender perspective. Introduced by internationally renowned TV journalist Daljit Dhaliwal, all videos are now available for download in English, French, Spanish and Russian.
- **MDG 1: Cambodia - Eradicate Extreme Poverty and Hunger**

Eradicating extreme hunger and poverty is a key focus of the Millennium Development Goals set in 2000 by world leaders at the United Nations. Secure employment is critical to overcome poverty, yet worldwide 60 percent of people are working without a formal contract or social security protection. The majority of them are women and too often their labour rights are exploited. But one idea showing promise can be found in the homes of women in Cambodia. We travelled to Phnom Penh to see how the rights of home-based women workers are being protected, providing the women with a ladder out of severe poverty.
- **MDG 3: Liberia - Promote Gender Equality and Empower Women**

Liberia — it was a country engulfed in war, its women bearing the brunt of the conflict. While peace finally did come, the legacy of violence against women continues to haunt the country. But Liberia's women are now taking positions of power and filling roles usually dominated by men. We look now at how women in decision-making positions are helping to pave a new path to their country's future.
- **MDG 6: Botswana - Combat HIV/AIDS**

Botswana, in Southern Africa, reportedly has one of the highest HIV and AIDS prevalence rates in the world. Especially hard hit are the women in rural areas, who cannot access medical care. While there still is a very long way to go, new methods for delivering services and information to hard-to-reach women is starting to make a difference.
- **MDG 7: Colombia - Ensure Environmental Sustainability**

Climate change in parts of the world can lead to an increased struggle to grow food and the displacement of populations. This is the case in Northern Colombia among the indigenous Wayuu people, where desert conditions have been exacerbated in recent years. As in many parts of the world, it is the Wayuu women who feed their families and provide water — and they are struggling to ensure their community's very survival despite dwindling water resources.

- **The Missing MDG Target: Violence against Women**

Tragically, up to three-quarters of women and girls worldwide experience physical or sexual violence in their lifetime. And the effect on the millions of girls and women who are abused is devastating — not just on them personally, but also on their ability to fully participate in the development of their countries. Unless violence against women is curbed, meeting all of the eight Millennium Development Goals will be impossible.

The Gender and Development Network is a diverse membership network of leading practitioners, academics and consultants working on gender and development issues in the UK.
