Dear Friends,

Across the country, Court Appointed Special Advocates (CASA) are providing life-changing, life-saving help to thousands of abused and neglected children each day. In Passaic County, currently more than 200 of the more than 600 children in the foster care system each year are receiving help from a CASA volunteer advocate. Their tireless efforts result in children reaching safe and permanent homes that they otherwise may not have known.

Once again this year, Passaic County CASA will join over 35 CASA programs across the country in hosting a "Superhero Run." The 3<sup>rd</sup> Annual Superhero 5k and Family Fun Run will be held on August 20, 2016 at Garret Mountain Reservation in Woodland Park, NJ in conjunction with the Passaic County Fair. This will be a special day to raise awareness about child abuse prevention, support those who serve our children, as well as raise funds to allow more children to have a voice in the courtroom. Many children can't run from abuse. We dare you to move, get involved, to make an impact, and help change your community for the better. All while having fun!

The day will incorporate both a USATF sanctioned, timed 4 mile race as well as a 1 mile, family "fun run/walk". At the end of the run will be a celebration of post-race activities geared for all ages. Sponsors and volunteers are sought for activities before, during and after the race. Prizes will be given for 1-3<sup>rd</sup> place male/female runners and also in the children's race. Additional prizes will be awarded for best costume, best team costume, (adults and kids). All children who register will receive a blue cape to run in and keep commemorating the day. Adults can purchase one at minimal cost. Adults will receive a commemorative race t-shirt. Sponsors are welcome to provide giveaways to runners at stations throughout the race or via a gift bag at the finish.

We ask that you consider supporting this important event by becoming a sponsor for the day. Sponsorship levels and benefits associated with each level are described in detail in this packet. We are willing to customize a sponsorship opportunity for you.
