The organization's activities principally consist of recruiting, training, and supervising volunteers who are appointed by a judge in Family court to advocate for a child or family of children who are in out-of-home placement. During this year, the Organization served 250 children and utilized the services of 105 volunteers who donated 6,647 hours of their time to the Organization's mission.

Program services expenses and other expenses as presented here does not include \$218,146 of donated services (see Schedule O for details).
