Client Electronic Notification For the Tax Year 2016

- You must retain a complete copy of the return and any supporting material.
- An amended return, if needed, must be filed as a paper return and mailed to the Internal Revenue Service Center that would process your paper return.
- Upon request, Milam & Associates, PLLC will provide you with the DCN (Declaration Control Number) and the date the IRS acknowledged that the electronic portion of your return was accepted for processing.
- The IRS TeleTax number, which can be used to inquire about the status of your tax refund, is 1-800-829-4477. We advise you to wait at least three weeks from the date the IRS acknowledged that the electronic portion of your return was accepted for processing before calling the TeleTax number. You will need your social security number, filing status and exact amount of your refund.
- Taxpayers can go to www.irs.gov to check the status of your refund or, if you have a smartphone or tablet, you can download the free app “**IRS2GO**” to check the status of your refund. In either case, you will need your social security number, filing status and exact amount of your refund.
- You have the option to receive your refund by paper check or direct deposit.
- Once the electronic portion of the return has been accepted for processing, (a) the direct deposit election cannot be rescinded, (b) the routing number of the financial institution cannot be changed, and (c) your account number cannot be changed.
- The IRS does not guarantee a specific date by which a refund will be directly deposited into your financial institution account (if you have selected the direct deposit option).
- If you have a balance due return, you are responsible for making full and timely payment of any tax that is due. Failure to make full payment will result in the imposition of interest and may result in the imposition of penalties.

RECORD A JOURNAL ENTRY IN QUICKBOOKS

In QuickBooks, journal entries are made in the **Make General Journal Entry** window. This option is available for accountants or users who prefer the traditional system of accounting in which transactions are entered into a general journal. If you are not an accountant, you might use the general journal to transfer amounts from one income or expense account to another or from one class to another.

In order to complete your year-end activities, Milam & Associates, PLLC may instruct you to record miscellaneous journal entries in QuickBooks. This step is important so your books match the information reported on your tax return(s).

Note: When making journal entries in QuickBooks, you need to know which account receives the debit and which account receives the credit side of the transaction. The Debits and Credits are indicated on the AJEs provided by Milam & Associates, PLLC.

To record a journal entry:

1. Choose **Company > Make General Journal Entries**.
2. In the Make General Journal Entries window, change the **Date** field to match the date noted on the AJEs (adjusting journal entries) provided by Milam & Associates, PLLC. If you receive multiple years of AJEs, you will need to change the date accordingly.
3. If there is no number in the Entry No. field, enter a number for your journal entries. QuickBooks will automatically number subsequent journal entries. The AJEs provided by Milam & Associates, PLLC will indicate the "number" to use, usually beginning with "CPA", the year, then the number of journal entry (i.e. "CPA.2015.1 or CPA.2016.2"). If you use the Milam & Associates, PLLC "number", we will be able to easily reference this AJE if you call for questions.

 - A. In the **Account** column, enter or select the first account in your transaction. If you are using an A/R (accounts receivable) or A/P (accounts payable) account, the first account in the General Journal transaction should be the accounts receivable or accounts payable account. If you do not show that account in your Quickbooks, Milam & Associates, PLLC may have created a new account for this entry.
