The Art Festival plays host to thousands of attendees over the weekend, from New England and the NY Metro area.

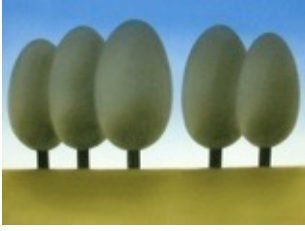
