ADRENALINE ALL-STARS CONTRACT

DANCE YEAR: 2018 - 2019

Season runs from June 1, 2018 to May 31, 2019

Thank you for joining Adrenaline! This agreement outlines the terms and conditions for participation in the Adrenaline All-Stars Program.

1. Overview of the All-Stars Program.

- A. All-Star Dance is a competitive, team-based sport focused on three types of dance (hip hop, jazz and pom) in six different age groups (Tiny, Mini, Youth, Junior, Senior and Open). It is governed by the United States All Stars Federation (USASF at www.usasf.net).
- B. We generally compete 6 8 times per year (including an Adrenaline sponsored season "Premier" at the beginning of the season) and a Spring Recitals in the end of May or early June.
- C. The All-Star season begins June 1, 2018 and continues through the end of May 2019. Worlds / Summit (late April / early May) and the Spring Studio Recital at the end of May or early June.

2. Fees and Expenses.

- A. Explanation of Fees and Expenses for the Season.
 - (1) Deposit Due Upon Registration.

Upon registration, an initial non-refundable deposit of \$350 per dancer is due. This amount will be applied towards mandatory pass-through team costs (i.e., costume, choreography, music, practice wear)

(2) Monthly Tuition (paid monthly on the 1st of the month via Auto-Pay).

- (a) Tuition is a MONTHLY fee based on the number of teams enrolled in per month.
- (b) Fees are not increased for 5-week months nor is it decreased for less than 4-week months-including holiday closings. Tuition is considered late after the 1st of the month. There is a \$15.00 late fee after the 5th of the month. Returned checks will incur a \$35 fee. Tuition unpaid by the 5th may result in the dancer not being permitted to return to practice until paid. Accounts must be current to participate in the first competition.
- (c) Per Dancer: One Team: **\$199/month, Two Teams: \$299/month, Three Teams: \$329/month.** See pricing sheet for more details. (tuition now includes a Technique Class per discipline)
- (d) Monthly Tuition includes one all-star only technique class per discipline. (Maximum Two Classes included)
- (e) All Star Tuition begins June 1, 2018 and continues through end of April 30, 2019. This means that if your child does not begin practices or joins the All-Star Program after June 1, 2018 (due to vacations, etc.), you are still required to pay tuition from June 1, 2018. This is because our studio still has fixed costs (instructors, rent, etc.) that must be paid, and it is unfair to start the season late when other members of the team are practicing over the summer.
- (f) There are is no monthly all-star tuition for May 2019.

(3) Mandatory Pass-Through Costs (paid *once* at the beginning of the Season, per team).

Fees are assessed one-time at the beginning of the season. However, in the event your team earns a bid to a non-scheduled competition at the end of the year, extra competition fees may apply depending on the type of bid received. Upon receiving a bid, let us know as soon as possible whether you will participate.

- (a) Costume, Music, Choreography.
- (b) Competition Fees. Estimated Competition Fees are: One Team \$659.00, Two Teams \$879.00, Three Teams \$999.00.¹
- (c) Annual Registration Fee. \$39 (individual) or \$50 (max/family)
- (d) USASF Registration. You will pay this fee directly to USASF.net (currently \$30) Instructions below.

¹ These are estimates only. Final amounts will be known after the schedule is finalized and a reconciliation will be performed based on actual costs resulting in additional amount required. The estimated amounts above are based on the past year's competition fees for 6-7 competitions. Solo, Duets, Trios not included. Travel and Hotel not included.

(4) Additional Fees

- (a) Warm-up Jacket. (*New All Stars or replacement) \$125.00
- (b) Backpack. (\$95.00 with name embroidered, New All Stars or replacement)
- (c) Practice Wear (*Required, \$35.00) 2-Practice Shirts
- (d) USASF membership (*Required) paid directly at http://www.USASF.net (see below)
- (e) Worlds / Summit Fees. For dancers attending Worlds or Summit in late April/early May, the following costs apply:
 - i. Fees to Worlds/Summit organization which includes competition fees, hotel accommodations and local bus transport; and
 - ii. Coaches fees, per dancer: 1st Team \$100.00, 2nd Team \$50.00, 3rd Team \$50.00 team attending Worlds / Summit which are used to pay coaches and their expenses.

B. Payment Terms.

- (1) Pass-Through Costs (Team Fees and Competition Fees) are due in full by October 15, 2018. Once your team fees are set, you will have three equal payments due by (July 14th, August 14th, and September 14th). Adrenaline will collect any outstanding Pass-Through Costs with November 1st Monthly Tuition via Auto-Pay.
 - (2) All-Stars must register with <u>https://dancestudio-pro.com/online/adrenalinestudio</u> to have their monthly tuition autopaid via credit card. More details below.
- (3) If the team fees and competition fees are not collected by November 1st, your dancer may be held out of practice and not compete in the first competition.

C. Tuition Discounts.

- (1) Multiple Children Discount for Monthly All-Star Tuition: Second Child 25%, Third Child 30%.
- (2) Please see the Pricing Sheets for more details and fees for Boys and Tiny Teams (Attachment 1)

D. Deposit Due Upon Signature. (Prior to 1st Practice)

Upon signature and prior to first practice, a \$350.00 non-refundable deposit per dancer is due (this will be applied toward the one-time fees described above) along with the June monthly tuition. See the attached pricing sheet for details.

Discounts on Studio Classes.

All Stars receive SPECIAL RATES on Adrenaline Studio Classes. For the 2018-2019 Season All Stars will receive 50% off tuition of studio classes. (Does not include master classes, camps, workshops, or recital costumes). Studio Classes continue through May 2019.

E. Cancellation Policy.

30-day's notice to leave the program for Major Medical and Family Relocation. Families are responsible for all tuition and fees up to the last day of the 30-day period. All associated All Star Team Fees (competition, costumes, etc.) paid are non-refundable.

Once enrolled, if a dancer decides to leave a team for any reason other than Major Medical and Family Relocation a <u>\$350.00</u> Cancellation fee per team applies.

3. Registration

A. Registration with Adrenaline Payment System.

After acceptance onto an Adrenaline All-Star team, online registration is required, along with automatic bill pay through our studio management software site <u>https://dancestudio-pro.com/online/adrenalinestudio</u>. Monthly All-Star Team Tuition is paid in advance for the entire month.

Registration with USASF.

You must have an active USASF membership for the 2018-2019 season by October 1, 2019. Current All Stars must renew and new All Stars must register for a new membership number for the 2018-2019 season after July 1st and October 1st. This is required for your competition eligibility in 2018-2019 and is done directly on the USASF site http://www.USASF.net. Returning All Stars must renew their current USASF membership number after July 1st.</u>. Birth Certificates must be uploaded onto the USASF.net site for approval to be eligible, as well as a copy of the birth certificate provided to the studio. This is because certain competitions may have problems verifying registration and we generally bring copies of all birth certificates to each competition.

4. Conduct.

A. Practices.

Practices are closed. Please be respectful and do not enter the individual studios without a coach's permission. Practices may be changed and/or added during the competition season. We will do our best to notify you as soon as possible with any changes. Team members are expected to have appropriate practice attire. Please wear your practice shoes while at the studio. Cell phones must be turned off during all practices. Dancers are expected to maintain good physical condition; to include flexibility and strength.

Studio Conduct.

Students and parents will conduct themselves in an appropriate manner while at the studio, performances, competitions, recitals and events where Adrenaline Studio is represented. Respect for the instructors and fellow students are expected of students, parents/guardians, and siblings in and outside the studio. Disrespectful, uncooperative, or aggressive behavior does not have a place at Adrenaline Studio. Violation of this policy can result in dismissal from team and or the program. No refunds will be given if a student is dismissed from the studio or program. Any inappropriate or slanderous remarks about Adrenaline Studio or its instructors on any social media site can be cause for immediate dismissal from the studio. Dancers are not permitted to smoke, drink, or use drugs - any athlete electing to do so at a dance event or a travel competition will be removed immediately, disqualified from performing and potentially expelled from the program. You understand and agree that the owners of Adrenaline have the sole discretion to determine whether a dancer or parent has engaged in conduct that warrants dismissal from the Program.

Supervision Required for Minors at the Studio While Not in Practice.

We understand that dancers often have time in between practices and it is not always practical for parents or guardians to pick up their children between practices. Therefore, any minor at the studio, not in a class or practice must be able to manage their own behavior appropriately. It is at the absolute discretion of Jen or Kelly Koonce to allow or not allow a minor to be at the studio without his or her parent or guardian and the terms of dismissal in the previous paragraph may apply. Because we have over 100+ All-Stars, if your minor is at the studio unsupervised by his or her parent or guardian, Adrenaline is in no way liable for or responsible for such minor, including, but not limited to such minor making the decision to walk to the nearby market for food and snacks.

B. "One Team One Family."

Adrenaline promotes a family atmosphere. We understand that not every one of our 100+ dancers will be best friends. We encourage our kids to resolve their differences and sometimes we ask for parents to get involved. At the end of the day, if we believe certain dancers and/or their parents are not making the effort we believe necessary to resolve their issues with others, we reserve the right to refuse service without reimbursement.

C. Addressing Concerns.

Adrenaline prides itself in being a safe and healthy program. We've built a strong, kind and talented studio and our participants and their parents are expected to behave consistent with this approach. Should you have any issues, please contact the Director, Jennifer Koonce immediately to set up an appointment to discuss your concerns. Process: send an email to request a meeting and outline your concerns to be discussed at the meeting.

D. Media and Video Taping.

Practices and Competition routines may NOT be posted on any social media or websites (including, but not limited to personal sites, YouTube, Vimeo, Instagram, etc.) until AFTER the competition season is complete (After Worlds/Summits). Practices may not be taped without a coach's permission. Videoing choreography of younger teams is permissible (to assist with memory, etc.), but will be at a coach's discretion. Please also be aware that is NOT permissible to duplicate or replicate competition or studio choreography or music in any outside performance (including but not limited to; schools, community events, talent shows, etc.).

F. Competitions.

Dancers are expected to arrive at the designated CALL TIME regardless of your performance time. This is a Program. We arrive and leave as a Program. Unexcused dancers at competition will be charged a non-participation fee of \$150. We are charged for every dancer on the roster and can be disqualified for unreported number changes. Absences put the entire team at risk and affects scoring. If your dancer is not feeling well the day of a competition, you are expected to be there and give it your all for the overall success of the program and team. Last minute changes in formations and routines are not fair to the Team. Injured dancers are expected to attend all competitions. Dancers must wear Adrenaline Program T-Shirts and warm-ups when not in uniform. Participation in the Season Premiere and Spring Recital is mandatory (like a competition) and pulling your dancer

without permission from one of these events will also result in a non-participation fee of \$150 and possible expulsion from the Program. Additional rules for competitions may apply.

F. Sportsmanship.

We expect our Adrenaline Family to be respectful of other programs and performers. Dance is a difficult and beautiful sport. We encourage everyone to do their best and celebrate the success of all programs. Results may not always be what we anticipate; however, dance is a subjective sport. The venue is NOT the place to voice concerns or critiques of other teams, performers, coaches or parents. At NO time will parents, team members, or family members approach a judge or competition official. If you have a concern, you may bring it to your coach's attention and we will determine with how to proceed. Parents, please be aware of your behavior at competition. We are representing our community of athletes at all times, so our families, fans, and athletes should refrain from inappropriate behavior, or negative speak about other teams, coaches, or parents. All dancers must be in costume (Hair & Makeup) for award ceremonies! No warm ups, phones, backpacks, purses on stage. Just costumes.

H. Travel Guidelines.

(1) Chaperones.

Dancers must have a parent/guardian or chaperone with them at the competition. Chaperones must have a permission slip from the parent/guardian allowing the Guardian/Chaperone authorization of medical treatment for your child. The Chaperone will need an insurance card. We have approximately 100 All-Stars at each competition and it is not the responsibility of the Adrenaline Staff or the Team Parents to chaperone dancers.

(2) Arrival Time.

Dancer families must arrive at venue when instructed. No early arrivals or missed practices due to early travel. The Adrenaline Travel Liaison Parent will be sending out important information all year. If you book a flight before the details of the competition have been provided and your travel plans are not in-line with the Program, you may be pulled from the competition.

(3) Hotel Information.

Hotel information will be provided for the host hotel of the event as soon as it is available. Host hotels offer discounts for competitions and each dancer/family is responsible to make your own accommodations for all out of town competitions. Please be aware of deadlines so you can get the best deal! Many of the hotels sell out early for big competitions. If you are late reserving your rooms, you may not be able to find a hotel. We do not reserve extra rooms.

I. Studio & Competition Attendance.

(1) Practices.

Please arrive on time for practices and be ready (10 minutes prior to start time). All-Star Dance is competitive and intense therefore, attendance is key for our teams to experience success! Please schedule all college preparatory courses and tests on non-competition weekends. Excused absences include: contagious sickness, and death in family, emergencies.

(2) Unexcused Absences.

Work, social events such as birthday parties, parties, or concerts; homework, projects, preparatory tests; minor illnesses (stomachache or headache), minor injuries— if you are not contagious you should be at practice! Injured dancers are required to attend rehearsals and competitions. Excessive absences may result in removal from a competition. Mandatory rehearsals are the two practices before a competition (Sunday & weekday before).

Withholding your dancer from practices as a punishment for non-dance related behavior is not recommended. Team sports are designed to build character and confidence. We want the very best for our dancers, building their confidence is important to us, so let's work together to make this a fantastic experience! If you miss practice and need to catch up on choreography, you will need to set up a private lesson to make up for missed choreography.

5. Participation Waiver and Release of Liability for all Adrenaline Activities

A. General.

In consideration for being allowed to participate in Adrenaline Activities (as defined below), the participant or the parent(s) and/or legal guardian(s) of the minor participant named below (collectively, the "Participant") agree as follows:

B. Definitions.

"Activities" are defined as all Adrenaline related activities including but not limited to: classes, practices, events, competitions, activities (involving gymnastics, cheerleading, tumbling, open workouts, trial classes) and travel to and from the above.

"Adrenaline" is defined as Adrenaline Studio, LLC, Adrenaline Dance Force, LLC, Adrenaline Dance Project, Inc., their affiliates, owners, agents, officers, subcontractors, employees and all other persons or entities acting in any capacity on their behalf (including other Participants).

C. Participation Involves Inherently Dangerous Activities: Inherently Dangerous Activities.

Adrenaline Activities are inherently dangerous. The Activities involve and include, among other things, exertion, running, jumping, kicking, lifting and rotation; full range and coordinated body movements (dancing, tumbling, gymnastic skills, etc.) and lifting or being lifted by a teammate. Travel. Adrenaline may need to use a practice space at a separate location located within the same office park. Participating in Activities may require Participants to walk back and forth between such locations while avoiding traffic within such office park. Participation in Adrenaline Activities may require attendance at events/competitions (both local and out of state) that involve overnight stays and significant distance. During travel to and from Activities and events/competitions and during the time in between, Adrenaline is not responsible for supervising the Participant unless expressly agreed upon between you and Adrenaline. Consequences of Participation. I understand that participation in the Activities involves risks (whether known or unknown) regardless of the precautions taken by Adrenaline. Action or inaction on the part of Adrenaline, Participant or others, or the conditions under which the Activities take place can cause, among other things, the following: sprains, strained muscles, broken bones, dislocated joints, permanent disability, paralysis, death, transportation related accidents, emotional distress or damage to me, my child, to property, or to third parties.

D. Acknowledgements and Assumption of the Risk.

I acknowledge that on behalf of myself and the Participant, we have voluntarily chosen to participate in the Activities, assume all risks incidental to and related to engaging in the Activities and I have full knowledge of the risks the Activities present, including travel to, participation in, and returning from the Activity. I acknowledge that there may be other risks either not known to me or the Participant or not readily foreseeable at this time. I am aware portions of the Activity are not guided or supervised by Adrenaline. I and the Participant understand the nature of the Adrenaline Activities and certify that the Participant is qualified, in good health and in proper physical condition to participate in such Activities. In addition, I am aware of the Participant's physical abilities and neither I, nor the Participant, shall exceed them. I and the Participant fully accept and assume all such risks and responsibilities for losses, costs, and damages I and or Participant incur or cause as a result of Participating in the Activities. I understand by being permitted to participate in this activity, I agree to assume any and all risk of loss, injury or death. I further understand and agree to assume responsibility for risk of theft, loss, or damage to my personal property, which may occur at any time arising out of my participation in this activity.

E. Release, Waiver of Liability and Indemnification.

I, for myself and Participant, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, I and Participant hereby release, discharge, and covenant not to sue Adrenaline, any sponsors, advertisers, owners and lessors of the premises on which the Activity takes place from liability of claims demands, losses or damages, caused or alleged to be caused in whole or in part in relation to participation in the Activities. I agree to indemnify Adrenaline and any third parties for any losses incurred which are caused by myself or Participant while participating in Activities.

F. Obligations.

In recognition of the importance of shared responsibility for safety, I will remove myself and/or the Participant and immediately report any noted deviations from the safety rules as well as any observed hazardous conditions or equipment to a member of the Adrenaline staff. I agree that if I or the Participants believe any Activities are unsafe, we will immediately discontinue participation in the activity.

G. Medical Release.

In the event of any illness or injury incurred during an Activity, I authorize, but do not require, Adrenaline to obtain and or provide in its sole discretion, necessary medical treatment for the Participant and hereby, in my own behalf and on behalf of the Participant, release and hold harmless Adrenaline in the exercise of this authority. I further acknowledge and understand that I will be responsible for any and all fees and costs that may be incurred on behalf of the Participant for any illness or injury that Participant may sustain during the Activities.

H. Appearance Agreement.

I understand that Adrenaline from time to time produces promotional material relating to its programs and Activities. I understand that as a Participant and/ or a spectator at an Activity that I or the Participant may be included in video, audio and photographs taken during the Activities. Therefore, without reservation or limitations, I, in my own behalf and on behalf of the Participant, hereby assign, transfer and grant to Adrenaline, its successors, assignees, licensees and third parties the right to photograph, audio and / or video myself of the Participant and to utilize such audio, video and photographs and my or Participant's name, face likeness, voice and appearance as a part of the Activities, in advertising and promoting Adrenaline. I, in

my own behalf and on behalf of the Participant, waive any right to inspect or approve the copies of any promotional materials related thereto.

I. Insurance.

I certify that the Participant has health, accident, and liability insurance to cover bodily injury or property damage that may be caused or suffered while participating in the Activities. Adrenaline does not provide insurance coverage for Participants for injuries occurring while participating in Activities. Any injury claim must be filed with Participant's own insurance.

6. Miscellaneous

A. Communications.

- (1) Information will be provided to you via the studio website, Google calendar, Closed Facebook Team pages, and Team Snap. We update them efficiently and it is the best method to get out information quickly. If you need to speak with a coach, please set up an appointment. Coaches are often scheduled tightly for rehearsals and need to concentrate on all performers. We ensure open lines of communication and can accomplish them with scheduled appointments.
- (2) All tuition, class, and fee information will come from <u>AdrenalineStudioNova@gmail.com</u> or <u>no-reply@dancestudio-pro.com</u>
- (3) Parents MUST sign up closed Team Facebook pages and team communication App (TBD).
- (4) Please check your email! We disseminate a lot of details via Email, Team Snap and the Closed Team Facebook Pages.

B. Studio Closings.

We will consider the Fairfax, Loudoun, Arlington, and Montgomery County Public School cancellation policies. If weather clears up during the day and the roads are safe, we will have rehearsals that evening. Weather cancellation calls will be posted by 2:30pm on our website and Facebook Page. In the event the studio will be closed due to weather, it will be posted on the website and on the Facebook pages. Please check these regularly. If school is closed, we still may be open, as you know often the weather can clear up by afternoon. We will make the call as soon as we can, and we do take into consideration the safety of our dancers and staff.

C. Emergency Procedures.

During an evacuation parents may pick up their children AFTER they have been accounted for. Instructors will exit the building with their class roster and will be responsible for keeping track of all students. Parents are free to accompany their children to the evacuation area; however, will not be permitted to take their child until the instructor has accounted for all students. In a medical emergency, 911 may be called if the staff feels the situation requires immediate emergency medical attention.

Acknowledgment. I have carefully read this agreement and fully understand all of its terms and conditions. I understand my financial commitment and my time commitment for the 2018-2019 All-Star Program. I have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect. I have had the opportunity to ask questions and have them answered. I am confident that I fully know, understand and appreciate the risks involved in Participation. I understand this is a release of liability, which could legally prevent me from filing a lawsuit or making any other legal claim for damages in the event of losses, death or injury. With this knowledge, I am entering into this agreement fully and voluntarily. I agree the agreement is binding upon me, my spouse, my heirs, my children, assigns, personal representatives and next of kin. I understand that I forfeit any monies paid if I choose to leave a team or am asked to leave the program for any reason.

Next Steps:

- 1. Review and sign the contract.
- 2. Indicate which teams you intend to join *based on style of dance and age range below*. (Hip Hop, Jazz, Pom)
 - Tiny (6 and under) -- Mini (9 and under) --Youth (10-12) --Junior (13-15) Senior (16-18)
- 3. Provide initial non-refundable deposit of \$350 per dancer is due. Calculate Pass through costs. (Next Page)
- 4. **<u>Referral Program</u>**: If you refer someone new to All-Star Tryouts and they sign up, we'll credit you for one month of your family's regular All-Star tuition payment once your referral has signed a contract and paid their one-time fees and two months of All-Star tuition.
