

**Cevalo Riding Academy
Waiver of Liability and
Express Assumption of Risk**

THIS RELEASE CONTAINS IMPORTANT LIMITATIONS OF LEGAL LIABILITY

I acknowledge that competitive and pleasure horse riding contains inherent risks of injury and damage to me personally and to my horse and my equipment. Further, I acknowledge that volunteering and working around the ranch and around horses and other animals involves certain inherent risks, including but not limited to the risks of possible injury as a result of contact with nails and other metal objects, or from over-exertion or environmental conditions. Despite these risks, I still choose to engage in these activities.

I know of no physical limitation that should keep me from undertaking these activities. In consideration for being allowed to participate in these activities, I hereby personally assume all risks, whether foreseen or unforeseen, for any harm, injury, or damage that may befall me as a participant, or that may befall my horse or other property.

I hereby release, on behalf of myself, my heirs, executors, administrators, and assigns, Douglas Novick and Cevalo Riding Academy and its directors, officers, employees, agents and volunteers, from any and all liability for any injury, death, or other damages to me, my family, heirs, or assigns, or to my horse or other property, that may occur as a result of my participation in these activities, or as a result of product liability, or the negligence of any party, including Cevalo Riding Academy, whether passive or active.

I further agree, on behalf of myself, my heirs, executors, administrators, and assigns, that I will defend, indemnify, and hold harmless Douglas Novick and Cevalo Riding Academy and its directors, officers, employees, agents and volunteers, against any claims, demands, and causes of action, including court costs and attorney's fees, directly or indirectly arising from any actions or proceedings brought by or prosecuted for my benefit contrary to this release.

Further, I do hereby acknowledge that this release will extend to any accidents, damages, or claims arising out of my participation in equestrian activities on or about Douglas Novick's property, or any Cevalo Riding Academy activity, wherever it may take place, caused by my own act or the acts of any person or animal within my control.

In case of illness or accident, permission is granted for emergency treatment to be administered. It is further understood that the undersigned will assume full responsibility for any such action, including payment of costs.

I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS WAIVER OF LIABILITY AND ASSUMPTION OF RISK BY READING IT BEFORE I SIGNED IT ON BEHALF OF MYSELF AND MY HEIRS.
