SUBJECT: Visual Arts Instruction for TK-6th Grade Classes in 17-18: CONSENT

ATTACHMENTS: Contract with Arts Council for Monterey County for 2017-18 school year.

RECOMMENDATION: It is recommended that the Board of Education approve the contract with the Arts Council for Monterey County to provide 8 hours of visual arts instruction to each SCESD TK-6th grade classroom before the end of the 2017-18 school year.

ANALYSIS: The feedback from various stakeholder groups during the 2017-18 school year reinforced the value of providing our students with exposure to Music, Visual and Performing Arts programs. As a result, such programs are included in the current LCAP approved by the Board of Education. Last year the Arts Council of Monterey County provided arts instruction to all of our first and second grade students to very positive reviews. This contract is building on that success to provide visual arts instruction to all TK-6th grade classes during the 2017-18 school year. This contract will provide artists, instruction, supplies, and showcases at each school. Artists will visit all classes in the district and provide art instruction under the supervision of the classroom teacher. In addition, artists would provide support for school and district-wide art projects that could include Open House meetings, school assemblies, the SCESD Spring Anniversary Celebration in connection with the city's sesquicentennial, etc.

FISCAL IMPACT: \$200,000 Supplemental/Concentration funds

PROGRAM IMPACT: The approval of this contract will provide instruction and opportunities for TK-6th grade students in Visual Arts. This will give them a chance to be creative, expand their horizons, and in many cases, provide them with an outlet for talents that are generally not emphasized in the school setting.



1. Contractor agrees to perform these special services in his/her capacity as an independent contractor:

3. District agrees to pay Contractor upon invoiced for **\$200,000.00** and payable when the services performed are satisfactory to District. *If over \$5,000 – Board approval date:* _____
