

#iamcredible #giveaway Official Rules NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. Eligibility: The Hanna Andersson #iamcredible #giveaway (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least 18 years old at the time of entry. Employees of Hanna Andersson, LLC ("Administrator") or Disney Consumer Products, Inc. ("Sponsor"), and their respective parent and affiliate companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable federal, state and local laws and regulations. Void where prohibited. 4. Prizes: One (1) winner will receive a \$400 Hanna Andersson Gift Card and family pack of four (4) movie ticket vouchers to view the film Disney• Pixar Incredibles 2. Approximate Retail Value ("ARV"): \$500. Odds of winning the Giveaway prize depend on the number of eligible entries received during the Sweepstakes Period.

5. How to Enter: To participate in the Promotion: During the Giveaway Period, you can enter the Promotion by: posting an image or video of your children on Instagram or Facebook saying why they're incredible. Each submission must include the hashtags #iamcredible #giveaway. Upon completion and submission of the photo or video with appropriate hashtags, you will receive one entry into the Sweepstakes. All potential winners are subject to verification before any prize will be awarded. Entrants may use the hashtags #incredibles and #giveaway multiple times during each entry period, and all will count as a single entry to the Promotion. By participating in the Promotion, entrant agrees to clearly and conspicuously disclose that he or she is participating in the Promotion. At a minimum, the hashtag #giveaway must be included in all entries. Sponsor will disqualify any participant who does not adequately disclose participation in this Promotion in connection with an entry. Limit: One entry per person.

6. Selection of Potential Winners: On or about June 11, 2018 Sponsor will randomly select the potential Sweepstakes winner from all eligible entries on Facebook and Instagram. Sponsor's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Potential winners will be contacted through the account they entered with.

7. ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION.
