A little over a year ago, my husband and I became parents. Like most parents of small children, we are often exhausted, harried, and struggling to balance our home and professional lives. In fact, I sometimes feel as if I can't seem to put two sentences together without major pauses or just defaulting to, "You know what I mean don't you?" (Not the best quality in a lawyer!) But, despite the overwhelming workload and major life restructuring parenthood has brought us, the joy of participating in our son's growth could not be more rewarding or satisfying.

In many ways, the work of the volunteer lawyer is the same. The past year has been challenging for so many people. People who have worked at the same job for decades are no longer employed, people have lost their homes, their benefits, and are finding it difficult to find a means to sustain themselves and their family. But the volunteer lawyers in Southern Arizona have risen to meet these needs in a profound way. Yes, we are surrounded by more poor and desperate people than ever before. But, in response, grace and generosity have abounded all the more! I simply marvel at the generosity of our volunteers, who will donate 7,000 hours this year to help clients who could not otherwise afford legal assistance. I am amazed by the staunch commitment to pro bono services that the legal community has made. Volunteers will staff over 500 clinics in substantive areas that range from minor guardianship to debt collection and bankruptcy to domestic relations. This year volunteer lawyers and law students will assist over 4000 clients through the VLP. This reflects a 20 percent increase over the number of clients assisted by volunteers in 2009. This is remarkable. Lawyers like you have selflessly given their time to participate in something larger than themselves, to impact lives and change futures. Lawyers like you have sacrificed their personal and professional commitments to serve the powerless, right wrongs, and fulfill the promise of the legal profession's long-standing commitment to the under served. I feel so honored to work with the VLP and witness your generosity every day. Thank you for inspiring me and thank you for helping so many people in need.
