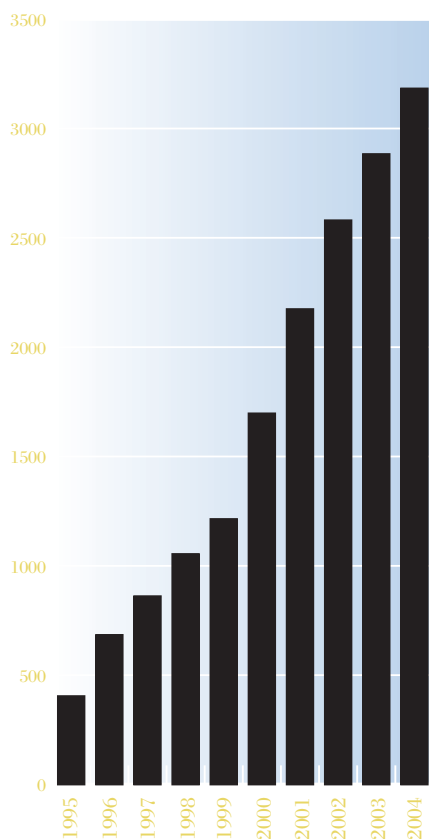

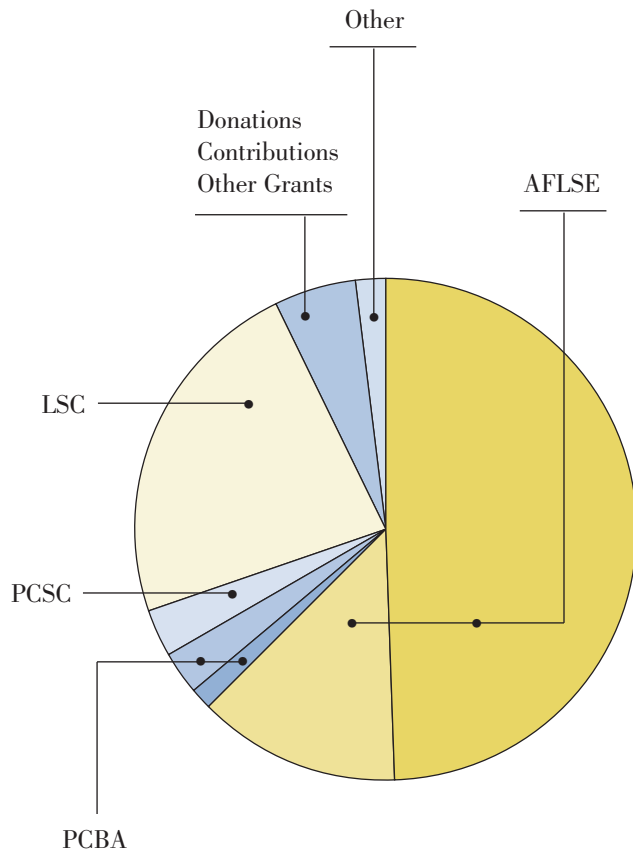

## Volunteer Opportunities

### Bankruptcy Court Reaffirmation Hearings

Volunteer attorneys supervise law students as they meet with unrepresented clients at the reaffirmation hearing in Bankruptcy Court. The students review reaffirmation agreements presented to the client by their creditor. Students then have the opportunity to appear before the court and offer their recommendation in regard to the client's reaffirmation agreement.

### Advice-Only Clinic

Meet with pre-scheduled clients to determine the legal merits of their cases and to determine the next course of action.

### Domestic Violence Law Clinic

Mentor law students while helping victims of abuse. You'll supervise students from the University of Arizona College of Law as they conduct interviews and advise clients.

### Chapter 7 Bankruptcy Clinic

Provide clients with basic information about the process of filing bankruptcy, and explain the benefits and consequences of this action. This clinic is also offered in Spanish.

### Domestic Relations Clinics

Assist clients in these areas: divorce with children, divorce without children and paternity. Provide basic information on domestic relations issues and assist clients in completing self-help forms.

### Transactional Assistance to Non-Profits

(Arizona Community Legal Assistance)

Help non-profits dedicated to assisting children and people with low incomes. Issues include formation, incorporation, obtaining tax exempt status, personnel matters, contracts, tax, real estate, housing and economic development.

### Direct Representation of Eligible Low-Income Clients

Represent low-income clients on issues such as consumer fraud, debt collection, family law, guardianship, home ownership, tenants' rights and tort defense.

VLP provides primary malpractice coverage, donated services to avoid litigation costs, mentors, consultants, CLE discounts and training.

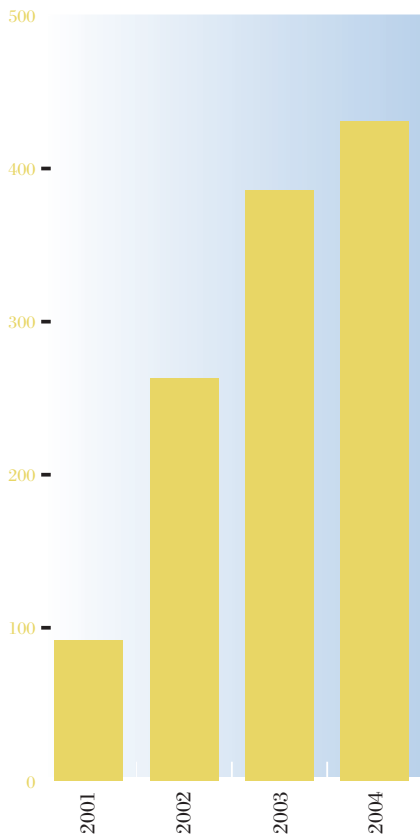

Since the inception of the VLP Advocates Program in 1999, its volume has grown and its impact reverberates throughout our community. This is clear from the increasing numbers of law students choosing to begin their careers with VLP experience. To date, more than 300 law students have volunteered with the VLP. This year the numbers are especially impressive, with 110 law student volunteers, up from 77 students in 2003. These law students will touch approximately 1,000 cases this year, almost one third of the total cases handled by the VLP annually.

## VLP Advocates Programs:

### Child Support Court Project

Under the supervision of an attorney, students review the pleadings of pro per litigants at domestic default hearings to make sure that their child support has been calculated accurately. If the paperwork is deficient, the student will enter the individual's information into a computer and then print out new and accurate documents.

### Bankruptcy Court Reaffirmation Hearings

Volunteer attorneys and law students meet with unrepresented clients at their reaffirmation hearing in Bankruptcy Court. The students review reaffirmation agreements presented to the client by their creditor. Students then have the opportunity to appear before the court and offer their recommendation as to whether the client should enter into the reaffirmation agreement.

### Domestic Relations Clinic

This clinic takes place at the VLP office and the student works with a client under the supervision of a volunteer attorney. Students provide basic information and advice and assist clients in completing self-help forms.
