THIS AGREEMENT is made and entered into this 9TH day of September, 1996, by and between the **TOWN OF COULEE DAM**, a municipal corporation of the State of Washington, hereinafter referred to as "**Town**" and the **COUNTY OF OKANOGAN**, a municipal corporation of the State of Washington, hereinafter referred to as "**County**", pursuant to authorizing resolutions duly adopted by each of said respective municipal corporations,

WITNESETH:

WHEREAS, the Town is desirous of entering into an agreement with the County pursuant to RCW 3.50.805,

NOW, THEREFORE,

IT IS HEREBY AGREED BETWEEN THE PARTIES as follows:

1. **Purpose.** It is the purpose of this Interlocal Agreement, entered into pursuant to RCW 39.34 and the statutes of the State of Washington prescribing the manner of operation of county district courts and the use thereof by municipalities, to set forth the terms and conditions for the use of the Okanogan County District Court by the Town of Coulee Dam.

2. **Duration.** This agreement shall be effective October 1, 1996, and shall continue thereafter indefinitely, subject to review from time to time, until terminated by written notice in the manner prescribed by law; **provided**, that any such prior notice shall be given not less than ninety (90) days prior to the end of a given calendar year and shall be effective as of the commencement of the ensuing calendar year.

3. Administration. The court shall be known as the Coulee Dam Municipal Department of the Okanogan County District Court and shall be administered by the Judge or Judges thereof.

4. Budget, Finance, and Filing Fees. The budget for the Okanogan County District Court shall be established by the Okanogan County Commissioners in the manner provided by law. The Town of Coulee Dam shall file and prosecute all civil infractions with, and pay on a monthly basis to Okanogan County District Court a filing fee of \$30.00 for each new civil and traffic infraction filed by its officers or employees, based upon a billing statement therefor rendered by the court. The Town shall establish its own screening process on all existing and pending civil and traffic infractions, and all such infractions that the Town elects to transfer to Okanogan County District Court shall be filed with the court without a filing fee. The Okanogan County District Court shall account for all income generated as a result of the prosecution of such infractions and shall remit the same to the Town.

~~5. Criminal Cases. Criminal misdemeanor cases may be filed with the Okanogan County District Court, and these cases shall be prosecuted, adjudicated and sentenced as criminal cases in the Okanogan County District Court (but not within the Coulee Dam Municipal Department) without cost to the Town. Necessary steps shall be taken to transfer all existing criminal warrants, if any, on the books of the Coulee Dam Municipal Court to Okanogan County District Court.~~

6. Periodic Review. The terms of this agreement, or any renewal thereof, shall remain in effect for the current calendar year and any succeeding calendar year for which the terms have not been modified as herein provided. Either the Town of Coulee Dam or the County of

Okanogan may give written notice to the other party, not later than October 1 of any calendar year, indicating a desire for the review and modification of the terms of this agreement for the ensuing calendar year. Each party shall make available to the other such financial or other data as may be pertinent to the financial terms hereof. If the parties are unable to agree on the terms for the continuance of this agreement, then such terms shall be submitted to arbitration in the manner provided by the laws of the State of Washington.

IN WITNESS WHEREOF, the parties hereto have caused this agreement to be executed this date pursuant to appropriate authorizing resolutions of each respective party.
