

2023 MINNESOTA FAMILY COUNCIL LEGISLATIVE SCORECARD

Votes matter. This scorecard shows how Minnesota legislators voted on a number of crucial issues during the 2023 Legislative Session. We tracked ten votes in the Minnesota House and eleven votes in the Minnesota Senate so that you can see how your legislators voted on issues affecting life, family, and religious freedom.

How to use this scorecard. First, use the key below to familiarize yourself with the issues legislators voted on in 2023. Then find your Minnesota Senator and Minnesota State Representative by looking at the district number, region, and cities represented. Because some municipalities are split between districts, and others are too small to be listed here, the most reliable way to find out who represents you is to use the Who Represents Me tool created by the Minnesota Legislature and available at www.gis.lcc.mn.gov.

I've found my legislators' votes. What next? First, we encourage you to pray for your legislators and contact them. You can thank them for voting for life, family, and religious freedom, or ask why they did not do so. Whichever way they voted, we ask that you pray for them and thank them for their service in the Minnesota Legislature.

Second, inform others about this scorecard so that they can find out where their legislators stand on the issues that matter.

Finally, don't forget to pray for all our elected officials. As the Apostle Paul writes in 1 Timothy 2:1-2, "First of all, then, I urge that entreaties and prayers, petitions and thanksgivings, be made on behalf of all men, for kings and all who are in authority, so that we may lead a tranquil and quiet life in all godliness and dignity." Pray, too, that God would be merciful and provide our state with leaders who meet the biblical criteria of Exodus 18:21, those who are capable, trustworthy, fear God, and hate dishonest gain.

BILLS WE TRACKED

- 1. Protect Reproductive Options Act:** Legalizes abortion up to the moment of birth.
- 2. Born-Alive Protections Removed:** Removes statutory mandate to protect the life of infants born alive during abortion.
- 3. Expansion of Taxpayer Funding of Abortion on Demand:** Significantly increases Minnesota taxpayer funding of abortion on-demand.
- 4. Kidnapping Bill:** Courts may take custody of children whose parents refuse to subject them to 'gender-affirming care.'
- 5. Changes to the Human Rights Act regarding adults physically or sexually attached to children:** Removes language in the Minnesota Human Rights Act explicitly stating that 'sexual orientation' does not include a physical or sexual attachment to children by an adult.
- 6. So-Called "Conversion Therapy Ban":** More accurately, a counseling censorship ban that denies children with unwanted same-sex attraction or gender confusion the counseling they voluntarily choose for their health objectives; threatens licensed status of mental health counselors who provide that counseling.
- 7. PSEO Program:** Prohibits schools that require adherence to a statement of faith in their admissions process from participating in the PSEO program.
- 8. Abortion Extradition:** Makes Minnesota a safe haven for doctors and other individuals who committed a crime related to 'reproductive healthcare' (abortion or otherwise) in another state by refusing to honor extradition requests to hold them accountable in the original jurisdiction.
- 9. Human Rights Reporting:** Compiles solicited and received reporting to the Minnesota Department of Human Rights on non-criminal acts perceived to be motivated by bias.
- 10. State ERA:** Further strengthens state constitutional protections for abortion and cancels the rights of women and children by granting constitutional protections on the basis of subjective 'gender identity and expression.'
- 11. Congressional ERA:** A resolution to Congress to ratify the federal Equal Rights Amendment, a proposed amendment to the U.S. Constitution which would strengthen protections for abortion and cancel the rights of women and children by granting constitutional protections on the basis of subjective 'gender-expansive individuals.'



