This tour is based on rates in effect April 5, 2017 and is subject to change in the event of significant currency fluctuations and/or airline tax/fuel surcharge increases. This tour is priced on a minimum of 25 paying participants.

Included in the Price

Shared double room in first class and superior tourist hotels; daily meals as indicated in itinerary; transportation and entrance fees to sights; and gratuities.

Not Included in Price

Single room supplement: \$950; possible increases in the airline tax/fuel surcharge; additions/changes to standard program; individual transfers; travel insurance; coffee and drinks; excess baggage.

Airline Transportation

The option to purchase group round-trip economy air from Los Angeles (LAX) on IATA carriers is available for a price of \$_____ per person (total tour cost of \$_____). Tickets are non-refundable, non-amendable tickets.

Flight Times

Flight times are subject to change by the airlines without advance notice. If this occurs, Footstep Ministries reserves the right to shorten or lengthen the itinerary accordingly and, whenever possible, you will be notified in writing. If changes necessitate extra overnights, you will be charged \$150 per night per person, single rooms \$250 per night per person.

Reservation and Deposit

A non-refundable deposit of \$450 per person is required at the time of reservation. The balance is due no later than January 23, 2018. For reservations received after January 23, 2018, payment must also include a \$100 late booking fee per person in addition to any subsequent increases in the price of airfare after January 23, 2018.

Activity Level and Health

The activity level on this tour is moderate. Participants must be in good health and able to walk at a moderate pace, without assistance, for a couple of miles at a time on uneven terrain. Certain sites require climbing multiple flights of stairs that may not have handrails.

Transfers

Group transport between airport and hotel is included. Those who request changes from the standard flight schedule and who do not arrive with the group are responsible for their own airport-hotel transfers.

Luggage

Limit of one suitcase and one carry on per person; portage is for one suitcase only. Carry-on luggage is the responsibility of passengers.

Cancellation Fees

Footstep Ministries must receive all cancellation and refund requests in writing. All cancellations are subject to an administration fee of \$450 per person if received on or before January 23, 2018; 25% of tour price if received between January 24 and April 23, 2018; 75% of tour price if received between April 24 and May 16, 2018; and 100% of tour price on or after May 17, 2018. No-shows or cancellations after date of departure receive no refund whatsoever. All cancellation fees are based on the total tour price including all additions and airline deviations.

Insurance
