

## **Terms and Conditions**

**Group Airfare from Phoenix/Rome Round trip & Bus to Florence: \$1,094 pp**

This tour is based on rates in effect April 2017 and is subject to change in the event of significant currency fluctuations. This tour is priced on a minimum of 35 paying participants.

### **Activity Level:**

The activity level on this tour is moderate. Participants should be in good health and able to walk at a moderate pace, without assistance, for a couple of miles at a time on uneven terrain. Certain sites require climbing multiple flights of stairs that may not have handrails.

### **Included in Price:**

Shared double room in first class and superior tourist hotels; daily meals as indicated in itinerary; transportation and entrance fees to sights, museums, and activities listed in itinerary; taxes and gratuities.

### **Not Included in Price:**

Single room supplement: \$975; increases in the airline tax/fuel surcharge; optional tour activities not listed in itinerary; additions/changes to standard program; individual transfers; travel insurance; coffee and drinks; excess baggage.

### **Reservation and Deposit:**

A deposit of \$450 per person is required at the time of reservation. The balance is due no later than November 18, 2017. For reservations received after this date, payment must also include a \$100 late booking fee per person.

### **Transfers:**

Group transport between airport and hotel is included for those participating in group flights. Those who request changes from standard program and who do not arrive with the group are responsible for their own transfers.

**Luggage:**

Limit of one suitcase and one carry on per person; portorage is for one suitcase only. Carry-on luggage is the responsibility of passengers.

**Flight Times:**

Subject to change by airlines without advance notice. In this event, FM of Carrollton, TX reserves the right to shorten or lengthen the itinerary accordingly and, whenever possible, you will be notified in writing. If changes necessitate extra overnights, you will be charged \$150 per night per person, single rooms \$200 per person.

**Cancellation Fees:**

Footstep Ministries must receive all cancellation and refund requests in writing. All cancellations are subject to an administration fee of \$450 per person if received on or before November 18, 2017; 25% of tour price if received between November 19, 2017 and February 16, 2018; 75% of tour price if received between February 17 and March 11, 2018; and 100% of tour price on or after March 12, 2018. No-shows or cancellations after date of departure receive no refund whatsoever.

**Insurance:**

Tour participants are highly recommended to purchase insurance for trip cancellation, trip interruption, accident, sickness and/or loss of baggage and personal effects.
