# Community Threads

## UNCONDITIONAL RELEASE AND HOLD HARMLESS AGREEMENT

I desire to participate in various programs, events, activities or service projects (each, an "Activity" or "Activities") sponsored, organized or operated, at least in part, by Community Threads, Arlington Heights, Illinois ("CT"), and I understand and acknowledge that CT will not allow me to participate in the Activities unless I first release and hold harmless CT, its directors, employees, volunteers or other agents from and against any damage and liability relating to or arising out of my participation in the Activities;

I understand and acknowledge that my participation in an Activity exposes me to various risks, and I have considered these risks and possible dangers involved. Specifically, I understand and acknowledge that my participation in an Activity exposes me or an immediate family member to such risks as accidents, disease, crime, political unrest, personal injury or bodily harm, emotional harm, loss/theft or damage of personal property, imprisonment, abduction and other calamities, even death ("Injuries"), regardless of whether the Injury is caused by me or by other volunteers, CT staff or guests or other persons, or whether the Injury occurs on or near CT property or in connection with my travel to or from the Activity.

THEREFORE, in consideration of the permission extended to me by CT through its directors, employees, volunteers or other agents to participate in an Activity I,

I hereby assume any and all risks associated with my participation in and with any travel related to such Activity, and I unconditionally agree to hold CT, its directors, employees, volunteers or other agents blameless for any liability concerning my personal health and well-being, or any Injuries incurred while participating in an Activity.
