GCF SUMMER CAMP DETAILS

GCF Summer Camp sessions are enjoyed from 8:30 am to 4.00 pm, Monday – Wednesday, include a lunch, and items made by your child on and from our farm! The camp is open to 5-13 year olds, June 13—July 27, six sessions (M-W) for 2 age groups, see below for dates specific to your child.

Throughout the week your child will experience modern homestead farming. Our goal is to bring back old farming traditions and connect with what our world provides for us today. Greenlands Farm incorporates sustainability practices into everyday life on the farm: permaculture, organic farming, composting, and rain cisterns. We believe these practices directly influence our impact on the environment, both on the farm and off. Greenlands Farm is a true homestead farm; we live off of what we produce: fruits, vegetables, and goats milk (for making goats milk soap). Your child will be doing the same during the week they spend with us: they will eat, can, and bake what we grow! They will get “hands on” experience by milking our goats and learning soap making with the milk they collect. How cool is that?! Greenlands Farm also has rescue farm animals we use to educate children about each animal: needs, care, and respect. These animals teach valuable lessons that can be applied to many facets of life.

Creating awareness of sustainable and responsible practices through homestead farming is a step towards our children changing the future of our society. Our goal isn't to encourage your kids to be future farmers, but to share with them the joy and fulfillment of working hard, respecting the environment around them, and reaping the benefits. Your child will learn teamwork, patience, and responsibility through Greenlands Farm's homestead farm life: all skills that can be applied to life off the farm. *Enrich your child and give an experience like no other!*

Activities:

- Animal Husbandry: includes egg collection, milking goats, grooming ponies, and learning about a variety of farm animals - pigs, goats, llamas, chickens, ponies, sheep, bunnies, turkeys
- Soap Making
- Canning & Baking
- Organic Farming, Vegetable Picking, Meal Prep (from what you pick!)
- Crafts
- Farm Games, Pony Rides, and Llama Cart Rides

Tuition is \$195.00 per child. Upon review and acceptance of your application, we will email you to confirm your child's registration. A \$75.00 non-refundable registration deposit is due with the application. If the week you choose is full, we will contact you for other session possibilities. If there are no other openings, your check will be returned. All GCF Summer Camp applications and tuition fee of \$195.00 are due no later than one week prior to registered session.

**ACKNOWLEDGEMENT OF RISK
ACCEPTANCE OF RESPONSIBILITY & RELEASE OF LIABILITY**

I, the undersigned, hereby acknowledge that I have voluntarily applied to engage in an activity of horseback riding, llama cart riding, and petting animals with Greenland Farm, LLC Pony Rides, Llama Cart Riding, and Farm Animals.

I understand that the activity of horseback riding, llama cart riding, and/or petting zoo animals involves numerous inherent risks of injury that are an integral part of such an activity. I assume full responsibility for all such risks, including loss of control, collisions, and obstacles whether they are obvious or not obvious.

I and/or my family further understand that an animal, irrespective of its training and usual past behavior and characteristics, may act or react unexpectedly or unpredictably at times, and I also assume such risks.

I understand that I may encounter variations in terrain, which may result in injury or damages. I acknowledge that these are my responsibility, and I assume the risk for these hazards, including breaks, growth, debris, rocks, cliffs, and other hazardous surface or subsurface conditions and obstacles, whether they are obvious or not obvious, man-made or natural.

I understand that animals are unpredictable and that the risk of injury is inherent to the activity. I understand that animals may bite, scratch, kick, or jump up on people in this activity. I agree to assume all risks of injury or death caused by horseback riding, llama cart riding, or petting zoo animals, whatever the cause, except as provided by law.

As consideration for being permitted to engage in the activity of horseback riding, llama cart riding, and/or petting zoo, I do hereby waive any claim, and release all of the animal owners, officers, member, affiliated organizations, landowners, agents, employees, and/or volunteers for any injury or death caused by or resulting from my participation in the activity of horseback riding, llama cart riding, and/or petting zoo animals.

This contract shall be legally binding upon my heirs, my estate, my assigns, my legal guardians, my personal representatives, and myself. I have carefully read this agreement and fully understand the contents. I am aware that I am releasing certain legal rights that I otherwise may have, and I enter into this contract on behalf of myself and/or my family of my own free will.
