GENERAL INFORMATION

Location: We are located in Brunswick County in Bolivia, 20 miles from the Cape Fear Bridge. Our address is 668 Midway Road SE, 1.6 miles from Old Ocean Hwy.

Hours: We are open year-round, but the farm store operates on seasonal hours, please check the website current hours. Farm tours are available during normal store hours.

Eating on the farm: We have a deli café with tables and chairs and also a shaded picnic area outside for your use.

If you would like to eat lunch with us and you **order in advance**, we have special discounted rates for tour guests (taxes on food included, gratuity not included):

<u>Children's Lunch</u> - Sandwich, organic fruit, and drink box (Almond Butter, PBJ or Ham/Cheese)	\$5.25
<u>Adult Lunch</u> – Select deli sandwich, deli side, and FREE drink (Tea/Coffee or Water) (Excludes Reuben, Club and Tuna Sandwiches)	\$9.00

Scheduling Tours: Tours must be schedule 2 weeks in advance. (See Attached Application)

Weather: Tours are subject to weather. If it is raining or we have had excessive rain, making the farm too wet to walk, we will contact you to reschedule.

Handicap Accessibility: The farm is wheelchair accessible, albeit a bit bumpy terrain! We have many special needs groups that visit the farm and have a wonderful time.

Tour Cost: Our tours are tailored to age groups and vary in price.

- General Public: \$10 per person, tour includes ice cream (\$8 without)
- Senior Living (Assisted Living)/Limited Mobility Groups: \$4 per senior (additional \$2 for ice cream)

Payment: We request that you pre-pay for the tour at least two days in advance. We accept cash, checks, atm/debit, and credit cards.

Approximate Tour Length: Our tours vary in length according to tour type and group size but generally last 1 to 1 ½ hours .

Tour Group Size: We allow a maximum of 35 people per tour and require a minimum of 18 paying guests per tour. You can bring more than 35 people, but you will need to reserve two tour time slots. If you have less than 18 paying guests, you can contact us to see if we can add you on to another scheduled farm tour. Our petting farm is open every Saturday from 10am – 3pm (if weather permits) to the public, no tour reservation required. The farm store operates on seasonal hours, please check the website current hours. The farm is closed to the public except during scheduled tours.

Parking: Parking is available for buses in the roadside parking lot, all cars please use our grass parking lot next to the farm store (to the left when viewing from the road) and cross the bridge at the purple admissions booth.

Waiver: We require every visitor, children and adults, to sign a waiver of release of liability. Waivers can be returned by mail or dropped off before your scheduled tour, or brought on the day of the tour. Please make sure every guardian and person has signed one or they will not be allowed to participate in the tour. (Attached)

Our Store: We sell a variety of products made and grown on the farm. We also have a deli (sandwiches, sides, & salads), creamery, bakery, fruits, vegetables, tea, coffee, hand-made gifts, and more. We encourage you to bring a little extra money to enjoy yourselves!

General Public Tours

Tour Cost: \$10 per person

Approximate Tour Length: 1 to 1 ½ hours

GREENLANDS FARM BARNYARD RULES

Although we will go over these rules with each tour, please go over the rules with your group BEFORE you come out to visit.

1. You must sign a waiver before entering the barnyard area.
2. Only 35 people allowed in at a time in the barnyard area.
3. DO NOT pick up, hit, be mean, poke, scare, or scream at the animals at any time.
4. DO NOT feed the animals.
5. No food or beverages allowed in the barnyard area. Also there are no bottles, sippy cups, your children's toys, stuffed animals, other pets, pacifiers, or smoking allowed as well.
6. DO NOT let your child put their hands in their mouth after petting an animal.
7. Keep your child's/children's hands and feet out of the mouths of the animals.
8. No personal items allowed in the barnyard area, including strollers & bags.
9. DO NOT climb any fence.
10. No barefoot or open toed shoes allowed inside the barnyard area.
11. Sanitize your hands before entering and immediately upon exiting the barnyard area. (See warning below)
12. If you get scratched or bit, from a surface or an animal, please go inside Greenlands Farm Store to receive First Aid. These rules are in place for everyone's safety. We take a no tolerance stance on them. If you do not cooperate you will be asked to leave the barnyard area and no refund will be given.

WARNING

There are some diseases and parasites that can be spread from animals to humans. The risk of infection through petting farm animals may be prevented by following everyday good hand hygiene measures. Therefore, the Centers for Disease Control and Prevention (CDC) warns that children and adults should wash their hands immediately after touching the animals at any petting zoo. Heightened precautions should be applied to high-risk groups: Children under age five, people with weakened immune systems, and pregnant women fall in the category of high-risk for serious infection, and hence should strictly follow all the precautions enforced in the animal contact area. If you prefer to wear gloves or shoe covers, please ask for a pair.

ATTENTION PARTICIPANTS

We are excited to teach you about our farm! If you prefer to wear the gloves or shoe covers Greenlands Farm provides, please inform us of your needs.

**ACKNOWLEDGEMENT OF RISK
ACCEPTANCE OF RESPONSIBILITY & RELEASE OF LIABILITY**

I, the undersigned, hereby acknowledge that I have voluntarily applied to engage in an activity of horseback riding and petting animals with Greenland Farm, LLC Pony Rides and Farm Animals.

I understand that the activity of horseback riding and/or petting zoo animals involves numerous inherent risks of injury that are an integral part of such an activity. I assume full responsibility for all such risks, including loss of control, collisions, and obstacles whether they are obvious or not obvious.

I and/or my family further understand that an animal, irrespective of its training and usual past behavior and characteristics, may act or react unexpectedly or unpredictably at times, and I also assume such risks.

I understand that I may encounter variations in terrain, which may result in injury or damages. I acknowledge that these are my responsibility, and I assume the risk for these hazards, including breaks, growth, debris, rocks, cliffs, and other hazardous surface or subsurface conditions and obstacles, whether they are obvious or not obvious, man-made or natural.

I understand that animals are unpredictable and that the risk of injury is inherent to the activity. I understand that animals may bite, scratch, kick, or jump up on people in this activity. I agree to assume all risks of injury or death caused by horseback riding or petting zoo animals, whatever the cause, except as provided by law.

As consideration for being permitted to engage in the activity of horseback riding and/or petting zoo, I do hereby waive any claim, and release all of the animal owners, officers, member, affiliated organizations, landowners, agents, employees, and/or volunteers for any injury or death caused by or resulting from my participation in the activity of horseback riding and/or petting zoo animals.

This contract shall be legally binding upon my heirs, my estate, my assigns, my legal guardians, my personal representatives, and myself. I have carefully read this agreement and fully understand the contents. I am aware that I am releasing certain legal rights that I otherwise may have, and I enter into this contract on behalf of myself and/or my family of my own free will.
